The Festival will be held in Historic St Marys GA, 8 miles east of I-95. All activities will be held on the waterfront on St Marys Street. To get there, take exit 3 off of I-95 east to St. Marys on Georgia Hwy 40 approximately 7 miles to a stoplight at the intersection of Hwy 40 and Dilworth Street. Turn right, follow Dilworth Street (which curves to the left and becomes St. Marys Street) 1.7 miles to a barricade at Bartlett Street.

Check-in begins at **6:00am** at the intersection of St. Marys and Bartlett Streets. **BOOTH SPACE NUMBERS WILL BE GIVEN OUT AT THIS TIME.** Booths must be setup and all vehicles out of the exhibit area, **NO LATER THAN 9:00 am!** (Parking available on side streets). No vehicles allowed in festival area from 9:00am until 6:00pm.

ALL VENDORS MUST REMAIN SETUP UNTIL THE FESTIVAL IS OVER AT 6:00 pm!
YOU MUST BE PACKED UP AND OUT OF THE FESTIVAL AREA
NO LATER THAN 8:00 pm!

FESTIVAL INFORMATION and INSTRUCTIONS FOR ALL VENDORS:

ALL FOOD VENDORS MUST HAVE A MINIMUM 5LB ABC FIRE EXTINGUISHER!

- Oil/grease must be removed by vendor. Do not pour into drains. Sand or absorbent materials must be used. All vendors are responsible for cleaning their booth space prior to leaving.
- No sale of alcoholic beverages
- Set-up is on street surface ONLY
- No refunds will be given other than non-accepted applications
- Festival will take place, rain or shine
- No Pets Allowed
