50th ANNUAL SEAFOOD FESTIVAL

The 50th Annual Seafood Festival will be held in Historic St Marys GA, 8 miles east of I-95. All activities will be held on the waterfront on St Marys Street. To get there, take exit 3 off of I-95 east to St. Marys on Georgia Hwy 40 approximately 7 miles to a stoplight at the intersection of Hwy 40 and Dilworth Street. Turn right, follow Dilworth Street (which curves to the left and becomes St. Marys Street) 1.7 miles to a barricade at Bartlett Street.

CHECK-IN BEGINS AT 6:00AM ONLY AT THE INTERSECTION OF ST. MARYS AND BARTLETT STREETS. BOOTH SPACE NUMBERS WILL BE GIVEN OUT AT CHECK-IN. Booths must be setup and all vehicles out of the exhibit area, **NO LATER THAN 9:00AM!** (Parking available on side streets).

No vehicles allowed in festival area from 9:00am until 6:00pm.

**ALL VENDORS MUST REMAIN SETUP UNTIL THE FESTIVAL IS OVER AT 6:00PM!
YOU MUST BE PACKED UP AND OUT OF THE FESTIVAL AREA NO LATER THAN 8:00PM!**

INFORMATION FOR ALL VENDORS

- All food vendors must use sand, floor coverings, or absorbent materials for oil/grease
- All vendors are responsible for removal of all litter in their booth space
- Set-up is on street surface
- No soliciting, broadcasting, amplified sound, or advertising outside booth, no hawking. No Loud music from booth without prior approval from Kiwanis.
- Ensure cords do not create tripping hazards
- Vendors must furnish their water and ice
- No sale of alcoholic beverages
- Festival will take place rain or shine
- Only food vendors may use generators
- No Smoking within 25' of vendor booths
- **NO PETS ALLOWED in festival area**
