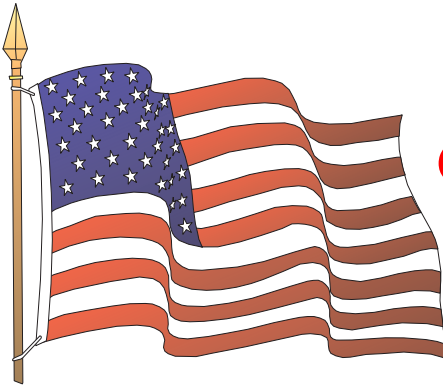

Named by Southeast Tourism Society a Top 20 Festival in the Southeast**

The 53rd Annual Independence Day Festival will be held in Historic St. Marys GA, 8 miles east of I-95. All activities will be held on the waterfront on St. Marys Street. Take Highway 40E to St. Marys turn right on Dilworth Street at light.

Check-in begins at 5:30am at the intersection of St. Marys and Bartlett Streets. Booth space numbers will be given out at this time. Booths must be setup and all vehicles out of the exhibit area, **NO LATER THAN 9:00 am!**
(Parking available on side streets)

INFORMATION FOR ALL VENDORS

- Vehicles may return to festival area ONLY during 4:30 pm - 6:00 pm and after 10:00 pm
- Vendors not gone by 6:00 pm must remain until after fireworks
- All food vendors must use sand or absorbent materials for oil/grease
- All vendors are responsible for removal of all litter in their booth space
- Set-up is on street surface.
- No soliciting outside booth
- Ensure cords do not create tripping hazards
- Vendors must furnish their water and ice
- No sale of fireworks or snap `n pops
- No sale of alcoholic beverages
- Festival will take place rain or shine
- **NO PETS ALLOWED in festival area**

ELECTRICITY

- Only food vendors may use generators
- Vendors requiring electricity must pay for it in advance as set forth in fee schedule; be prepared to furnish extension cords up to 150 feet in the unlikely event outlets are not nearby
- Food vendors are encouraged to use generators.

FOOD VENDORS

- If not gone by 6pm, they must remain until after fireworks. Those remaining for the fireworks must be gone no later than midnight.
- Generators are strongly encouraged. Electrical outlets in the food vendor area are limited.
- **ALL FOOD VENDORS MUST HAVE A MINIMUM 5 LB ABC FIRE EXTINGUISHER!**

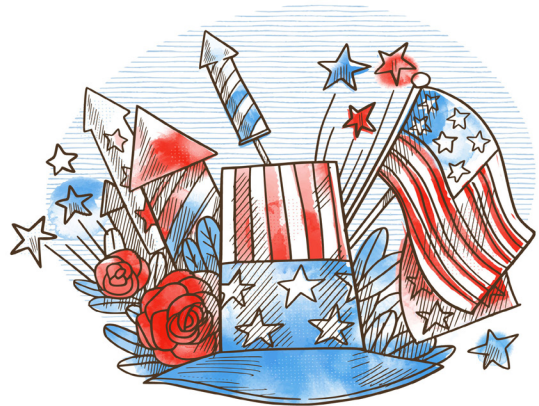
