PARADE APPLICATION

Registration: Please complete and submit this form to enter. Forms **WILL NOT** be available the day of the parade, so submit your application early. Early entries get positioned in line first. We will acknowledge receipt of your entry via email. If you do not receive a reply, please contact us well before parade day. Deadline for submission is **30 September 2021**.

Assemble: Line up begins at 8:00 am at the corner of Osborne and Meeting Street (Just south of the St. Marys Railroad Tracks). Please be lined up by 9:30 to ensure your spot. The Parade will begin at 10:00 sharp.

Viewing Stand Announcements: We will announce entrants from the Platform Stage Trailer at the end of Osborne and St Mary Streets. The parade will turn **RIGHT** at the end of Osborne Street, onto West St. Marys Street then head west passing in front of the Gilman Waterfront Park to Bartlett Street turning right to head up Bartlett to return to the Meeting Street Assembly area or disband along the way. **PARTICIPANTS MAY NOT STOP** anywhere along the Parade Route and must continue past Lang’s Restaurant all the way to Bartlett Street. Please have your application submitted to us by **September 30th** to ensure entry.

REMINDER: Due to the COVID Pandemic, we suggest that you check with State and Local Regulations in place at the time of the Festival, as requirements may change. Please use caution and common sense with respect to the parade and your participants to keep everyone safe. September can be a hot month as well, prepare accordingly.

CITY OF ST MARYS REQUIREMENTS:

The **City of St. Marys** requires compliance with the following rules, which are designed to ensure the safety of both participants and spectators, and to ensure everyone has the best possible time at the Parade and Rock Shrimp Festival. Everyone in your party must be made aware of the rules and agree to follow them.

DRIVERS: Must be properly licensed and be at least 18 years of age. Proof of Insurance is required. Drivers may NOT hand out anything while operating the vehicle.

TOW VEHICLES: If decorated, must have a clear field of vision.

FLOATS AND VEHICLES OF ALL KINDS: Must be attended at all times. Decorations must be securely attached. Wiring devices must be UL approved and properly fused. Portable generators must be securely mounted, have at least 12 inch clearance from combustible materials and must have firmly attached exhaust blinds. All vehicles must be equipped with a fire extinguisher.

MINORS: Children under the age of 16 MUST be accompanied by an adult.

CANDY AND OTHER DISTRIBUTED ITEMS: For everyone's safety, **DUE TO COVID-19, give away items are NOT encouraged.** However, parade entrants may toss (NOT Throw!) items to parade spectators. Members of your group may walk along the parade route and hand items to spectators. Children under the age of 6 may not distribute items. Edible items must be fully wrapped.

No profanity, fighting, drinking or illegal conduct shall be tolerated. No provocative or offensive words or displays of any kind shall be permitted.

The applicant hereby agrees to defend, indemnify and hold the Kiwanis Club of St. Marys harmless from and against any claim, demand, suit, loss, causes of action, liabilities, obligations, costs, expenses and judgements (including without limitation, death and damages to property) caused by Applicant's acts or omissions or failure to abide by the rules and conditions contained herein.
