

Privacy Policy

At WBC we're committed to protecting your privacy. We developed the following policy pursuant to the Personal Information Protection and Electronic Documents Act, 2000 c.5. (the "Privacy Act").

This page sets out our privacy policy and describes why and how we collect, use and disclose personal information you choose to provide to us on our website, as well as how to access, modify, or delete your personal information. This policy doesn't apply to anyone who isn't under our control or management, such as the operators of other websites you might link to from our website. Such operators may have their own privacy policies, which might differ from ours.

How Will We Collect Personal Information?

You are under no obligation to disclose any personal information to us at any time. However, some features of the website need some personal information, such as applying for or renewing membership, receiving email notifications & reminders, or online payments for WBC events (via PayPal). In the process you may be asked to give your name, email address, address, etc. for the purpose of these services.

How Do We Use and Disclose Personal Information?

We will keep your personal information stored securely on our system and will not release it to any third party without your prior consent. None of your personal information will ever be shared, rented, sold or otherwise released to any third party.

You may receive automatically-generated emails from WBC that are triggered when you perform certain tasks such as registering for an event or requesting a forgotten password.

Please know that as a member, you may receive emails from other club members. WBC does not control the frequency or content of member-generated emails.

Does Your Site Use "Cookies"?

Our site uses "cookies" which are small files containing pieces of information that are stored by your browser on your computer's hard drive. Most web browsers automatically accept cookies, but if you prefer, you can set your browser to block them. Our cookies can contain information, such as your user ID, our website uses to recognize you. Our cookies can't read data off your hard disk or read cookie files created by other sites. The only personal information our cookies contain is the information you provide. When you enter personal information on our website, your personal information will be linked to the cookie we save on your computer. If you do choose to delete your cookie, you may not be able to use the administrative features of the website.

How Is My Personal Information Protected?

Women's Business Council is committed to protecting your personal information and has developed policies and procedures to ensure our compliance with our own Security and Privacy Policy and with applicable Federal and Provincial laws. We also understand your concerns about online security and do our best to prevent the loss, misuse or alteration of information under our control. We have no control over how other websites fulfill their obligations and conduct their privacy policies. We encourage you to review the privacy policies posted on the websites linked to our website.

Will My Information be Shared?

When you voluntarily provide us with personally identifiable information online, that information is kept within the Women's Business Council organization and will not be shared or distributed.

What if I Want to View or Update My Personal Information, or Want You to Stop Using or Retaining My Personal Information?

You may, at any time, view and update any of your personal information. The only information required for the membership directory (accessible only to other registered users) is your name and the committee to which you belong.
