Nuisances

The Council discussed the status of the nuisances at 200 East Jefferson Street. The Council discussed the bid and the need to clean out the shop and agreed to table until spring to discuss further then.

Mayor Fishler informed the Council that he would like to take the sander truck in for maintenance. Fishler also informed the Council that the other truck was serviced at DJ Repair and there was nothing major wrong with it.

City Code Update

City Clerk Learn reviewed a quote from Iowa Codification to update the City Code. The Council asked that ECIA be contacted for a quote as well.

Department Reports

Fire/Civil Defense: The annual steak fry will be October 26, 2024.

Streets: Council Member Lahr informed the Council that the streets had been done by Prairie Road Builders and that Randy will monitor them to ensure they are satisfactory. Lahr also informed the Council that he and Council Member Clark had filled potholes around town.

Park: Council Member Ries informed the Council that the committee is waiting on an estimate for a tree at the park and that planning was underway for lights at the City Park for the holiday season.

Water: Council Member Palmersheim informed the Council that the chlorinator is working now. The Council discussed safety procedures when there is a chlorine leak. The Council discussed the rate review being required by the Iowa Finance Authority.
