Mayor Fishler called the meeting to order at 6:00pm.

Nuisances

The Council discussed the property at $516 - 6^{th}$ Street as a complaint had been received on the condition of the yard and the junk there. City Park Project

Council Member Ries updated the Council on the park project, noting all the mulch had been placed. The Phase 1 of the project is complete with the exception of the holiday tree as they are still getting quotes. Ries also informed the Council that 15 vendors were signed up for the vendor fair in the park this Saturday.

Water Testing/Maintenance

The Council discussed a stipend for Zach Fishler who has been doing the daily water testing and working with Operator Dean Hendricks on maintenance issues. Mayor Fishler informed the Council that the City truck needs to be taken to DJ Repair for maintenance as the check engine light is on. Council Member Lahr noted that when the City bought the truck, the dealership said the City should drive the truck a little ways each month.

Snow Plowing

Council Member Lahr informed the Council he'd talked to Daniel Palmersheim and he'd be willing to be back-up for Zach Fishler for plowing. The Council discussed the pay rate for snow plowing. Motion by Ries, seconded by Clark to hire Zach Fishler and Daniel Palmersheim (as back-up) for snow plowing this winter at a rate of \$20 per hour.
