\* Medicare: You will receive a \$98.95 rebate (refund) from Medicare for 10 psychologist sessions per year with a Better Access Mental Health Care Plan (MHCP) referral from your General Practitioner, Psychiatrist or Paediatrician. We process your rebate online so the money is automatically refunded into your nominated bank account.

\*\*Private Health Funds: If you are paying privately, you may be eligible for a partial rebate of your fees through your private health fund. Rebates vary depending on your health fund and coverage level so we recommend you check your coverage for a “General Psychologist Consultation” with your health fund prior to your consultation. Please note that health funds will not provide a rebate if you are already receiving a rebate through Medicare for the same session.

**\*\*\* Bulk Billing: 10% of Winnie’s caseload is dedicated to compassion work for significant disadvantaged people** e.g. Centrelink HealthCare card holders **after the standard fee initial assessment session**. Discounted session fees are offered for appointments between 9.30am to 12.30pm on weekdays only. Standard fees apply for appointments outside of these times.
