What information we collect, use, and why

We collect or use the following information to **provide services and goods, including delivery of vehicles:**

- Names and contact details
- Addresses
- Photographs or video recordings
- Vehicle details

We collect or use the following information to **comply with legal requirements:**

- Name
- Contact information
- Identification documents
- Vehicle details

Lawful bases and data protection rights

Under UK data protection law, we must have a “lawful basis” for collecting and using your personal information. There is a list of possible lawful bases in the UK GDPR. You can find out more about lawful bases on the ICO’s website.

Which lawful basis we rely on may affect your data protection rights which are set out in brief below. You can find out more about your data protection rights and the exemptions which may apply on the ICO’s website:

- **Your right of access** - You have the right to ask us for copies of your personal information. You can request other information such as details about where we get personal information from and who we share personal information with. There are some exemptions which means you may not receive all the information you ask for. [Read more about the right of access.](#)
- **Your right to rectification** - You have the right to ask us to correct or delete personal information you think is inaccurate or incomplete. [Read more about the right to rectification.](#)
- **Your right to erasure** - You have the right to ask us to delete your personal information. [Read more about the right to erasure.](#)
- **Your right to restriction of processing** - You have the right to ask us to limit how we can use your personal information. [Read more about the right to restriction of processing.](#)
- **Your right to object to processing** - You have the right to object to the processing of your personal data. [Read more about the right to object to processing.](#)
- **Your right to data portability** - You have the right to ask that we transfer the personal information you gave us to another organisation, or to you. [Read more about the right to data portability.](#)

If you make a request, we must respond to you without undue delay and in any event within one month.

Our lawful bases for the collection and use of your data

Our lawful bases for collecting or using personal information to **provide services and goods** are:

- Consent - we have permission from you after we gave you all the relevant information. All of your data protection rights may apply, except the right to object. To be clear, you do have the right to withdraw your consent at any time.

Our lawful bases for collecting or using personal information for **legal requirements** are:

- Consent - we have permission from you after we gave you all the relevant information. All of your data protection rights may apply, except the right to object. To be clear, you do have the right to withdraw your consent at any time.
- Legal obligation – we have to collect or use your information so we can comply with the law. All of your data protection rights may apply, except the right to erasure, the right to object and the right to data portability.

Where we get personal information from

- Directly from you
- CCTV footage or other recordings

How long we keep information

All personal information held by us will be stored for 6 years following the date of the last invoice we provide you with, or until we receive a request from you to remove such information. If however, you only obtain a quotation from us without accepting our offer then, we will remove your personal data upon expiry of the quotation. Some information must remain within our records for the purposes of legal obligations such as HMRC requirements for business record keeping.

CCTV imaging is carried out at our premises first and foremost for the purposes of protecting our own assets and our customers vehicles. Infrequently, we may use this information to recall a vehicle registration from a customers previous visit. All CCTV imaging is recorded and held for a period of 5weeks before automatically being deleted.

Who we share information with

- Suppliers and service providers
- MOT garages
- Any law enforcement agency, should they ask
- If there is a change in ownership of this business, we might share your details with the new or prospective owner.

How to complain

If you have any concerns about our use of your personal data, you can make a complaint to us using the contact details at the top of this privacy notice.

If you remain unhappy with how we've used your data after raising a complaint with us, you can also complain to the ICO.
