- III. CORRECTION AND/OR APPROVAL OF MINUTES

Gary – we cannot open employee's records in a public general meeting. Chief Lane stated he has contacted the county attorney and is going forward with actions according to his hostile work environment complaint included in the packet. Lynnette Allen read correspondence from Scott Kennedy's concerns with Shirley Goudzwarrd's ongoing harassment of the chief, employees and volunteers. Scott pointed out the process for written complaints. He also encourages the board to consider asking Shirley to step down. Board communication and correspondence via text, email or otherwise is public information under MT 2-6-1001. There are regulations that do not permit secret board meetings outside of the posted board meetings. Dave Perez says the county and department websites for the minutes of the meetings are not accurate. Chief Lane stated the minutes are sent to the county and uploaded by the county.
