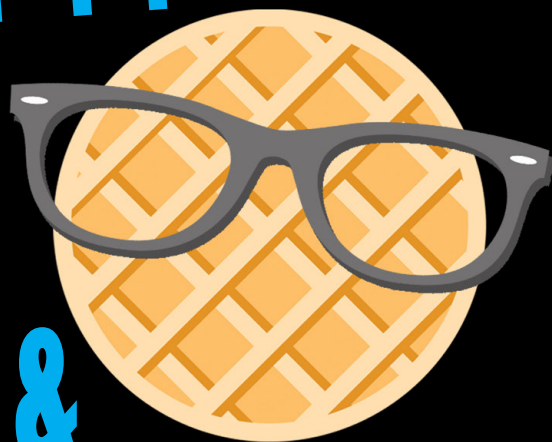

# On the Horizon

## CHANGE CAN CAMPAIGN

We are about to start our Change Can Campaign for 2020. We will be calling all the churches that have participated in the past and hope you will continue to participate in the future. We have two options for you this year.

**OPTION #1-** We can send you as many change cans as you wish. You can distribute them to your congregation. They will have approximately six months to fill them up with change they receive from daily shopping and restaurants. Some churches have children bring in "Coins for the Children" each Sunday and put them in the can during Bible class. Our tradition is to have the cans returned at our annual Fish Fry and Open House. You can come to campus on the last Saturday of September, return the full change cans, and enjoy a free catfish lunch.

**OPTION #2-** We can send you information about Hope Harbor's special emphasis Sunday on May 31, 2020. We will ask you to build up the excitement for a special contribution to Hope Harbor's campaign. If you wish, you can designate where you want your funds to be directed: Grocery Costs, Utility Costs, or General Operations.

When we call your church please let us know the person who will serve as the contact for this special campaign. Or you can call us and let us know that you will be participating in either Option #1 or Option #2 and the name of your contact person. Thank you for supporting Hope Harbor.

**ROUND UP APP - Hope Harbor is also on the ROUND UP APP. You can download the app from the app store on your phone and assign a credit card to it that will round up your purchases on that card and donate the extra change to Hope Harbor. ## PERISHABLE FOOD ITEMS

Hope Harbor is proud of the many churches who provide canned goods and other nonperishable items for our pantry. In addition to these donations, we spend about \$700 each month for perishable items (meat, bread, milk, salads, etc.) for each cottage. Who knew that growing teens would eat so much? We have sent a letter to the churches encouraging them to pick a month in 2020 that they will cover the cost of the perishable foods that we need to purchase. So far, one church has graciously answered our plea. If you or your church would like to cover one month this year, please call Bob Whiddon, our Executive Director, and let him know which month you would like to help us out.
