WHO?

- Attorney Clarence Davis, of Griffin Davis

WHAT? An Initial Demand Letter (NOT a lawsuit) seeking:

- The HOA financial / budget statements for fiscal years of 2020 through 2022.
- The status of replenishment of the stolen HOA funds in the amount of \$349,320.00.
- To conduct a forensic audit of HOA records.
- To compel the Developer to run the HOA in a compliant manner (including bringing all financial accounts and past due maintenance requests into good standing).
- To potentially request the Developer to relinquish the HOA to the member homeowners if the terms and conditions are favorable and homeowners are in agreement.

WHY?

- · Multiple ignored requests for OUR financial records.
- Hiring of a convicted CFO. Subsequent theft of HOA funds by said CFO.
- Protracted lapse of landscaping, maintenance, and repair services.
- Lack of fulfillment of numerous HOA obligations.

WHEN?

 The time is NOW to protect our Homeowner rights. We have an excellent attorney, and we have a plan. This is our moment to try to change the situation or else live with the status quo.

THE ASK?

- The legal plan has a budget of \$25,000.
- We are asking each participating household for a contribution of \$150 by personal, bank check, or money order.
