AMENDED DECLARATION OF

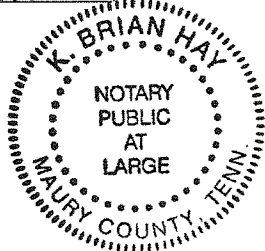
