 - b. Section 10 is hereby amended to read as follows "No residence shall be constructed on any lot which shall have an outside finish of any material other than brick, vinyl siding, or material approved by the Architectural Review Committee as set forth in paragraph 3. On the front and ends of the houses, no bare foundation blocks (painted or unpainted) can show and must be covered with brick to grade.
