**AMENDED DECLARATION OF

Unless owner(s) of lots in the Oak Lake Estates Subdivision (Section 9) elect in writing to become members of the Oak Lake Estates Subdivision Homeowners Association, they shall not be responsible for paying any dues, fees or assessments to the Oak Lake Estates Subdivision Homeowners Association nor shall they be permitted to use any of the common areas maintained by Oak Lake Estates Subdivision Homeowners Association.

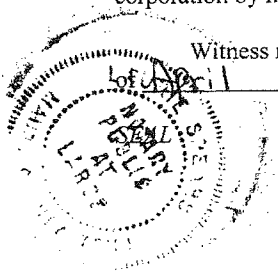
