Public Comment .Jay talked about the need for a S. Lake Ogemaw access to the road way which would be in Mills Twp. Supervisor stated he would have to work with the Mills Twp. Board on that issue. Blight issue at 2521 M-33 & neighbor's trailer With discussion not a blight issue per the Twp.'s ordinance.

Blight issue at 1863 Cuyuga Trail- neighbor. Roof Tarp is not in the Twp.'s Ordinance. Not a blight issue.

Discussion on Township selling additional grave sites to resident that have situations of family member's deaths.

Township gives two plots to our residents at no cost- we do not sell additional plots to residents & non-residents.

Board will ask the Sexton to come to the next meeting for discussion on plot selling and land available.

Unfinished Business: MTA Dues

Churchill Twp. Board Members disagree with the request of dues for the County MTA. There is no answer when asked what the funds would be spent on other than if they need to pay for a speaker. After contacting many past members of MTA we were told they have never had to pay for a speaker. Board does not feel comfortable using Twp. funds when there is no reason for the money. The exception to the dues is hosting a meeting at your Township. Churchill Twp. did host and supply refreshments & food to those that attended at the cost of the Board Members- no Township money was used. Churchill Township was planning on hosting again in 2026- there are only four meetings per year.

At the September County MTA Meeting a motion was made and carried to not allow non-paying dues members To attend the meetings.

Treasurer contacted the County Prosecuting Attorney with the question "does the County MTA meetings fall under the "Open Meetings Act" There is a quorum of elected officials, minutes are taken, agendas are handed out & votes are held.

The answer to the question is all Churchill Twp. is requesting- no further action is being taken- We just want the knowledge of the Open Meeting Act & County MTA meetings.

Since meeting things have been blown out of portion, have been told they hired and attorney. Suggested was to host the next meeting in November to end issue- even though another township was scheduled to host.

With Discussion Board will wait for answer from Prosecuting Attorney and does not plan to go any further than to have the question answered.
