Churchill Township Monthly Minutes.

July 1, 2024 Meeting called to order at 7 pm

Pledge of Allegiance

Jay Balog spoke on having maintenance done to the Lake Ogemaw Roads since the Road millage passed.

Supervisor stated that he drove the roads and agrees that Mohawk Rd. does need some work done. Also talked about Choctaw Trail being a busy road that the dust is really bad and would like to have this road considered for paving. Supervisor will get with road commission & get some quotes. Requested was to have a sign place stating no heavy trucks.

M. Vincent told the Board that she is on the Road Commission's agenda for Wednesday on the road issue with her home at Lk. Ogemaw. B. Reasoner suggested culverts to channel the water away. They will bring a plan with estimated costs for the Board to review. Supervisor will also contact the Road Commission for quotes too.

**Commissioner Report:** Commissioner David told the Board that they are working on the budget and still are having funding issues. The jail is a big cost so they are looking at housing out inmates & closing the jail. She told us that the Road patrol is only working to midnight and are on call after- with 911 deciding if to call them out. Questioned was how the millage for night patrol was not being used as voted in by the public. She stated they can levy the millage if it's not being used properly by the sheriff. She said the animal control officer retired and they may not replace the position. She reminded us of the upcoming elections & discussion on how DDA's capture taxes.

We Thanked Commissioner David for the updates as she had to leave for another meeting.

**New Business. Contracts for our Special Assessment garbage areas.**
