Commissioner report: Commissioner Wiltse informed the Board that EDC is looking for funding, he gave a report on what they do for the County. He said the Sheriff Dept. is doing some night patrols coverage but not the 24/7 as the millage that had passed. The sheriff office has now moved into the Correction building. He stated that the first Quarter is in and the savings they have from closing the jail. That Ogemaw County has a housing shortage.

The County approved 1.2 million to repair the County building-new window, remodel bathroom heat & cool system with ARPA funds. Commission meeting are now held in the Court house with security available there.

Unfinished Business: Road commission is getting pricing for the ultra-thin paving to be done at Lake Ogemaw.

Motion Carried on the Bid for painting the Twp. Hall heat vents of \$ 700.00 with ARPA funds.

Motion Carried on bid to Replace men's toilet & install a mop sink & pluming of \$ 961.00 with ARPA Funds.

Supervisor gave a report on the Fire Dept. and the yearly bill for fire protection cost.

Motion Carried to pay the fire protection bill with Ogemaw County Fire Dept.

Discussion on future improvement to the Township hall.

Supervisor: Report to the board on the Fire Dept., Road Commission, Emergency manager grant writing.

He stated the slaughter house on M-55 had to submit a new plan that would be 330' off roadway-is approved.

He also told the Board that BST Exteriors –they cut the Cemetery & Twp. Hall lawn did not renew the contract.

Per Discussion of the Board on the great job they do all spring & summer

Motion Carried to offer BST Exteriors Cemetery cutting at \$500.00 & Twp. Hall at \$50.00.

Clerk: Reported that the school is holding a May Election renewal millage.

Treasurer: Informed the Board at the high Interest totals we have received on the savings & roads accounts.

Motion Carried to donate the old law books to the Ogemaw County Antique Village.

Motion Carried to discard broken equipment in the furnace room.

Trustee Lauria- no report.

Trustee Quigley told the Board that the Amish school is looking for donations, they are having problems at Bass Lake & County is hiring a part-time animal control officer.
