After careful consideration, the Housing Corp Board votes to raze old house

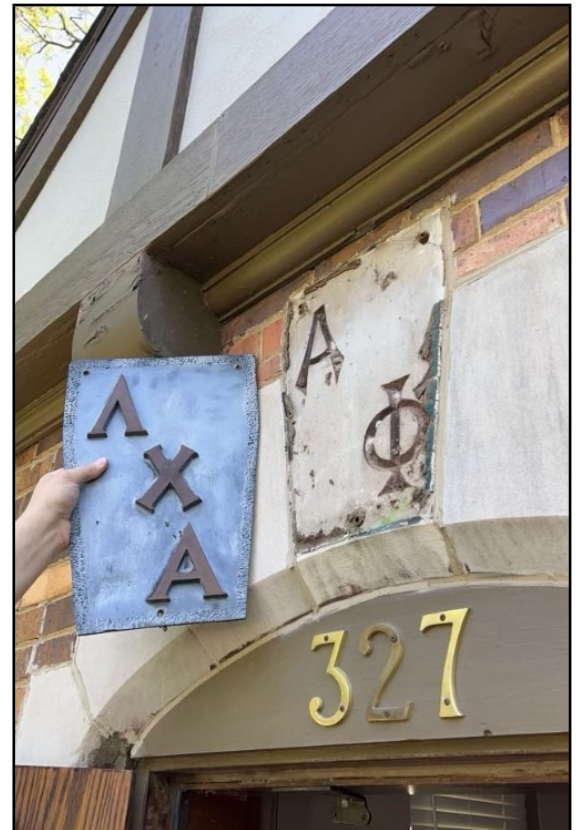
The Alpha-Gamma Zeta Housing Corporation Board voted unanimously on June 11 to proceed with razing the old house after July 4.

Ever since the 2019 Spencer Ruff & Assoc. engineering report, we've been on a countdown to getting our undergraduate brothers out of the building.

A number of additional factors helped the Board determine that now was the right time:

House is no longer safe—while great care has been taken to ensure building safety during the entire history of our chapter house, the Board no longer believes the house to be safe for our Undergraduate Members.

Final construction cost comes in higher than hoped

The Building Committee, chaired by Mike Runge (ΑΓ 1379), has worked diligently over the last year to obtain a construction cost that would meet our initial fundraising

goals and achieve a mortgage-free outcome post construction. After a competitive bidding process and several design iterations, the construction

Upcoming maintenance costs—we must replace the boiler and have a number of other high cost repairs coming due

High insurance costs—our insurance rates have drastically increased, and if the house was left empty, rates would rise even more.

Vermillion codes precludes a remodel—we discovered on April 21 that had we pursued a remodel, we would not have been able to meet Vermillion City Codes ([§ 155.083 NON-CONFORMING USES AND STRUCTURES](#)). (F) No existing nonconforming use or structure shall be enlarged, moved, or structurally altered except to change to a permitted use. This is not to include normal repairs and maintenance, which do not enlarge, move or structurally alter a nonconforming use. (Ord. 1189, passed 7-7-2008; Am. Ord. 1409, passed 12-2-2019)).

Actives won't live in it next Fall—the Active Chapter informed us before the end of the Spring 2023 semester that none of them intended on living in the old house next fall, citing safety and cleanliness concerns.



High construction costs (continued)

costs to build the new House are coming in at \$3.5 million versus our initial projections of \$3.0 million.

With additional costs such as furnishing, fundraising, and potential bridge loan interest, **we need to better close the gap before we begin construction.**

With your help, we hope we can pay off the bridge loan soon after the construction has been completed, without taking on a long-term mortgage.

A more detailed look at our financial model from our Finance Committee led by Randy Sorensen (AF 989) will be forthcoming in the next month. The Building Committee continues to work industriously to find ways to stay in budget. Detailed construction costs will also be communicated as we solidify them.

We are so fortunate to have construction and finance professionals on our team!

Chapter Houses over the Years

When we move into our new chapter house, it won't be the first time Alpha-Gamma Zeta has transitioned into a new building. In fact, this will be our fourth home, but it is the first purpose-built fraternity house in our USD history.

The first home was the C.M. Ruyan house at 101 Prospect Street, two blocks south of campus.

The second house was almost a mile south of campus at 401 Park Lane on the bluff overlooking the Vermillion and Missouri Rivers. What a view! But what a walk to campus! Roger Mjoen (AF 790) spoke with the current owners in May 2023 and discovered that the previous owners reduced the size by one third because it was "too big," and they added a garage.

Our current chapter house at 327 N. Pine Street was originally

built in 1931 as the Alpha Phi Sorority house. We purchased it from the A-Phis in 1937. Jim Hart (AF 656) recalled that his aunt was an A-Phi and had the same room he had above the front door (second floor, first on the right)!

On May 20, Brandon Wilsey (AF 1653), Dave Landry (AF 867), Logan Stone (AF 1979), and Triston Curry (AF 1989) met to remove composite photos, plaques, trophies, the fireplace hood, and other items

and carefully put them into storage during the construction of our new house.

Upon removing the letters from above the front door, the original Alpha Phi letters were discovered engraved into the keystone. We plan to clean up the stone and present it along with a framed blueprint to the A-Phis during Dakota Days 2023.

Black Hills Mixer August 17

The next Black Hills area mixer will be in Sturgis at the new Sturgis Brewing Company on Thursday, August 17, from 5 to 7 p.m.

The brewery is right off Exit 32 at 600 Anna Street, and has great food and beer, a cool atmosphere, a tree-covered lawn, and is promised to be biker-free by August 17! The crowds will have cleared out, so it will be a nice time to visit Sturgis—and maybe buy some leathers on sale!

The Annex: The Other House

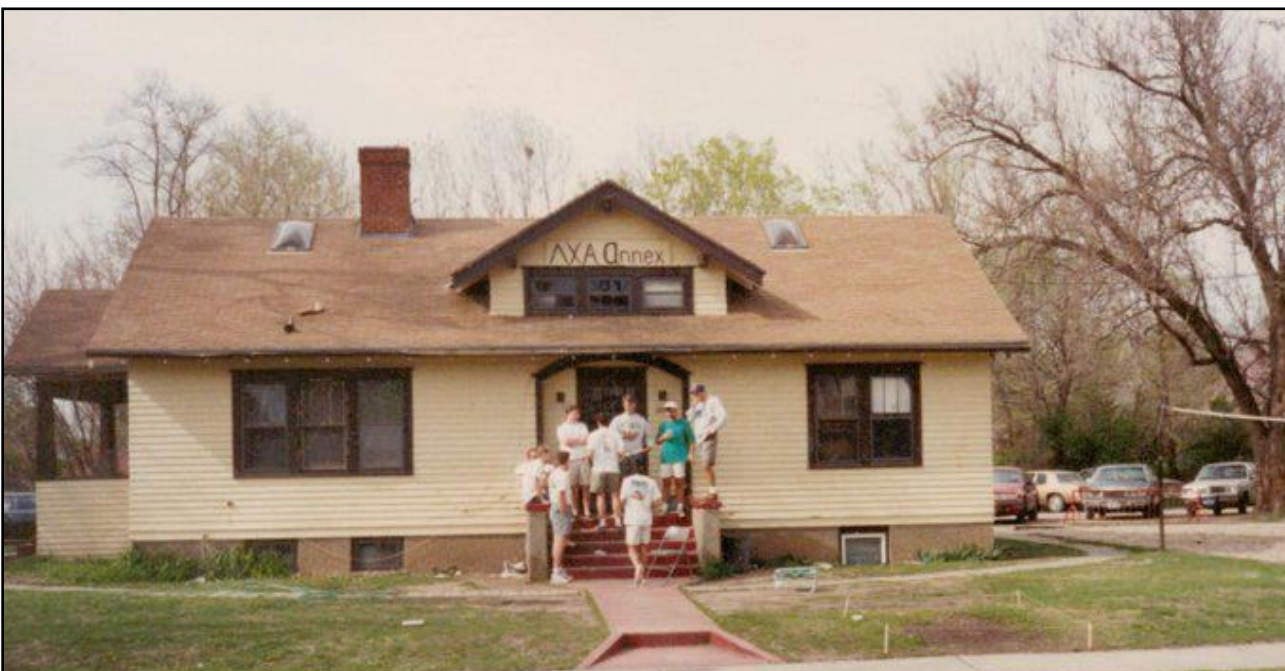
First purchased in 1967 to provide additional housing for members, the Annex across Madison Street from the “Brown House” served the fraternity (pretty) well for over 30 years. Generally used as housing for seniors or fifth-years, the (usually) quieter Annex was a great way to keep upperclassmen engaged with the fraternity without as many loud Thursday night parties outside your bedroom door.

Financially, the Annex was an incredible success, costing us little in the purchase or upkeep, and bringing in another seven to eleven house bills or so. Jeff Esbenshade (ΑΓ 757) recounts the years of the Annex, which was sold in 2000.

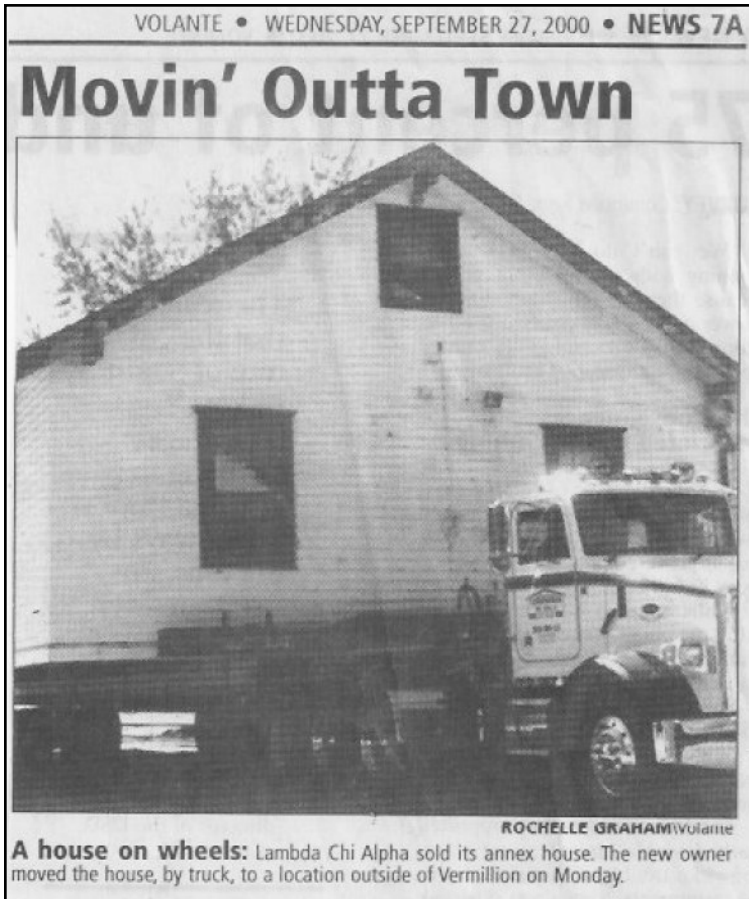
The property was sold to the University for \$42,000 to create additional parking spaces, 15 of which are earmarked for Lambda Chis.

Believe it or not, the Annex lives on! After being purchased for \$1,500, the building was moved to north Greenfield Road by a farmer for his hired man to live in. It has a walk-out basement, new windows, new siding, and French doors that open to the front porch. Esbenshade said that the farmer gave him a tour and that he did a really nice job on the kitchen and bathrooms. Roger Mjoen tried to take a photo, but the trees are too thick from the road.

Helping Kids Round First

Lambda Chi's continue to be involved in philanthropic projects well after their years at USD. In 2009, Craig Severtson (AF 904) founded "Helping Kids Round First," a non-profit organization that provides baseball equipment and instruction to youth in rural Nicaraguan communities. Baseball is the most popular sport there.

"Baseball has a unique ability to both bring together different cultures and teach life lessons helping to provide a foundation on which to improve lives," according to their website Helping-KidsRoundFirst.org.

Severtson developed the organization as a way to continue professional baseball player Roberto Clemente's legacy of giving underprivileged youth opportunities through baseball. Brother Jim Plucker (AF 896) is also on the non-profit's board.

Plucker, who first went to Central America in 1969 on a mission trip, said that over 250 families have gone from dry land farming to irrigated farming, and have built poultry sheds providing fresh eggs for children. Two shipping containers of supplies are sent annually.

Their annual banquet is Thursday, November 16 at the Sioux Falls Hilton Garden Inn. The keynote speaker is John Randle, Hall of Fame defensive tackle for the Minnesota Vikings.

Tordsen Completes First Session as State Representative; Petersen Serves as Legislative Intern

The 98th South Dakota Legislative session came to an end on March 9 as state lawmakers wrapped up their regular work for 2023. While this year's session was held in high regard by many in the South Dakota political sphere, it also stood as a testament to our chapter's continued involvement in the lawmaking process.

Two of our brothers, an active and an alumnus, played integral roles in the success of the 2023 South Dakota legislative session. One of these brothers was Representative Tyler Tordsen (ΑΓ 1863), a 2015 graduate of USD who currently serves as the High Pi (alumni advisor) of our chapter. Tordsen, who resides in Sioux Falls and works as the Southeast Regional Director at the Office of U.S. Senator Mike Rounds, was elected to represent the people of District 14 in the state House of Representatives in November of 2022. After completing his first session as a legislator, Tordsen had many good things to say about his experience.

"I thought it was awesome. It was very humbling, exciting, chaotic and pretty much everything I expected it to be plus so much more. Taking my oath, being able to sit on the floor, voting on legislation, and being a part of the process was very cool." Tordsen carried five bills this past session, all of which were approved by both chambers and sent to Governor Noem's desk. The bills dealt with subjects ranging from election security, commerce, tribal relations, and workforce initiatives. However, when asked about what interested him the most

this session, the freshman legislator stated that the budget was what garnered most of his attention and that he was proud to have been a part of the discussion on it.

"When the dust had settled, we had delivered a balanced budget that gave tax dollars back to the people and took care of what we needed to take care of." Tordsen was among a small group of legislators under the age of 35 and credits both his education and membership to Lambda Chi Alpha as

what inspired him to seek public office at such young age.

“When I joined Lambda Chi Alpha, I didn’t realize how much of a political legacy we had. I think that our fraternity, our culture, and our people produce leadership qualities among all our brothers. I’d really give credit to USD and Lambda Chi Alpha for the alumni network I was able to meet early on and for giving me so many opportunities to be a leader in a number of different capacities.” Tordsen is a former two-term High Alpha of the Alpha-Gamma Zeta and has continued to live by the Seven Core Values of our fraternity, even in his current role as a state representative.

When asked about the values that are most pertinent to serving in the Legislature, Tordsen said candidly, “All of them, really. I think integrity, service and stewardship, and respect would be the three that stand out most. Obviously, there is a sense of duty to it as well. Anyone can have the personal courage to run and throw their name into the mix, but if you are not doing it with integrity and respect for the people you represent, you may have considerably less success.”

Despite it being his first year as a member, Tordsen is no stranger to the South Dakota Legislature, having served as an intern for then-Senate Majority Leader Russell Olson (ΑΓ 1479) as a USD junior during the 2013 session. Olson is also an alumnus of Lambda Chi Alpha who helped Tordsen receive “the best internship experience possible.” The experience opened up many other job opportunities for him, including

an internship at the governor’s office under alumnus Dennis Daugaard (ΑΓ 917) in the Summer of 2013.

The South Dakota legislative internship program continues to attract service-minded students from colleges and universities across the state. Among this year’s pool of interns was me (High Rho Griffin Petersen, ΑΓ 1998)! During the session, I was assigned to Majority Leader Will Mortenson of Pierre, and my tasks included conducting policy research, reaching out to constituents for feedback, and assisting the House Republican Caucus with other daily tasks.

I greatly appreciated the opportunity to witness the legislative process firsthand and I very much enjoyed being able to work alongside our current High Pi in the halls of the South Dakota Capitol. Given both of our involvement in the session this year, it is clear that Lambda Chi Alpha continues to produce the next generation of state and national leaders with its robust alumni network and its core teachings!

We have lived and continue to live independently in a retirement community for the last eight years where we enjoy a pool, exercise classes, play bridge and fellowship with the other residents.



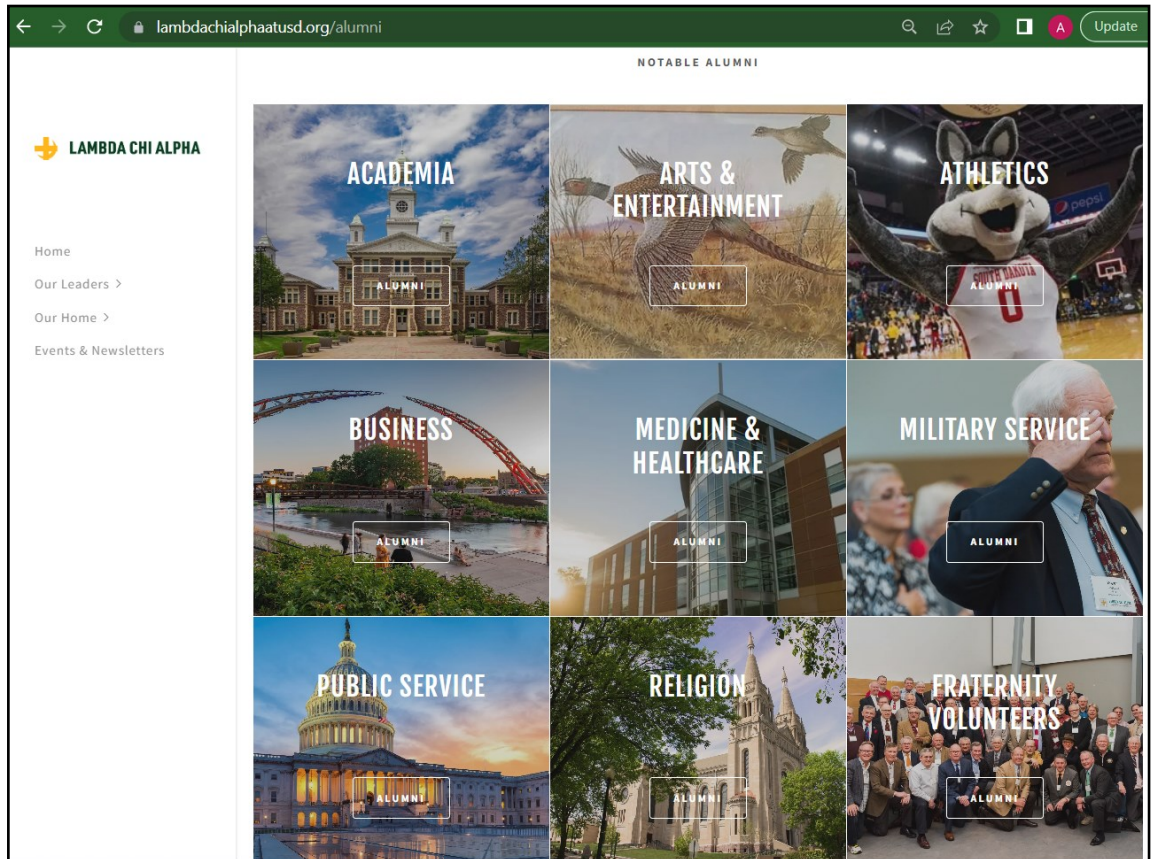
Notable Alumni Added to Website

January 30, 2023: **John Bailey Jones** was born March 30, 1927, in Mitchell, SD, to John B. and Grace (Bailey) Jones. Eldest child of a Lyman County homesteader, John grew up in Presho with his sister Margaret Jones Konik and his brother Kenneth Jones. John enlisted in the US Navy in 1945, taking a bus to boot camp immediately upon graduating from Presho High School that year. John saw service in the naval occupation forces in Japan, as the war ended while he was enroute on a ship. While there, he received a Pacific Fleet Appointment to the US Naval Academy in Annapolis. After attending the Naval Academy Prep School for only one semester, he concluded that his future was in South Dakota, not in service as a naval officer. Following his honorable discharge, John enrolled in the University of South Dakota (go Yotes!), Vermillion, where he obtained a degree in Business Administration in 1951 and a Law degree in 1953. While attending college, John met a lovely young nursing student from Yankton, Rosemary Wermers, whom he married in 1950. Between 1951 and 1958, the young couple were blessed with six children.

After graduating from Law School, John established a solo law firm in his hometown of Presho. That same summer, he was appointed County Judge of Lyman County and his lifetime of public service began. In 1956, the voters elected him to a two-year term in the SD House of Representatives, electing him again in 1958. John continued to practice law until he was appointed to the South Dakota Circuit Court in 1967 by Governor Nils Boe. He presided as a state judge, with his office in Kennebec, SD, until 1981, when President Ronald Reagan appointed him to the federal judiciary as a United States District Court Judge for South Dakota, assigned to the Sioux Falls federal court. John took senior status in 1995, reducing the amount of time he spent on the bench. In 2002, the South Dakota Trial Lawyers association presented Judge Jones with the Fred J. Nichol Award for Outstanding Jurist. Judge Jones was respected as an intelligent, humble, patient, quiet, gentle man who treated everyone fairly and courteously. Attorneys and other court personnel considered him to be a firm but fair judge, and an excellent mentor.

John held many leadership roles on judicial committees and commissions, as well as state and local Bar Associations. including State Bar Commissioner from 1965-1968. Some of John's service memberships include the Elks, Veterans of Foreign Wars, American Legion, Lions Club, Presho Methodist Church, Lambda Chi Alpha social fraternity and Phi Delta Phi legal fraternity. He also served as a Boys State Counselor and president and vice president of the South Dakota Boys State Corporation. Even after moving from Presho, he frequently returned to assist in the maintenance of the Presho Cemetery, continuing past his eightieth birthday.

Family ranked highest among John's priorities as he and Rosemary lovingly raised their six children: John Jr. (Shirlene), Bill (Ruth), Mary Lou (Don) Schuh, Dave (Gerry), Judy (Brian) Bauman, and Robert. The young family spent many memorable summers camping together throughout the country and even ran their own campground, giving

the children summer jobs and responsibilities. Gregory Stanley Smeenk, age 70, took his last breath on this side of heaven on Easter, April 9th, 2023. He was surrounded by his family. He was born February 23rd, 1953, in Rapid City, SD as the youngest of 2 children. He grew up as the 3rd generation on the family ranch.

He attended Newell High School, was active in football, bull riding and met his wife Sherry in high school. At the University of South Dakota, he earned a double major Bachelor of Science in Psychology and Sociology with an emphasis in Criminal Justice and was a member of Lambda Chi Alpha Fraternity where he earned the title of "The Governor." He worked as a police officer in Vermillion and Rapid City after college.

From 1977 until 2005 his family owned and operated a ranch in northern Butte County, approximately 8,000 acres in size, a livestock operation consisting of cattle, sheep, and buffalo. The total number of cattle was about 400 head, sheep numbers ranged from 500 to 1,200 head, and the buffalo cow herd was 300 head. He also rented pasture and ran beef cows and sheep with neighbors on a share basis.

He became a licensed private pilot for a single engine aircraft in 1974. He flew his plane to check livestock daily with his most memorable flights being a snake falling into his lap from the ceiling when he was in the air and flying a loop with his uncle Mac.

For 15 years, he operated a hunting enterprise on his ranch taking in deer and buffalo hunters. Greg shot a world record buffalo on his ranch in 2004 which was recorded in Safari Club International with a total scoring of 79 2/8".

He was in many movies, Ford commercials, magazines and books with his most memorable movie roles in "Thunderheart" with Val Kilmer, "Roads," "Lakota Woman," and supplying horses for the movie "Dances With Wolves."

He got his real estate license in 2004 and just 2 years later, became a broker and started his own real estate company, Dakota Properties of Belle Fourche. For the year 2008, he was the Top Producer for the Northern Black Hills Association of Realtors out of 153 realtors and was recognized by the South Dakota State Legislature.

He had a commercial real estate business in the Black Hills of South Dakota and Oklahoma. In 1987 he purchased his first apartment building, a 15-unit residential complex. Since that time, he added more apartment units and storage rental buildings, all of which he was the general contractor for. His most recent business venture was building a wedding venue, The Barn Out West.

He was a member of the Northern Black Hills Association of Realtors, President of the Dakota Territory Buffalo Association, Director of the South Dakota Sheep Growers, Black Hills Round Up Club and Western South Dakota Buckaroos.

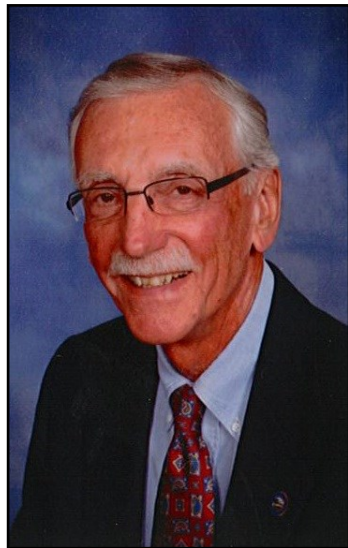

In 2012, Jerry was inducted into the Dakota State University Innovators and Influencers Hall of Fame, an accomplishment that was especially sweet for him, as he had been a champion of (and largely responsible for) changing the University’s mission to technology *continued on next page*

focus in 1984.

While Jerry was certainly proud of his professional achievements, where he found the most joy was in spending time with family and friends, as well as indulging in his hobbies and charitable ventures. Jerry bought his beloved Piper Dakota low wing four-seater plane in 1977 shortly after he and his wife learned to fly. In addition to commuting to Pierre for the legislative sessions, he enjoyed flying to various places throughout the country, often with the family in tow. In 2002, Jerry and Nancy flew to New York as part of the Flight Across America tribute to the victims of 9/11. In the 1980s, Jerry and Nancy began volunteering for AirLifeLine, an organization that helps medical patients get to treatment centers that are too far away for them. When it was time to return to the lake home that he and Nancy owned since they were wed, there was always a Corvette in the garage, one of his few, true self-indulgences.

Jerry was also active on many local organizations and boards in Madison. His life-long commitment to the Kiwanis organization is just one of the ways Jerry showed a steadfast commitment to the community he called home.

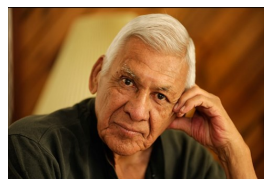
