2018 Report from the Rev. Matthew R. Rasure

Last year, in my 2017 Annual Report, I highlighted that we at First Baptist Church have experienced exciting growth in our membership and worship attendance. I am so happy this trend has continued into 2018. I also called on the Church Corporation to commission a Bylaws Task Force, which the Corporation approved enthusiastically at the same meeting. The goal of the Bylaws Task Force is to investigate how we can adapt our institutional identity and structure to the changing demands and energies of our parish leaders—both established and emerging. I called for applications to join in this important work and four persons were selected: Kimberly Frazier-Booth, Beverly Mattatall, Ruth Kline, and Ken Tarr.

The work of the Bylaws Task Force began in earnest in the Autumn of 2018, and the first fruits of their labor has been before you on recent weeks in the form of the survey all attendees and members have been asked to complete. After compiling the results of the surveys, the Bylaws Task Force will conduct sit-down meetings with the current boards and committees of the church as well as at-large meetings to engage people in directed conversations about their dreams and visions for the structure, identity, and institutional values of our parish. By late Autumn or early Winter of 2019, we should have a draft proposal for the Corporation to begin considering, debating, and revising.

As we look forward to growing into the fullness of what God is calling us to be in terms of our organization and community ethos, it is imperative that we take seriously our calling to be faithful stewards of the resources God has entrusted to us. Our anticipated pledged giving for 2019 remained the same as it was for 2018. First and foremost, pledges totaling \$155,000 are a cause for celebration and should be commended. Your generosity and faithfulness makes our ministry at First Baptist possible.

When I look at these numbers, however, I have tinges of concern when I think about where we might be in five, ten, or even twenty years. How are these figures going to change as portions of our giving population transition from the workforce into fixed incomes, as life circumstances change, and as people pass from this life into the greater reality of God?

As the costs of housing and food continue to increase in this area while wages stagnate, underemployment abounds, healthcare costs spiral, and educational debts continue to hamstring the economic potential of the emerging workforce, the economic reality of our parish and EVERY OTHER Mainline parish like ours is changing.

In the midst of this, what will this mean for our work here? As the new bylaws go into place, I am calling on the Church Corporation to begin a process of serious discernment concerning the abundant resource we have. These resources are indeed abundant—our endowments, our Church Building, our Educational Building, our properties, and our volunteer base. We need to establish a clear plan for how we will use them faithfully and shrewdly to meet the demands of ministry today, taking careful account of their potential and their setbacks.

Our founders gifted us with abundant resources which they used to the best of their abilities in their day to build and to care for our dear community. We owe it to them to bring the full resources of our creativity and imagination to do the same in our day.

I believe we have been called to pursue excellence in our shared values of music, Christian education, and community formation. I also believe it is possible to continue to pursue the same excellence we have enjoyed even as economic realities continue to evolve, but it will not happen passively.

There is so much potential for us to do the work of God in this community, bringing beauty, inspiration, and hope. The needs of the community are certainly very real, and I encounter them face to face every single week. Families in our town and in our parish face food insecurity, forgoing meals and sacrificing fresh healthy options for the sake of price. Families in our town and in our parish live paycheck to paycheck and are one crisis—one car repair, one medical bill, one service charge—away from free fall. Families in our town and in our parish work long hours and sometimes multiple jobs to cobble together money for rent, household needs, and some basic enjoyment. This changes how people give. It changes how people volunteer. It changes what people expect to have asked of them when they come into God's house for a moment of peace.

Above all else, that is what we offer to those who come to us—the peace of Our Lord, Jesus Christ. This is our one and only message, and it is the only thing that will endure years, decades, and centuries after we are gone.

As we consider these questions, I ask the Church Corporation the same four questions with which I have closed the last two Annual Reports.

Are we willing to take risks?

Is our vision too small?

Do we know how to tell the story of our church and invite others to join us?

And most important of all, do we really want to?

Once again, I would like to thank the parish for the incredible privilege of serving this precious community.

2018 Board of Christian Education Report

Our church provides Christian Education for all ages from toddlers to adults. It is our belief that as Christians we are lifelong learners. Our board offers programs for all to grow and learn. Some of these programs are Sunday School for all ages, Childcare and Make and Learn during the church service and programs for our youth.

Thank you to our Superintendent of Sunday School, Barbara Drauschke, who has served for many years. We appreciate Barbara's dedication and all that she does to keep things running smoothly. Barbara also accompanies our youth to the Judson Association youth group meetings.

Thank you to Rachel and Jarmel Dumond for their faithful service taking care of our infants, toddlers and preschoolers. Thank you to those that have filled in when needed. Thank you to all the volunteers that have lead Make and Learn for our children in Grades 1 through 5.

Thank you to Jodi Cloney for leading our youth for the first part of 2018. Thank you to Tricia and Diane who have stepped in to lead the second half of the year. The youth meet on designated Sundays during the church services for fellowship.

In addition to the weekly Sunday activities the board also puts on a number of special events. On Easter Sunday, after the breakfast, an Easter Egg Hunt is held. The youth have filled the eggs with candy and toys. They then help to hide the eggs. The children look forward to this event and helps keep them occupied before church.

In June we celebrate and recognize graduates from high school and college. This year we celebrated the graduation of Alexa Barnes, Nicholas Romano and Rachael Zaniboni. Children's Day is the end of Sunday School for the year. It is celebrated with presentations from each Sunday School class during the morning worship service. This service is planned by the teachers and Barbara Drauschke. The attendance awards are presented and Bibles are given to first graders. Children and teachers receive plants at the end of the service. Thanks to Fred for ordering and picking them up. After the service there is an all church luncheon to celebrate.

We held our Vacation Bible School the week of July 23rd. There was a total of 9 students that attended and 5 teenager assistants. This is a great way for them to earn community service hours. Thank you to all the volunteers for their time and help to make our VBS program a success.

A special thanks to Dr. Nancy Crandall who helps teach the children some songs. We raised \$150 for the ABCUSA for mission project to provide clean water for people in Haiti.

We had a few activities throughout the year sponsored by Christian Education. The youth once again hosted the coffee hour for Souper Bowl Sunday with the donations going to a local food pantry. In February we had a family game night and in April we held a family movie night with the showing of Disney movie Coco.

In September we celebrated Rally Day which is the start of Sunday School. We would like to thank all the dedicated teachers who faithfully give of their time for education of our children and adults.

We held our German Dinner for Saturday night supper. It was well attended and enjoyed by all.

In December we planned our annual Come to Christmas, the Christmas Pageant and Christmas caroling. Come to Christmas is a time of fellowship where families make Christmas crafts and enjoy a pot luck supper. The Christmas Pageant is an event that we all look forward to. The story of Christ's birth is acted out by our children of the Sunday School. The teachers and volunteers work hard practicing with the children to be ready for the pageant. Caroling to our shut-ins is an all church event that we participate in. It is a time to bring cheer to our members who are in nursing homes or unable to come out to church.

We began the implementation of our new Child Safety Policy to continue ensuring the safety and well-being of all the children participating in FBC activities. Beyond having many of our long standing practices standardized, having this official policy and enforcing it will materialize in substantial annual savings on the church insurance premiums.

We would like to thank all the board members who faithfully worked to make all our events a success and continue to make our educational programs run smoothly. Your work is greatly appreciated.

2018 Church School Superintendent's Report

We are proud of the Christian Education program that we offer at First Baptist Medford. Christian Education is a lifelong learning experience, and we have room in all our classes for more—please try us, you might like us! Our church school attendance averages 20-25, with less on a bad weather day or holiday weekend, and as many as 36 on an excellent day.

Our children's classes use curriculum which we purchase from Cokesbury, called Deep Blue. It comes with take home leaflets for the children, as well as materials to help the teachers with the lessons, such as posters, games, music CDs and stickers. Children start in a church school class at age 4, and the program continues through high school. Our adults use a discussion based curriculum, also from Cokesbury that they really enjoy.

One area of concern has been that many of our class members miss a lot of the material when they are absent. Rev. Matt did an extensive search of other curricula for children and youth, which included an at home/on line component. We had already started the fall quarter, and in the end we decided to stick with what we have been using, but to keep an open mind about making material more accessible for those who can't attend in the future. If you are interested in this, please let me know.

Younger children, infants up to age 4, are provided with childcare from 9:30 a.m. until noon on Sunday mornings. We thank Jarmel and Rachel Dumond who have provided childcare the past two years. They sometimes alternate coverage during worship so they can worship with us. We sometimes have a youth group volunteer to help with childcare during worship. These youth can get community service credit for their volunteer efforts.

Thank you to all the teachers: Barbara Drauschke and Diane Tobey, Carmel Dumond and Tricia Voner, Bev Mattatall, and Alan Rogers and Roberta Jenner. Thanks to those who filled in to teach the adult class when Alan or Roberta were not available. Rev Matt teaches the Koinonia Class (adult class) about once a month. The adult class attendance remains strong, often with as many as 10 participants.

Please see the report of the Board of Christian Education for more details about events during the year. We offer Christian Education for all ages, and invite you to participate. We encourage you come join a class at 9:30 a.m. some Sunday morning. All are welcome.

2018 Missions Outreach and Social Concerns Committee (MOSC)

The committee had a busy year promoting four American Baptist offerings, helping the shelter on Central Ave, preparing a monthly Saturday night supper and redeeming the returnable bottles and cans to help with the church expenses (and the environment). We have had good support from our committee members Marie Paul, Joe LeFave, Alan Rogers, Staci Cummings, and liaison reps Chuck Shepherd from Diaconate and Roberta Jenner from Christian Ed.

We had our annual cookout in June for the families, and provided hot dogs, hamburgers, potato and pasta salad, fruit salad, chips, cupcakes, cookies and fruit punch. We also brought the children toys to play with outside.

In November we cooked a Thanksgiving Dinner at church and transported it to Central Ave. Dinner included turkey, stuffing, roasted sweet potatoes, three hot vegetables, cranberry sauce, pickles, olives, bread and butter, milk, apple cider, apple pie, cupcakes, cookies and brownies.

In December we cooked a Christmas dinner with all the fixings at our church and transported it to Central Ave. We served Baked Ziti, and for dessert we had cupcakes, cookies, brownies, ice cream and apple pie. Alan Rogers came as Santa Claus, and the children loved it! These meals are an opportunity to get to know the residents and become comfortable with one another. We often talk to the women about the programs the church offers, and have recently added them to the Carillon mailing list. A couple of the children were able to come to the vacation bible school, and some families came to Come to Christmas, and to the Christmas Eve Service.

Throughout November and December Roberta Jenner did a lot of shopping and wrapping for the women and children. With some donations from our members and \$700 from the Judson Association grant we were able to provide gifts for all the children and mothers. We also provided small gifts for the staff.

A new mission project, which does not cost anything to participate: If you buy soda, soup, or fruit in cans, many of them now have flip top openers. Please take these flip tops off the can lids, and bring them to church. We are collecting them to be given to the Shriners. They use the value from the metal collected to help defray the cost of transportation for children from all over the world to the Shriners hospitals.

We continue to collect cans and bottles that are returnable for which we collect the 5 cent deposit. Thanks to Bev Mattatall and Anthony Voner for counting and bagging these and taking them to a redemption center. The money helps with church expenses. We thank Bev who is no longer a member of the committee, but she continues to help us out when needed.
