Minister's Report from the Rev. Dr. Matthew R. Rasure

Dear FBC Family,

Because of the way our Annual Corporation Meeting is set in our bylaws the vast majority of the reports contained in our Annual Reports through the years were written a month or two after the close of the year they describe. This volume for 2019 is a wholly different matter. The rise of the Global COVID-19 Pandemic has delayed the 2019 Annual Report quite significantly. I am writing these words in September (!!!), perched more than a year after most of the events described herein. As I have thumbed through these pages three things stand out to me.

2019 does not feel like "just yesterday." It feels like a vast world away.

2019 was particularly beautiful in its normalcy and predictability. Most of the programs and traditions of the church continued on as they have for decades, without a hitch.

2019 saw some exciting new endeavors begin that will only come to full expression in 2021.

So, while this volume does focus the lion's share of its attention on fondly remembering past, these pages are also suffused with a bright hope for exciting possibilities in the future. There are certainly many efforts that deserve attention here, and I would like to call attention to five.

- 1. The Bylaws Taskforce has focused much attention and effort trying to understand the capacities and needs of our congregation from administrative and missional perspectives. Their work will help to keep us running efficiently and collaboratively for years to come.
- 2. The Food Security Task Force has begun the work of understanding the nature of food needs in our surrounding community, and has given us a framework of options for how we might discern our next steps to answer Jesus' call to love our neighbors.
- 3. The Choral Fellows and Scholars Program began its inaugural work and the power of this innovate program has sustained and uplifted the worship of the Church in the midst of our exile from out building and in the face of challenges we could never have predicted. The visionary generosity of the Boston Baptist Social Union is a profound grace to our church and, indeed, to the Church Universal.
- 4. The Concerts @FBC Series received a \$5,000 grant in December of 2019 from the Medford Community Fund to support our 2020-2021 Season. While nary a dime of this money has yet been spent, nor has a single concert happened, this important seed money will be able to help us to create beauty in the community again as soon as conditions allow for the safe participation in live musical performance.
- 5. The work and ministries of the Affiliate Pastors of the church have been a wonderful and profound blessing to our congregation as well as to me personally. I offer my deepest appreciation to Pastor Greg Sakal, Pastor Florence King, and Pastor Rand Peabody, each of whom have enriched our worship and offered insight, wisdom, and vision for what God is able to do in any circumstance.

If the transition from 2019 to 2020 has taught us anything it is that what lies ahead should never be taken for granted. However, this is not cause for despair. The future ahead of us is bright.

I will close with the words of the Apostle Paul to the Church in Philippi, which feel beautifully bright and fresh at the beginning of this volume.

I thank my God every time I remember you, constantly praying with joy in every one of my prayers for all of you, because of your sharing in the gospel from the first day until now. I am confident of this, that the one who began a good work among you will bring it to completion by the day of Jesus Christ.

Philippians 1:3-6

May each of us do our part to cooperate with God in the completion of the good work in front of us!

Summer Series

In our Lenten services we focused on the visual arts, in the summer we turned our attention toward the musical. For the second year, Rev. Matt prepared & presented a study of songs of a spiritual nature: "A SECRET CHORD- the Spiritual Songs of Leonard Cohen,". In this study, held on select Wednesdays, discussions included Cohen's "Hallelujah" and his other songs on religious and biblical themes. The Canadian singer-songwriter's most well-loved and ubiquitous work, "Hallelujah." tells of a frail and broken King David looking for hope and redemption in music and prayer, and it has one of the most hauntingly beautiful choruses ever penned.

Affiliate Pastors

In its last meeting before the summer break, the Diaconate voted unanimously to recognize three people with the title of "Affiliate Pastor." This position recognizes a person's great contribution to the health, well-being, and vitality of the Church Universal, and anticipates their continued service as needed among us in Medford. On Rally Day, the church recognized as Affiliate Pastors Greg Sakai, Rand Peabody, and Florence King.

- Pastor Greg Sakal, M.Div., recently retired from serving as the minister of Hill Memorial Baptist Church in Allston, MA, where he lives He served "The Hill"—as they call it—for ten years. He trained for ministry at the Episcopal Divinity School in Cambridge, and served for many years as librarian at the New England College of Optometry.
- Rev. Rand Peabody, D.Min., served as an interim minister in parishes across New England before retiring several years ago. Among the parishes he served was the West Medford Congregational Church. He and his wife, Sally, split their worshipping time between Old South Church in Boston and FBC-Medford. Rand was trained at New Brunswick Theological Seminary and Andover-Newton Theological School.
- Rev. Florence King, D.Min., has been a member of FBC-Medford for many years. She was ordained at FBC-Malden, and has served at FBC-Plymouth, Messiah Baptist Church of Brockton, among others. She was trained for ministry at Andover-Newton Theological School.

We are thankful for the leadership of Pastor Greg Sakal, who took over pastoral & preaching for much of December and into January 2020, while Reverend Matt, his wife Rev. Rachel Pettengill-Rasure and Jack welcomed Magdalena (Maggie) Marie Rasure on December 13th. Notwithstanding that joyous event Reverend Matt presided over our Christmas Eve Service, uniquely positioned at that time to help celebrate the birth of the Christ child.

On Sunday 12/30, the Diaconate developed and presented a new "Lessons & Carols Service." with key music provided by the congregation, and Music Director, Dr. Nancy Crandall, and giving the choir a rare Sunday break. Thanks to all who offered the readings, including Doug Tibbets, who lead a review of the possible spiritual references in the "Twelve Days of Christmas."

In September we celebrated Rally Day which is the start of Sunday School. We would like to thank all the dedicated teachers who faithfully give of their time for education of our children and adults.

We held our German Dinner for Saturday night supper. It was well attended and enjoyed by all. In December we planned our annual 'Come to Christmas', the Christmas Pageant and Christmas caroling. 'Come to Christmas' is a time of fellowship where families make Christmas crafts and enjoy a potluck supper. The Christmas Pageant is an event that we all look forward to. The story of Christ's birth is acted out by our children of the Sunday School. The teachers and volunteers work hard practicing with the children to be ready for the pageant. Caroling to our shut-ins is an all church event that we participate in. It is a time to bring cheer to our members who are in nursing homes or unable to come out to church.

2019 was a challenge financially for our church partly due to necessary repairs to the church heating system. Even with a reliable cash flow, these expense fluctuations can be challenging. Because of their efforts, the Finance Committee has been able to manage these variations.

The faithful giving of our congregation enabled us to end the year with a positive checkbook balance.

As we look forward to 2020, we are grateful for the congregation's response to our financial campaign. We continue to work to control expenses and increase income. Hopefully, the growth in the stock market will help us with increased income.

We want to thank the committees that worked on the Saturday night suppers and special dinners which raised over \$3,000. Thanks to everyone who supports these events.

We want to acknowledge and thank our Treasurer, Wendy Cox, Financial Secretary, Diane Tobey, and Treasurer of Invested Funds, Tricia Voner, for all their hard work.
