This is a perfect opportunity to display and distribute information about your services. Each booth is 10'x10' and organizations may request several spaces as needed to accommodate their displays. At least one individual must staff your booth at all times.

Because we know you'll want to take advantage of this fun and exciting way of getting the word out, we have enclosed an application for a courtesy space. Since space is limited you should return your application as soon as possible. Submitting this application does not guarantee a booth space. Booth spaces are limited and are assigned on a first-come, first-served basis.

We understand that you need the support of your employees and volunteers to achieve your mission, however, life shouldn't be all work so we would like to invite your staff to come early or stay after their shift to enjoy the festival. Employees and volunteers will receive free admission on any day they complete a shift for your agency or organization.

In an effort to make the admission process as easy as possible, we ask that you complete the attached (required) worker roster. We will post your list at the front gate so your staff can gain admission at no cost. Of course we won't be able to allow anyone in, without a charge, who is not listed on your roster. Please be sure to include all individuals that will be assisting you.

By signing this agreement, the exhibitor agrees to use full capacity of the space allotted and to make the given area attractive and colorful, keeping in mind the theme of the Festival and the public nature of the event.

**Exhibitor is responsible for providing all staffing, display equipment, tables and chairs.** Exhibitor agrees to setup exhibit on **Friday, January 23, 2021 between 10 AM and 6 PM.** Exhibitor agrees that no portion of their display will be removed prior to 5 PM on the last day of the event. However, Exhibitor agrees to have everything removed from the Festival grounds by NOON the day after the event is over.

The Exhibitor agrees to indemnify and save harmless Pinal County, Central Arizona Festival Association, Festival Executives, their officers, agents and employees from any and all claims, causes of actions and suits occurring or resulting from any damage, injury or loss to any person or persons, including but not limited to persons to whom the Exhibitor may be liable under Workmen's Compensation law and the Exhibitor himself and from any loss of property, goods, wares or merchandise, caused by arising out of or in any connected with the exercises by the Exhibitor of the privileges herein granted. The Exhibitor further agrees to obtain their own insurance against risk of all kinds and description and to indemnify Pinal County, Central Arizona Festival Association, Festival Executives, their officers, agents and employees from and against all claims and demands, costs, charges and expenses which it may incur, suffer or be put to in connection with the use of said premises by said Exhibitor.
