Youth Dairy Goat Department Rules

Complete entries include online entry plus Exhibitor Signature form with all signatures, copy of YQCA certificate and Seasonal Pass and entry fees. **Entries MUST be entered online and supporting documents must be uploaded (see red box). No mailed entries accepted. Incomplete entries will not be accepted.**

SHOWMANSHIP: Friday, March 15, 2024, 8:30 am

JUDGING: Breed Divisions - 15 minutes after Dairy Goat Showmanship, going in numerical order.

DAIRY GOAT EXHIBITORS PLEASE NOTE:

1. This show is not an ADGA sanctioned show, however, ADGA rules shall govern. All does must be registered in the youth exhibitor's name (or family name) with either ADGA, AGS, MDGA, or CGS. Animals not meeting this criterion WILL NOT be allowed to show. Does under six months of age can be shown with an official stamped duplicate registration. Animals (kids under 6 months) waiting for registration paperwork must be able to submit proof of both parent's registration.
2. All animals must be kept in livestock area. Any exhibitor found with their animal outside livestock area will not be allowed to participate in the auction. Species coordinator may make exceptions to this rule as needed.
3. Age base is March 15, 2024. Use the base date to establish the age of the animal for proper class placement for the show.
4. The exhibitor must have an animal entered in the dairy goat department to participate in showmanship.
5. Scurs, over 2" on does, not accepted.
6. Bucks over 3 months of age and horned animals are not eligible.
7. Animals are to come clipped/trimmed.
8. Exhibitors are responsible for tattoos on animals entering the show ring.
9. Pens will be assigned by the coordinator based on the number of animals entered. No pen switching will be allowed. Tack pens will be assigned only if space is available. No pen consideration will be made for animals not entered in the show.
10. Pinal County Fair Dress Code required. *Refer to General Rules* **NOTE: in addition, dairy showman may wear show whites.**
11. Dairy goats will be selling in the small auction and not the large livestock auction. **Animals must be entered and judged in Division 3208: Dairy goats for Auction, to be eligible to sell.**
12. All kids must be checked in to the coordinator at check-in deadline.
13. Animals that are due to kid within 2 weeks of fair are ineligible to attend fair.

**** Nursing kids born after the deadline and before March 7, 2024 are eligible to come to fair but will not be allowed to enter to show.****

DIVISION 3208: Dairy Goats for Auction

Animals must be entered in this division if they wish to participate in the small stock Auction.

1. If the exhibitor has 2 animals entered they *MUST* inform the coordinator immediately following show, their choice to sell or not to sell.
2. Exhibitors can enter 2 but are limited to selling a total of one Dairy Goat in the Auction.
 - o Wether: any breed or mix (two years of age or less)
 - o Doe: any age
 - o Buck: born on or after January 1, 2024.

Class Description

- 100 Junior Doe Kid: 2-3 Months
- 101 Senior Doe Kid: 4-6 Months
- 102 Junior Doe Yearling: 7-12 Months
- 103 Senior Doe Yearling: 13-24 months

Senior Does

***Must have freshened at least 1 time.

Class Description

- 104 Milker Doe: yearling - less than 2 yr
- 105 Milker Doe: 2yr less than 3yr
- 106 Milker Doe: 3yr less than 4yr
- 107 Milker Doe: 4yr less than 5yr
- 108 Milker Doe: 5yr and over

DIVISION 3215: Showmanship

Must be entered at time of Entry. All exhibitors are required to enroll in showmanship classes.

Class Description

- 100 Junior Novice: Junior member - first year project
- 101 Junior: 8yrs -13yrs prior to Jan. 1, 2024
- 102 Senior Novice: Senior member - first year project
- 103 Senior: 14yrs -18yrs prior to Jan. 1, 2024

Winners of novice division have the option to show in non-novice division. Winners from class 101, 103 will represent the Dairy Goat Department in the ***Round Robin Showmanship Contest***.

DIVISION 3216: Dairy Goat Poster Contest - No entry fee. Must be entered as exhibitor in this department.

Poster relating to and about Dairy Goats. Two entries per exhibitor. Poster must be submitted day of goat receiving. All posters will be displayed. Poster size 18"x 24".

Class Description

- 01 Junior: 8yr to 13yr prior to Jan. 1, 2024
- 02 Senior: 14yr to 18yr prior to Jan 1, 2024
