

# Great Oak Pet Resort's Policies & Requirements Release Form

*The mission of Great Oak Pet Resort is to provide a safe, fun and stimulating environment for your pet. To ensure the safety of your pet, we require the following rules and regulations.*

- All pets must be free of fleas, ticks and other parasites.
- All pets must be current in all required vaccinations, which are: DA2PP, Rabies & Bordetella.
- No pets will be allowed if it is human aggressive.
- All pets brought into the facility must be on a leash or in a carrier.
- We do not board or groom pregnant dogs that are late into their term. If your dog is pregnant, you are required to inform us so we can properly care for the mother and her unborn babies.

I understand that even though all pets are closely monitored, there is risk involved, including scrapes, cuts, bruises, bites and more severe injuries, which are commonplace due to the nature of dog play. Unless otherwise specified, your dog will be spending playtime with other dogs their size and or same temperament. Great Oak Pet Resort cannot guarantee the health of any animal, but pledges to give appropriate care to **all** boarded pets.

**I understand that Great Oak Pet Resort may/will separate my dog from interacting with other dogs if it is deemed necessary by staff.** This may include behaviors such as aggression, reactivity, mounting, and/or any other medical needs or concerns noticed by staff.

I hold this facility harmless for conditions that often are unavoidable in boarding environments, including but not limited to, **weight loss, potential tooth loss, rough hair coat, kennel cough, upper respiratory infection, H3N2 Canine Influenza Virus, diarrhea. hotspots and fleas.**

**I understand that I am solely responsible for any harm to staff or other pets caused by my pet while a guest at Great Oak Pet Resort.**

I give permission to Great Oak Pet Resort's employees or a veterinarian to administer treatment to my pet(s) should illness or injury occur, and **I will assume full financial responsibility for any and all expenses involved including emergency veterinary care.**

I hereby certify that my pet(s) is in good condition and has not been ill or shown any signs of coughing, sneezing, upset stomach or any communicable medical conditions in the last 30 days. I further certify that my pet(s) has not harmed or shown aggressive or threatening behavior towards any person or other pets.

**Personal items may be left at your own risk. We are not responsible for loss or damage.** All dog beds and blankets brought into the facility must be new or freshly laundered.

Any dispute between the parties shall be resolved without the aid of a jury (by a non-jury trial) by a judge of the 14<sup>th</sup> Judicial Circuit sitting in Jackson County Florida, applying Florida law without giving effect to any choice of law provisions.
