**CALL TO ORDER** Meeting was called to order at 7:00 p.m. In attendance were supervisors Jeff Eaton, Luke Weldon and Eric Taylor; Solicitor Gery Nietupski and Meredith Borstorff, secretary.

**MINUTES** Jeff Eaton moved to approve minutes of the May 12, 2025, meeting. Seconded by Luke Weldon; passed by unanimous roll-call vote.

**TREASURER'S REPORT** As of 6/9/25 Total Assets: General Fund -- \$748,428.16; Liquid Fuels -- \$237,598.35. Jeff Eaton moved to approve the Treasurer's Report (subject to audit); seconded by Luke Weldon; passed by unanimous roll-call vote.

**BILLS** Payment of the bills on the bill list were unanimously approved by a roll-call vote upon a motion by Luke Weldon and seconded by Eric Taylor. Bills as follows: GF \$179,961.04; LF \$2,758.09. P-card \$73.00; and \$1,639.33 paid during the month. The Unifirst bill will be reduced by \$77.40 because pants were returned on May 8, 2025.
