Closing Remarks

Marks Of Excellence OREE Lifetime Achievement Award

lesse White is Illinois' 37th Secretary of State. White was first elected to the office in 1998 and won landslide victories in 2002, in which he won all 102 counties, and again in 2006 and 2010. On November 4, 2014, White was re-elected to a record-breaking fifth term, winning another landslide victory by a 2-to-1 margin in which he earned over 2.3 million votes statewide. White became Illinois' longest serving Secretary of State on May 30, 2014.

The Illinois Secretary of State's office is the largest and most diverse office of its kind in the nation, providing more direct services to the people of Illinois than any other public agency. As State Librarian, Secretary White oversees the State Library and literacy programs, and as State Archivist, he maintains records of legal or historic value.

Under White's leadership, customer service has been improved through the use of technology as well as modernizing and streamlining operations. Wait times in facilities are shorter than ever before. Illinois has become a national leader in road safety as White strengthened DUI laws, reformed the CDL program and overhauled teen driving guidelines. As a result, traffic fatalities have decreased, with drunk driving deaths down nearly 50 percent and teen driving deaths reduced by 51 percent. In 2014, White was inducted into the Illinois High School & College Driver Education Association Hall of Fame.

Prior to his election as Secretary of State, White served as Cook County Recorder of Deeds - a job to which he was first elected in 1992 and re-elected in 1996. Before that, he served 16 years in the Illinois General Assembly, representing the most culturally, economically and racially diverse district in Illinois.

In 1959, White founded the internationally known Jesse White Tumbling Team to serve as a positive alternative for children residing in and around the Chicago area. Since its inception, more than 17,500 young men and women have performed with the team. White has spent 58 years working as a volunteer with the team to help kids stay away from gangs, drugs, alcohol and smoking, and to help set at-risk youth on the path to success. The program has received international praise. This year the team will make more than 1,500 performances using seven units, consisting of 225 young men and women. Currently, there are 51 members enrolled in college. In 2014, the Chicago Park District opened the Jesse White Community Center and Field House in honor of White's lifelong contributions to the community. In addition, a school in Hazel Crest, Illinois, was recently renamed the Jesse C. White Learning Academy, and a Chicago street was designated Jesse White Way in honor of White.

White served our country as a paratrooper in the US Army's 101st Airborne Division and as a member of the Illinois National Guard and Reserve. He played professional baseball with the Chicago Cubs organization, which was followed by a 33-year career with the Chicago Public Schools as a teacher and administrator.

Jesse White earned his Bachelor of Science from Alabama State College (now Alabama State University) in 1957, where he was a two-sport athlete earning allconference honors in baseball and basketball. In May 1995, White was inducted into the Southwestern Athletic Conference Hall of Fame. He was an all-city baseball and basketball player at Chicago's Waller High School (now Lincoln Park High School) and was inducted into the Chicago Public League Basketball Coaches Association Hall of Fame in June 1995. In 1999, he was inducted into the Alabama State University Sports Hall of Fame. Born in Alton, Illinois, he now lives on Chicago's Near North Side. White has two daughters, Glenna and Lorraine, and two grandchildren, Jesse and Susan.





1st Congressional District of Illinois

U.S. Representative Bobby L. Rush is a transcendent and influential American leader who keeps his legislative and policy interests focused on the needs of his constituents in the 1st Congressional District of Illinois, with an emphasis on the most vulnerable and the communities that have been left behind. Rush is a senior member of the House Energy and Commerce Committee, where he serves as Chair of the Energy Subcommittee, and is also a member of the House Agriculture Committee.

Some of Rush's proudest accomplishments as a Member of Congress fall under the issue of civil rights, an issue that inspired him to enter public service. Rush was the original House sponsor for the Civil Rights Cold Case Records Collection Act, which created a board to review what materials from Civil-Rights-era cold cases can be declassified and released to the public. During his last term in Congress, Rush also reintroduced the Emmett Till Antilynching Act, designating lynching as a federal crime and defining lynching as a conspiracy to commit a hate crime that results in death or serious bodily injury. The bill passed the House on a 422-3 vote and passed the Senate unanimously, before President Joe Biden signed it into law in March 2022. Despite 200 previous attempts to pass an antilynching bill in Congress since 1900, this was the first time such legislation was able to get through both chambers and signed into law.

In office since 1993, Rush has been a steadfast champion of civil rights and legislative initiatives to create jobs, tackle gun violence, and make communities safer. Rush is an honorably discharged veteran of the United States Army and an ordained minister with a master's degree in Theology, and he holds honorary doctorate degrees from the Virginia University of Lynchburg, Roosevelt University, and the Illinois Institute of Technology (IIT). In addition to his Congressional responsibilities, Rush is the pastor of the Beloved Community Christian Church of God in Christ in Chicago. Rush listens to his constituents with a pastor's ear and acts on their needs through hard work, empathy, and a commitment to public service.





Cook County Commissioner, 2nd District

Cook County Commissioner Deer proudly represents one of the most diverse districts in Cook County. The 2nd Cook County District extends north to Division, south to 75th Street, east to King Drive and west to Laramie. He serves as Chairman of the Health and Hospitals Committee, and the Cook County Sustainability Committee for Cook County Government. In addition he serves as Vice-Chairman of the Cook County Forest Preserve Finance Committee.

He is a graduate of Jackson State University, where he earned his Bachelor of Science in Elementary/Special Education and the Master of Science in Rehabilitation Psychology. He later went on to earn his Ph.D. in Christian Psychology. Born and raised on Chicago's west side, Dr. Deer remains a resident of the North Lawndale community. He has a long history of community service and has worked extensively with local community organizations on employment and training, reentry, economic development, affordable housing, healthcare, and education. Dr. Deer is a Certified Rehabilitation Counselor, Licensed Clinical Professional Counselor, Clinically Certified Forensic Counselor, and a Certified Corrective Thinking Therapist.

He is also an Illinois Law Enforcement Standards and Training Board Certified Instructor, as well as a Cognitive Restructuring National Trainer. With this, Dr. Deer has been able to help craft solutions to community issues using multiple lenses. His passion for the community became evident some twenty plus years ago when he returned to North Lawndale and founded Deer Rehab Services Inc., a company that has become one of the most well-regarded providers of comprehensive services for ex-offenders. Dr. Deer went on to later start the Law Enforcement Family Training Services. Both organizations are full-service training, curriculum design, and consulting firms.

Dr. Deer serves on several not-for-profit and community boards including Strategic Human Services and North Lawndale Community Coordinating Council which he co-founded. He was also appointed to the Illinois Department of Human Services (IDHS) Domestic Violence Advisory Council (DVAC); Partner Abuse Intervention Programs Subcommittee; Executive Steering Committee of Domestic Violence Accountability Council (DVAC); and is Vice President of the Illinois Coalition Against Domestic Violence. In addition, he is a graduate of the Goldman Sachs 10,000 Small Businesses Program and Chicago Urban Leagues Nextone business accelerator. Dr. Deer's long track record of serving the community demonstrates a sustained level of involvement over many years, and a track record for giving back

He has not only served the community in many roles, i.e. as a community organizer and in executive leadership roles, something that he insisted upon to make himself easily available to people who most needed his help. Through his work, Dr. Deer has helped to transform the lives of individuals and families who stopped believing in themselves and/or were counted out by society. He has been and continues to be a servant-leader, a person who is unquestionably dedicated to the community and works collaboratively to impact positive change. Outside of his work as a Commissioner Dr Deer served as Vice President of Org. Health and Mgmt. with Lawndale Christian Legal Center. Dr. Deer is married to his high school sweetheart, and he and his wife Barbara have three teenage children.





Ben Oluwole-Johnson is one of the founders and pioneers of the African United Organization in Chicago. The organization was responsible for assisting and advising people of the African Diaspora residing in Chicagoland to ensure that they are educated, productive, and empowered to contribute their time to serve the communities where they live.

Mr. Oluwole-Johnson helped galvanize the African community of Chicago to support the mayoral candidacy of the late Mayor Harold Washington. He recruited volunteers to support candidate Washington and provided training on the essence of community and public service by Africans.

Mr. Oluwole-Johnson was the Director of Financial Services under Mayor Washington's administration. He also previously served as Executive Assistant to Mayor Eugene Sawyer, Deputy Executive Director with the Cook County Housing Authority, and Cook County Deputy Comptroller during the tenure of Cook County Board President Todd Stroger.

Mr. Oluwole-Johnson is currently CEO of his own company, Benol Development Corporation, that has developed, financed, and constructed retail, commercial and residential projects worth more than \$850 million in minority neighborhoods. Addditionally, he has held various executive positions in the private sector.

Mr. Oluwole-Johnson has advocated for African Americans to be considered for top administration positions in public service at County, City and State levels of government. He has a bachelor's degree in Business Administration from Roosevelt University and an MBA from Keller Graduate School of Management of DeVry University. Mr. Oluwole-Johnson has received numerous honorary, professional and leadership awards from nonprofit organizations and governmental institutions.

She is steadfastly committed to life safety and protection of property for all residents and visitors of Chicago, in addition to the safety and continuing education for all CFD members. She is acutely aware of the importance of training and preparedness and works with many external groups and organizations to ensure that Chicago is as prepared as any metropolitan city can be.

A native of Chicago, Ms. Nance-Holt was raised in the Maple Park community on the southside and attended both parochial and public schools. In May of 2007, tragedy hit when her 16-yearold son, Blair Holt, was fatally shot on his way home from school. Since Blair's death, Ms. Nance-Holt has supported parents who have lost a child to gun violence with the creation of the non-profit organization, Purpose Over Pain - an advocacy organization that supports parents who also lost children to gun violence, provides safe and positive outlets for children and youth, and advocates and promotes safer communities in Chicago, Illinois. Also, she volunteers with the Carl Holmes Executive Development Institute (EDI), which provides a curriculum that prepares Fire Service professionals with the skills to lead departments, which is hosted yearly at Dillard University in New Orleans, LA.

Ms. Nance-Holt is a member of St. Sabina Church, Delta Sigma Theta Sorority, Inc., the International Association of Black Professional Firefighters and the African American Firefighters & Paramedics League, where she once served as President and Vice-President.

Omer Osman was appointed Transportation Secretary by Gov. JB Pritzker in 2019. His role as secretary reflects three decades of experience at the Illinois Department of Transportation in engineering and management.

Moving through the IDOT ranks gives him unique insight into department operations and scope, funding challenges and opportunities, as well as the need for strategic maintenance and infrastructure growth to support economic development and travel for Illinois residents.


