

Longtime New Line Theatre actor and illustrator Zachary Allen Farmer teams up with New Line artistic director and writer Scott Miller for SHELLIE SHELBY SHARES THE SPOTLIGHT, a delightful story of a young woman discovering for the first time the incredible magic and power of musical theatre, as she embarks on a wild adventure through the treacherous social jungle of her first high school musical.



When Shellie gets cast in the school show, she can't believe her luck, but her best friend, poor tone-deaf JoJo McQuill, isn't so lucky. Can Shellie successfully navigate the drama club mean girls, her crazy philosopher-teacher, music rehearsals, killer choreography, and Tech Week, without losing her mind and her best friend in the process?

SHELLIE SHELBY is appropriate for tweens, teens, and adults, though it may not be appropriate for younger children. There are references to marijuana, but no other "adult content."

Just before the pandemic hit, Miller published his latest book of analysis Idiots, Heathers, and Squips: The New Golden Age of the Musical Theatre. After the theatres were shut down, he returned to writing, and he soon released a short story anthology, Night of the Living Show Tunes: 13 Tales of the Weird. And then for something completely different, he followed that up with the new songbook, Broadway Musical Christmas Carols, and just last month, he released The ABC's of Broadway Musicals: A Civilian's Guide, a fun, short, easy-to-read introduction to the art form.

Zachary Allen Farmer is a professional actor, singer, and illustrator. He has appeared onstage with New Line Theatre in dozens of shows, including as Barry in the American regional premiere of High Fidelity in 2008 and again in 2012; as Charles Bukowski in Bukowsical; as Sheriff Karnopp in the 2009 world premiere of Love Kills; and as Albin in La Cage aux Folles. He also appeared as Edna in Hairspray with The Black Rep and Washington University, and in several independent films, including the feature film Four Color Eulogy. He has written a number of radio plays and co-written several comic books.

Scott Miller is a musical theatre director, composer, lyricist, bookwriter, historian, consultant, self-proclaimed fanboy, and the founder and artistic director of New Line Theatre, the alternative musical theatre company in St. Louis. founded in 1991. He has a degree in music and musical theatre from Harvard University. He has written eleven musicals, two plays, more than a dozen books about musical theatre, and he also writes the Bad Boy of Musical Theatre blog. For fifteen years, he co-hosted the radio show Break a Leg: Theatre in St. Louis and Beyond on KDHX, and now he hosts the theatre podcast Stage Grok, available on iTunes. Miller's Amazon Author Page, with all his books, is here. He has written a number of musical theatre analysis collections, as well as the books Strike Up the Band: A New History of Musical Theatre; and It's a Musical!: 400 Questions to Ponder, Discuss, and Fight About.

### About New Line Theatre

New Line Theatre is a professional company dedicated to involving the people of the St. Louis region in the exploration and creation of daring, provocative, socially and politically relevant works of musical theatre. New Line was created back in 1991 at the vanguard of a new wave of nonprofit musical theatre just starting to take hold across the country.

New Line has given birth to several world premiere musicals over the years and has brought back to life several shows that were not well served by their original New York productions.

Altogether, New Line has produced 90 musicals since 1991, and the company has been given its own entry in the Cambridge Guide to American Theatre and the annual Theater World. New Line receives funding from the Missouri Arts Council, a state agency, and the Regional Arts Commission.



# Why You Should Avoid Opening a Retail Store Credit Card Just for the One-Time Discount (Hint: It Could Hurt Your Credit Score)

Store credit cards can be very enticing because they offer immediate value, typically in the form of a one-time discount or bonus cashback, but it can do more harm than good. Here are some things to consider before signing up:

## First Comes the Credit Pull

When you apply for any credit card, your credit report is pulled by lenders so that they can check your credit-worthiness. Unfortunately, this impacts your credit score negatively by a few points. By spacing out your credit applications, you’ll assure that your credit score won’t take a serious hit. But many pulls in a short time frame can definitely bring your score way down. And it could be worse for your score if you apply and are denied.

## Lowens Your Credit Utilization

How much of your credit limit you use has a major influence on your credit scores. The only thing that matters more is paying on time. The credit limits on retail cards that you use only at one store or chain are typically about 10% of those on comparable general-use credit cards, so in order to keep your credit utilization low, it’s suggested to pay your bill before the issuer reports the balance to the credit bureaus.

## High Interest Rates and Undesirable Terms.

While the average interest rate for an American credit card is around 15%, those for retail credit cards are usually upwards of 20% to 30%, and some cards can be even higher than this. Not only are rates high on this card, but they are variable and at the whim of the lender. This means you could start with what you think is a decent rate that is only increased a couple months later. It’s definitely not something you want to maintain a balance on and with interest rates like this, it won’t be long before your “discount” is canceled out by interest charges and your so-called bargain turns into a nightmare.

## Approval Can Decrease Your Credit History.

The “length of credit history” means how long any given account has been reported open. Generally, the longer an account has been open and active, the better it is for the credit score. Credit History calculates the average of how long all your accounts have been open. That average age of accounts is your “credit age.” Opening a new account often causes the average age of your credit accounts to decrease.

IMPORTANT NOTE: If you already have a store card? Don’t close it —that also would hurt your average age of accounts. Better to use it lightly and pay on time. Both actions have a positive effect on your credit scores.

## But Oh the Temptation.

You may sign up for a store credit card for savings, but if it leads you to spend more than you intended –either on the day you sign up, or subsequently –is it worth it? If you can’t keep an eye on your purchases as closely with a store credit card as you can without one, you might be better off without. As always, opening a credit card should not be done on impulse. Review all the factors carefully before deciding whether or not it’s worthwhile; don’t let your sales associate pressure you. After all, would you make any other important financial decisions in a busy check-out line?

## The Bottom Line

There’s no right or wrong answer when it comes to store credit cards. If it’s a bad idea for you to sign up for another card, making it a retail-issued card just makes it worse. On top of potentially hurting your credit score, retail cards have usability issues. They might only be good only at one store or retail chain, usually have high interest rates and typically have less robust security alerts than traditional cards.

You might be better off using a traditional credit card, especially if you have a rewards card that offers cash back on every purchase, not just the initial one. # Metro Theater Company and The Repertory Theatre of St. Louis Support Young Voices with #ENOUGH: Plays to End Gun Violence

Watch seven short plays produced around the country for free Dec. 14-20

The Repertory Theatre of St. Louis and Metro Theater Company are proud to present #ENOUGH: Plays to End Gun Violence – a yearlong theatre initiative that encourages teens to confront gun violence by creating new works of theatre, culminating in simultaneous staged readings across the country on Dec. 14.

“#ENOUGH brilliantly weaves together art and activism,” said Julia Flood, Artistic Director for Metro Theater Company. “When we give young people a voice, we all learn. When we let young people lead, we all benefit. When we empower young people, we all win.”

The public launch of #ENOUGH will be held on the eight-year anniversary of the 2012 Sandy Hook shooting, in which 20 young children and six adults were shot and killed at a Newtown, Conn. elementary school. Metro Theater Company and The Rep will host a pre-show discussion about the impact of gun violence with representatives from CureViolence St. Louis, the Institute for Public Health at Washington University and the St. Louis Public School System.

“Our children know far too much about gun violence,” said The Rep’s Augustin Family Artistic Director Hana S. Sharif. “#ENOUGH gives young people an outlet to express their fears and their hopes and to dream of a better future and take positive action to manifest it. The Rep is thrilled to amplify their voices and make these beautiful plays accessible to all communities.”

The mission of #ENOUGH, a sponsored project of the non-profit arts service organization Fractured Atlas, is to promote playwriting as a tool for self-expression and social change and provide a platform for America’s playwrights of tomorrow to discover and develop their voices today. Michael Cotey, #ENOUGH founder and producer, launched the project in 2019, inspired by the young people who took to the streets (and continue to do so) to manifest the change they wanted to see in the world.

#ENOUGH is making this collection of 10-minute plays available for free to any theatre, school, college or community organization to produce a reading on December 14. Educators can visit the #ENOUGH website to find a wealth of resources on involving their students in the 2020 readings, as well as creating and submitting plays for next year’s festival.

#ENOUGH: Plays to End Gun Violence is viewable at any time between December 14 and 20 for free on the streaming platform Broadway on Demand (BOD), which can be accessed from metroplays.org or repstl.org.

A pre-show discussion, hosted by Metro Theater Company and The Rep, will provide context for the plays to be performed and highlight some of St. Louis’ vital service organizations and mental health professionals, including CureViolence St. Louis (a program of Employment Connection), the Institute for Public Health at Washington University and the St. Louis Public School System.

# Missouri Botanical Garden Garden Glow



While much will be different about the 2020 holiday season, visitors can still enjoy a winter walk through the Missouri Botanical Garden at Garden Glow, a favorite seasonal tradition for many St. Louisans.

The Garden’s eighth annual Garden Glow presented by Wells Fargo Advisors runs nightly through January 2. The event features more than 1 million lights, photo opportunities, food, drinks, music, traditional favorites and new experiences. Hours vary by date. Advanced tickets are required and capacity is greatly reduced to allow for ample social distancing. Visit [mobot.org/glow](https://mobot.org/glow) for more information.

To ensure the health and safety of all, additional protocols are in place to prevent the spread of COVID-19. Those include:

- All employees and visitors will be required to wear face coverings. Cloth face coverings must cover the nose and mouth are required for everyone age 9 and older per the City of St. Louis and CDC guidelines. Face shields do not qualify as appropriate face coverings.
- All staff working on Garden grounds must pass health and temperature screenings prior to working the event.
- All interactive and high-touch points are being modified to reduce interaction.
- Visitors will enter and exit through separate buildings. All paths are one-way.
- Additional hand sanitizing stations will be placed throughout the Garden, including all point-of-sale locations and strategically around Garden grounds.
- Frequency and intensity of cleaning and disinfecting all high-touch surfaces is increased per CDC and EPA guidelines.
- Visitors displaying any of the following symptoms before visiting should stay home: coughing, shortness of breath/difficulty breathing, fever, chills, muscle pain, sore throat, new loss of taste or smell. Refunds and exchanges during this period will be honored without penalty.
- Plexiglass has been installed at the sales counters to protect staff and visitors. All payments are cashless; no signature is required for credit card transactions.

Ticket prices vary by date and range from \$3 to \$20. Family Nights, which include \$3 children’s tickets, are Wednesday nights through Dec. 9. For more information, visit [mobot.org/glow](https://mobot.org/glow).







## City of Brentwood Updates Related to COVID-19

The City of Brentwood continues to monitor developments related to the COVID-19 pandemic. **The following information is accurate as of December 7, 2020:**

**Brentwood City Hall is open to the public by appointment only. Please call 314.962.4800 to make an appointment.**

Visitors who need to drop off items for Planning & Development or other departments may place the items in the designated bin inside the main entrance to City Hall (the entrance that faces Brentwood Boulevard).

- Entry by members of the public into City Hall is by appointment only.
- Any member of the public requesting entry to City Hall must fill out the St. Louis County Public Health information sheet and have their temperature taken.
  - o Anyone symptomatic (per the Public Health form) or with a temperature equal to or greater than 100.4 F (38 C) will be denied entry into City Hall.
- Anyone granted entry into City Hall will be required to wear a mask and will be offered gloves and asked to use hand sanitizer.
- Anyone refusing to adhere to these guidelines will be asked to leave and referred to the Brentwood Police Department.
- Public restroom usage at City Hall is at the user's own risk.

### HOW TO CONTACT THE CITY

We ask Brentwood residents and community members to help minimize public contact during this public health crisis. Those who choose to opt in to this service will receive flash flood, tornado and severe thunderstorm warnings just moments after an alert has been issued by the National Weather Service.

If you wish to activate the Weather Warning Alert options, you'll need to register for CodeRED again.



You can enter a cell phone number, landline number and email address and select the types of weather warnings you wish to receive. There is no charge to residents or businesses for this service.

If you have not previously signed up for CodeRED notifications, you may do so at any time by clicking on the "Brentwood CodeRED" icon on the home page of [www.brentwoodmo.org](http://www.brentwoodmo.org).

We'll continue to send other public safety notifications, such as road closures or specific emergency situations, through the CodeRED system.

## Report a Concern

Make requests (such as scheduling a household bulk item pickup or a vacation check) or submit concerns (such as a missed trash pickup or a possible code violation) through the MyGov request tracking system via the home page of [brentwoodmo.org](http://brentwoodmo.org).

Click on the "Report a Concern" icon, choose a category and subcategory, complete the additional information and submit your request.



If you include your contact information, you'll receive feedback when the request is received and updates as the request is investigated by City of Brentwood staff.

City staff can see replies to City posts, but City staff is not able to see what you or your neighbors are posting on Nextdoor. 

## CITY ADMINISTRATOR REPORT Brentwood Bound Update

Craig Schluter with Navigate Building solutions gave an update of project and property acquisitions. He then shared his screen for a Power point presentation re: Unfunded Project Updates, which include-Phase 2 Trails, Dog Park, Event Lawn/Comfort station and Playground. The City has been very successful with partnerships and grants for these projects. One grant awarded is the Federal Clean Water Act Section 319, another is the Great Rivers Habitat Alliance grant, and then the Final Phase 2 Trail connections,

The Muny Grant was also received for the construction costs for Norm Wet Park. Project design by Christner is to be created and implemented in 18 months. 

# Memories Abound

With graduation from Webster Groves High School hitting the fifty-five year mark in June 2021, my life memories have acquired an even more golden glow. Softened and strengthened by time, wonder abounds at each remembrance, primarily, how did this occurrence happen so long ago? It surely seems just yesterday, or thereabouts anyway.

Many varied holiday memories have made their way into The Pulse since my first article about Maplewood’s iconic Goldie’s Department Store, a shopping landmark of the 1950s. It is rather astonishing to be gathering my thoughts for a tenth Christmas story, for which I’m very grateful.

Memories are perhaps more cherished in 2020, this emotionally difficult and exhausting year, with the election and Covid-19 still escalating as this is penned. This singular SARS-CoV-2 virus has caused profound loss and hurt, so the bright hope that is Christmas has never been more important.

Drawing my own sweet memories close, let’s join together, determined to focus on the joy and beauty of this season and on faith in the Lord, the reason for our annual celebration. In journeying back in time, one of my earliest memories is my five-year-old desire for a “Bride Doll.” The story has been written, but my heart still smiles at the remembrance of peeking around the corner and seeing Mom and Grandma in the kitchen on Christmas Eve.

They were ironing the bridal veil for the doll lying nearby, my mother’s own beautiful treasure from the 1910s which I would receive the next morning. Even though they had a hand in this present, I crept upstairs to keep a vigil at the bedroom window in hopes of seeing Santa’s sleigh and reindeer hail into view. Sleep overcame sight until I woke to see an abundance of presents under the sparkling tree, including my Bride Doll, a testament to Santa’s arrival.

There were several traditions that made December 24th especially memorable. In order to give my mother quiet time to finalize her Christmas preparations, Dad took us children to downtown St. Louis to see the department store windows decorated in an animated and wondrous fashion. This was before suburban shopping centers sprouted into a vast business that supplanted the downtown retail market. The enchanting storefront windows of that pre-mall era captured my fancy and were even more exciting than seeing Santa Claus, for there were lots of Santa’s on street corners and on every toy floor we visited. This was confusing in my younger years until my older brother explained they were helpers who represented the real Santa, like our parents did. Seemed reasonable.

Even more wonderful than our trip downtown, however, was coming home to a festive house and homemade, frosted cutout sugar cookies. Eventually we were old enough to help, but early on Mom carefully crafted yellow stars, blue bells, and green Christmas trees decorated with cinnamon red hots, colored sugar, chopped nuts and raisins. She also painstakingly decorated a large Santa face for each member of the family, our names written individually across the bottom of his white beard. Christmas had indeed arrived and let the celebration begin!

As the years passed, other traditions marked this sacred holiday. The Webster United Methodist Church choir program was a highlight. We processed solemnly into the sanctuary carrying our battery lit candles, the adult choir in maroon robes, the youth choir in their white surplice.

Traditional carols and worship were lifted even higher by the glorious offering of *O Holy Night* by the senior choir, a song that still stirs our emotions. The service ended with a hushed rendition of *Silent Night* as everyone lifted their own candles high, a reverent and beautiful moment. Afterward as we ventured forth into the cold, dark night, our hearts warmed by the joy of our faith, a gently falling snow often added an exhilarating and heavenly benediction.

High school recollections from the 1960s always include the annual Vespers Christmas program. The a cappella choir under the exceptional direction of Esther “Miss Rep” Replogle gave numerous performances each December for both students and the public.

In my senior year it was a thrill to be included in the cast for the nativity scene. The biblical telling unfolded as the choir sang the holiday’s haunting and moving music, the solo rendition of *I Wonder as I Wander* especially affecting. Miss Rep’s creative vision for the tableau included a wide-ranging host of visitors to the manger, from the regal to the humble, my small part forever cherished.

Many sweet memories abound about an era that is far removed from today. The 1950s and 60s were my *growing up* decades, but whatever decades comprise our lives, it’s important





The song implored everyone to “cross over the bridge” for the best deal on a vehicle.


Flash forward fifty years and that same phrase will bring you to where you can still dine inside some great restaurants. (at least at the time while I am writing this article). Having said that, I must say that I think the St. Louis region’s regulations regarding Covid-19 are ridiculously stupid. Each City and County, as well as the State, making up their own rules, or lack thereof, is confusing, as well as extremely dangerous. I would like to see the entire area with one unified set of regulations to face this issue. But at this time you are welcome to come break bread with us in St. Charles. It is “suggested” you wear your mask (so much for rules) however, most business’ do require a mask to come inside.

We had been to MicroCenter, in Brentwood, and crossed over the bridge as we went home. It was time for lunch so we drove into “The Streets Of St. Charles”. Going back fifty years, this was the location of “Noah’s Ark”. We decided to try First Watch. We have had many breakfasts at First Watch locations, but never a lunch.

This location has plenty of space for social distancing and it was spotlessly clean. There wasn’t even a fingerprint on the fixtures of the men’s room! All of the employees wore masks. I was genuinely impressed.

After being seated and given menus, we were greeted by “Hello Kevin and Sue McCarthy” This came from an employee from Brentwood. We shared many fond memories of Brentwood with Ann Yancy talking about the late Willy Wright, Chief Neimeyer, Dan Fitzgerald and all the things that makes Brentwood a special place to live.



Sue found the Lemon Ricotta Pancakes with fresh, whipped ricotta cheese on two multigrain batter .pancakes topped with marinated berries and creamy lemon curd. She said there was no reason to look at anything else.



I went for the “Two For You” lunch special, your choice of a half sandwich with either a salad, or cup of soup. The roast beef & horseradish havarti, house-roasted onions and tomato with lemon dressed arugula on grilled Parmesan-crustured sourdough and horseradish sauce on the side had my name all over it. I chose the chicken avocado chop salad consisting of chopped romaine and arugula, all-natural chicken breast, avocado, tomatoes, corn, black beans, Feta cheese and crispy tortilla chips with a citrus chipotle dressing. WOW, It was perfection! There was a lot of thinly slice chicken breast pieces, amazingly fresh ingredients and a perfectly spiced dressing. I could easily make a meal of this alone. It was one of the best salads I’ve ever eaten.

Our server was very good and the decor, and furniture were very comfortable. The menu has a large number of items that will appeal to any taste and diet. Every item has a calorie count and items range from exceptionally health to good old comfort food as well as some items that combine both sides of the dining spectrum.

First Watch is definitely a great place for lunch as well as breakfast. Perhaps we will see you there.
