Ozzie Smith might help decide whether Bonds, Clemens make it to the Hall of Fame

Ozzie Smith did not spend much time in recent weeks worrying about whether Baseball Writers Association of America members would elect Barry Bonds or Roger Clemens to the Hall of Fame.

Smith might have to start thinking more about the issue in the months ahead.

When the results of this year's Hall of Fame vote was announced in late January, it ended the chances that either Bonds or Clemens would be elected by the writers. This was the 10th and final year for each on the writers' ballot.

The next potential path for both players to be elected to the Hall of Fame could come from a select Hall of Fame committee assigned to evaluate and elect players, managers, executives and umpires whose primary contributions to the game came between 1988 and 2016.

Smith, the former Cardinals shortstop who was elected to the Hall of Fame 20 years ago, has been a member of that committee the last two election cycles. Even though Smith doesn't know officially that he will again be on this year's committee, it is a renewable appointment.

If Smith is once again part of the 16-member committee that includes Hall of Fame players, baseball executives, historians and veteran baseball writers, Smith could have to cast his vote saying yes or no to whether Bonds or Clemens should be elected.

"This will probably be one of the toughest ones (his vote) if I am on that committee simply because of the subject matter," Smith told STLSportsPage.com. "It's going to be real interesting."

Smith has said publicly that he has opposed the election of players to the Hall of Fame who had their careers stained by performance enhancing drugs, even if they were among the best players ever to play in the major leagues.

In a 2010 interview Smith said, "From my perspective, if a guy tested positive or admitted using, he automatically eliminated himself from being part of the Hall of Fame."

Following last week's election results, Smith said his opinion on the issue has not changed.

"I still feel that way," Smith said. "Now knowing that there are others who have made it who were associated with it, I don't know if that changes other people's views. It certainly makes me give it some second thoughts."

"It does become a very personal thing. Some people look at it and put more weight to it (the character issues) than others. There is a whole gamut of things to think about as we go through the process."

One of the primary arguments for including Bonds and Clemens in the Hall of Fame is their career accomplishments, and a belief that both still would have been among the greatest players in history even had they never been connected to the use of steroids.

Should the best players in the game be in the Hall of Fame? The easy answer is yes, but Smith says the question is not that easy to answer.

"I think our goal is that it (the Hall of Fame) should be something much more than that," he said. "The real question is how much value do you put on the fact that there are already people there who you know were associated with it."

"From a traditional standpoint you say no, I don't think those guys actually belong. I think that has actually stood up to this point but you never know until you get in there and sit down and hear the historians talk about it."

"I can't sit here today and tell you that I'm going to say no. I can't tell you I'm going to say yes."

Smith said that in the last two Today's Game Era committee votes in which he has participated, as well as earlier committees evaluating other players, some of the information he heard during the meetings led to him changing his position about how he ultimately voted.

"There have been times when I went into the meetings thinking one way and sitting down and listening to the historians talk, it changes your mind," Smith said. "You never know when you go in there. You go in (thinking) one way and come out completely different."

Before Smith will have to make that decision, there are two things which will have to happen. First, he will have to be asked by the Hall of Fame to once again serve on that committee. There will be at least two changes among the players serving on the committee because of the death of Joe Morgan, and Roberto Alomar being removed because of his own character issues.

Second, Bonds and Clemens actually will have to make it onto the 10-man ballot that the committee members will consider. Getting on the ballot might prove as difficult as actually getting the 12 out of 16 possible votes necessary for election.

A different committee of veteran writers will select that ballot of former players, managers, executives and umpires.

Expected to be on the ballot are former managers Lou Piniella, Bruce Bochy and Jim Leyland. The group of players - apart from Bonds, Clemens, Sammy Sosa and Curt Schilling - who will be considered by that committee includes Fred McGriff, David Cone, Carlos Delgado, Kenny Lofton, Johan Santana and former Cardinals Jim Edmonds and Lance Berkman. Executives and umpires also will be considered.

Once the ballot is finalized, the Today's Game Era committee will meet and vote in December to select members for the induction class of 2023. Committee members can vote for no more than four candidates, and 12 votes are required for election.

"It's going to be interesting to see who winds up on the ballot," Smith said. "It all depends on the views of the writers who will pick the ballot."

"It's real interesting being on the committee. It gives you a totally different perspective. It's thought provoking. Sometimes you go in there with an idea and walk away with a totally different idea."

Sky Wars, which is presented by the nonprofit Missouri Pyrotechnics Association, is the nation's largest fireworks competition and one of the only pyrotechnic competitions in the U.S.

The more than two-hour long fireworks championship will feature invitation-only pyrotechnicians who are among the nation's top fireworks choreographers. Up to 10 highly skilled teams will create award-winning pyromusicals—or "concerts in the sky"—which combine the artistry of music and pyrotechnics.

Sky Wars will feature The Fireball Dudes, who hold a world record for their signature gasoline fireballs. They will attempt to break another world record at this year's event.

There will be a Children's Festival Area from 2 to 7 p.m., and families are welcome. A wide variety of food and beverages will be available for purchase. Musical entertainment is by Diamond Empire Band from 3 to 7 p.m.

Proceeds from the event will benefit Wags & Whiskers animal shelter and its "Raise the Woof" campaign.

Boating Safety Courses Offered

Colonel Eric T. Olson, superintendent of the Missouri State Highway Patrol, announces the Patrol is offering boating safety courses to inform and motivate boaters to prepare for the boating season. These approved courses meet the national boating educational standard.

“Missouri’s many rivers and lakes offer a variety of boating opportunities,” said Col. Olson. “Please do your part: Take a boating safety class. Join us in our mission to promote safety on our waterways.”

Missouri law requires everyone born after January 1, 1984, who operates a vessel on Missouri lakes to possess a certified boating safety education card. This includes personal watercraft operators.

Boaters have the opportunity to sign up for a certified course in a classroom at: <https://www.mshp.dps.missouri.gov/WP02Web/app/safetyEdClasses>

The classroom courses provided by the Missouri State Highway Patrol are free, but registration is required and the boater ID card costs \$15.

Don’t see classes in your troop location? Please contact your nearest troop headquarters and ask to speak with a marine operations supervisor to check the possibility of administering additional classes. Troopers welcome invitations to teach classes for groups and teams throughout the state.

MSHP Reports Zero Traffic Fatalities Over New Year’s Holiday Weekend; No Drownings Or Boating Fatalities

Colonel Eric T. Olson, superintendent of the Missouri State Highway Patrol, provides the following preliminary statistics related to the New Year’s holiday weekend:

No one was killed in a traffic crash during the 78-hour counting period, which began at 6 p.m. Thursday, December 30, 2021, and ended at 11:59 p.m. Sunday, January 2, 2022. There were no boating crashes or drownings over the 2022 New Year’s holiday counting period.

2022 New Year’s Holiday Traffic Statistics

Troopers investigated the following:

Traffic Crashes — 406, Traffic Crash Injuries — 91
Traffic Crash Fatalities — 0, DWI — 94

[Note: Last year during the 78-hour New Year’s counting period, there were 1,247 traffic crashes statewide. In those crashes, six people were killed and another 389 people were injured. During the 2021 New Year’s holiday, troopers worked 173 crashes including three fatalities and 48 injuries. Troopers arrested 94 people for driving while impaired last year.]

The fatality statistics in this news release could change if late deaths occur, or if other departments report fatal traffic crashes after this news release is sent to the media.

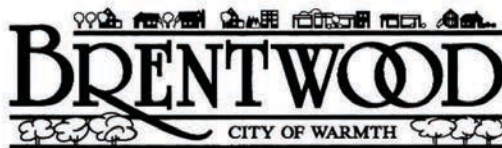

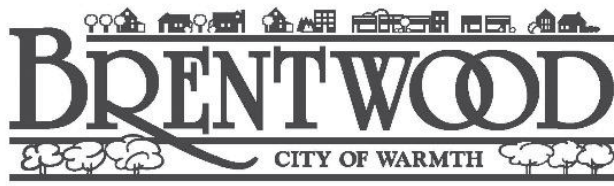

 - Improve accessibility to better connect our neighborhoods. For example, we can improve walkability between East and West by making Brentwood Blvd safer to cross.
 - Raise the bar for Construction Company and Home Builder accountability. Builders working in Brentwood should take great care to protect our streets, sidewalks, trees, and common ground. Most importantly, they should respect surrounding neighbors AND finish their projects in a timely manner.
 - Have forethought and be progressive in promoting sustainability and environment. Green space, school yards, dog parks, gardens, playgrounds, and tree lined streets are good for community. These are assets that encourage us to be outside, meet new people, and stay active.
 - Explore and implement traffic calming and speed reduction measures. We can figure out how to reduce or eliminate speeding from cut-thru traffic on our streets.
 - Create awareness and safe operating conditions for alternative modes of transportation. Yes, I’m the guy driving around on a Golf Cart. Electric bikes and scooters, golf carts, and other small electric vehicles are fun, quiet, functional with zero emissions and now commonplace. Brentwood has a unique opportunity to be forward thinking in this area.
- You’re probably thinking, this guy has a lot of ideas. You would be right about that. Again, I will go back to my first bullet point above, ultimately it is your ideas that count. If you plan to vote on April 5th, I would love your vote and to hear from you on the priorities you have for Brentwood, our “City of Warmth.”

Happy New Year, Brentwood! I really hope everyone is doing their best to stay healthy and safe. We continue to face challenges head-on as we struggle to deal with a new COVID variant, and as we continue to see certain types of crime in our neighborhoods.

Just to provide you with a brief vehicle-related crime update from 2021 compared to 2020:

- Vehicle thefts were down
- Thefts from vehicles were down
- Attempted thefts from vehicles were down
- More than 10 vehicle-related suspicious persons were identified by BPD and crimes were prevented through enforcement action

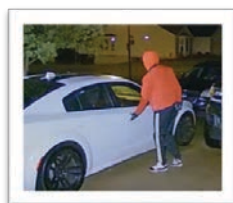
This is great news and tells me that more of our residents and visitors are committed to keeping vehicles locked and valuables out of sight! Also, we received calls from some keen citizens who called in what they saw as suspicious!

Always call 911 when you see something suspicious, you are never bothering us. We wish we could be everywhere at once, but it’s simply not possible. Well, not yet. Who knows what Apple will come up with next?

All of this great news is fine and good, but our work never stops. Areas all around Brentwood have been experiencing an uptick in vehicle-related crimes, and we still need to be vigilant with our vehicles, and in our surroundings. Please, continue to lock your vehicles, encourage your neighbors and friends to do the same, and continue keeping valuables out of sight. Over the next few

weeks additional BPD personnel will be out and about in the early morning hours in an attempt to prevent vehicle warm-up thefts, carjackings, and other vehicle-related crimes.

So many vehicle thefts that occur in the winter months take place as a result of people warming up their cars in the morning, or leaving their cars running while they run a quick errand. Those few minutes or seconds is all a thief needs to help themselves to your vehicle.



What do I do at home AND at work? If I warm up my car, I lock it, and I keep the key fob on my person. I don’t keep my computer bag visible inside the car. I am aware of my surroundings as I leave home to make sure I don’t see

anyone suspicious looking to commit a crime of opportunity in my neighborhood.

At the Police Department we have experienced several officers who have come down with COVID, but thanks to proper protocol, we are staying as healthy as possible. We



encourage you to stay well and to adhere to the guidelines set forth by the CDC. As a favor to your first responders, if you have been exposed

or are experiencing symptoms, please let us know before we make contact with you, or as soon as possible, so that we may take proper precautions.

Alderwoman Sunny Sims Files for Re-election as Brentwood's Ward 2 Alderwoman



Election Set For April 5th, 2022

Sunny has served as Alderwoman of Ward 2 since April of 2016. She is a 2005 graduate of St. Louis University School of Law, and a 2002 graduate of George Washington University. She has been in private practice as a trial attorney at Wasinger Daming, LC, located in Brentwood, for almost 8 years. She focuses her practice on business, banking, real estate, estate planning, and municipal law. She was born and raised in St. Louis and moved to her current residence, 2016 Spanish Drive, in 2010.

As Alderwoman she has served on the City's Public Safety and Public Works Committees, and she has served as Chair of Ways and Means since 2019. She has served as the City's Excise Commissioner since 2017 and has served as a board member of the Brentwood Redevelopment Corporation since 2019. She has been a part of Brentwood Bound since its inception. Brentwood Bound is a comprehensive plan to renew the Manchester Road corridor between Brentwood Boulevard and Hanley Road. There are three components to the plan: Deer Creek Flood Mitigation, Manchester Road Improvements, and Deer Creek Greenway Connector. Most recently, Sunny supported moving forward with a \$5 million destination playground in the Brentwood Bound area.

As Chair of Ways and Means:

- She guided the City through 2020 Covid, a year with decreased revenue;
- She ensured cuts were made to have a balanced budget while still providing services residents are accustomed to receiving;
- She helped direct how ARPA funds were to be used;
- She ensured proper budgeting for 2021 — the year of uncertainty; and
- Every year her committee has presented balanced budgets to the Board of Aldermen.

As Alderwoman:

- She fought against scuttling the lateral sewer program but supported necessary changes to ensure viability of the program for the foreseeable future;
- She fought against outsourcing the trash service and insured that it would stay “in house;”
- She championed installation of speed humps on Rosalie, and helped create and implement the City's traffic calming tool kit to address speeding;
- She championed surface transportation programs for installation of new sidewalks and streetlights to improve pedestrian traffic;
- She supported acquisition of additional Flock cameras for the police department to help with patrolling;
- **She has been a vocal proponent of increasing pay for first responders, dating back to 2018;**
- She lead the effort to add an additional police officer to the force;
- She supported a vaccine mandate for City employees;
- She has been working with businesses in the Hanley Industrial Court to increase presence:
 - She supported the expansion of the Hoffmann Brothers campus;
 - She has been in discussions regarding a possible multi-family development at the Post Holdings site; and
- She supported legislation favoring EV-readiness, which will support the deployment of plug-in electric vehicles and charging infrastructure.

Since 2016, Sunny has been an integral part of the positive changes in Brentwood. She lives and works in the City and believes that Ward 2 deserves a representative that will continue to listen to residents and advocate for their needs. She believes her experience as an attorney representing clients has served her, and will continue to serve her, in this capacity.

Beginning in February, Sunny will hold a number of open houses to fully explain her contributions to the City and her vision going forward. She looks forward to meeting with the Ward 2 voters to discuss this vision and to hear their concerns.

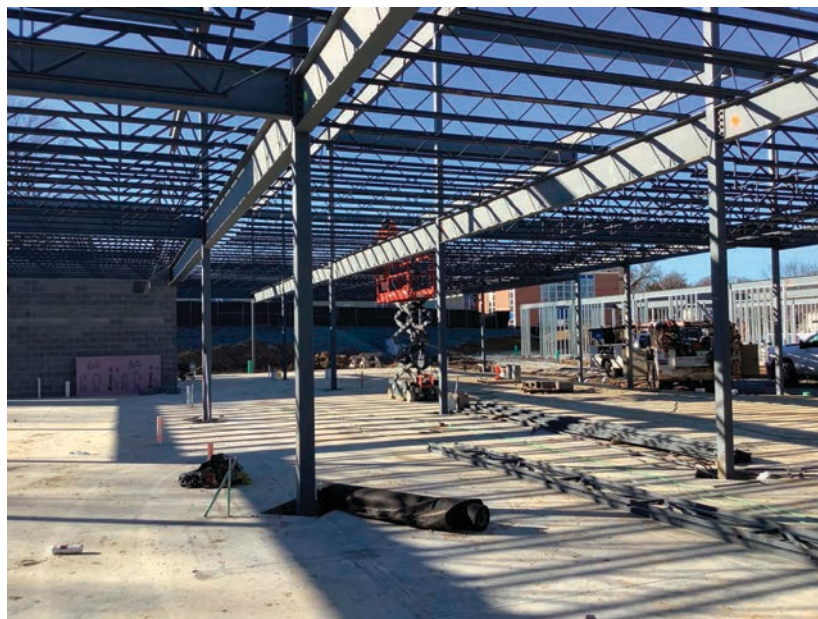

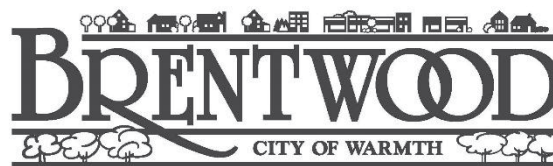

What is a Balance Transfer and how can it save you money?

A balance transfer is a type of credit card transaction in which debt is moved from one account to another. For those paying down high-interest debt, such a move can save serious money on interest charges if done strategically. For example, debt that's moved to a credit card with a 0% introductory APR offer on balance transfers could potentially be paid off interest-free.

Balance transfers come with certain costs and limitations, though. Generally, you'll have to pay a balance transfer fee — usually 3% to 5% of the total transferred. And if your balance transfer card's limit is low, you might not be able to transfer your full balance.

How Balance Transfers Work

While the exact process for balance transfers can vary widely, here are the steps you generally have to take when working with major issuers:

1. Apply for a card with an introductory 0% APR offer on balance transfers or use an offer on a card you already have. Something to keep in mind: Same-issuer transfers generally aren't allowed.

2. Initiate the balance transfer. If you're doing this online or by phone, you'll need to provide information about the debt you're looking to move, such as the issuer name, the amount of debt and the account information.

3. Wait for the transfer to go through. Once the balance transfer is approved, which could take two weeks or longer, the issuer will generally pay off your old account directly. That old balance will show up in your new account.

4. Pay down the balance. When that balance is added to the new card, you'll be responsible for making monthly payments on that account. And if you pay it down during the introductory 0% APR period, for example, you could potentially save a bundle.

Pro tip: Credit card debt isn't the only type of debt you can transfer. Many issuers also allow cardholders to move other types of debt — such as auto loans or personal loans — to a credit card or consolidation loan.

Choosing a Good Balance Transfer Card

The goal of a balance transfer is saving money, so you want to choose a card that helps you minimize your costs. The ideal balance transfer credit card comes with three big zeroes:

- A 0% introductory APR offer for balance transfers.
- A \$0 annual fee.
- A \$0 balance transfer fee (or a way to avoid paying such a fee).

With such a card, you could potentially pay off your debt without spending a penny on interest and fees. Cards without transfer fees are rare nowadays, so take advantage when you find one.

In general, a balance transfer is a valuable choice if you need months to pay off high-interest debt and have good enough credit to qualify for a card with a 0% introductory APR on balance transfers. You could save plenty on interest, giving you an edge when paying off your balances. PUBLIC HEARING

Adoption of The FY 2022 Adopted Budget - Mayor Dimmitt opened the public hearing on the adoption of the FY 2022 Budget beginning on January 1, 2022 and ending on December 31, 2022. No one from the public spoke. Hearing was closed.

AGENDA APPROVAL

Approval or Amendment of Agenda

Mayor Dimmitt asked to remove Item 8A -Resolution No. 1324 from the Consent Agenda. The City Staff heard from the Missouri Attorney General’s Office. A representative from the office said “unfortunately, only political subdivisions with a population greater than 10,000 are included in this settlement proposal from the distributors and manufacturer.” Sorry about that. You should know that all Missourian’s will benefit from the settlement proceeds as the State utilizes the funds consistent with 196.1050, RSMo.”

Motion was made by Alderman Plufka and seconded by Alderman Gould to approve amended agenda. There were no objections.

Motion carried by unanimous voice vote.

The agenda was then approved by acclamation.

CITIZEN COMMENTS

Citizen Comments – Brian Hansen spoke on amended Bill No. 6356.1. He commented that the number of electric vehicles was miniscule and feels the policy is premature. He asked that clarification of the definition for new dwellings be provided and that the Board of Aldermen reconsider the adoption of this bill.

Email comments were provided by Don Keeling, Mevo-tech, National Sales Director, Traditional Accounts regarding Bill No. 6365.1. Comments were read into the minutes and uploaded into Board Docs.

Email comments were also provided by Paul Presson regarding Bill No. 6365.1 and were read into the minutes and uploaded into BoardDocs.

Susan Mullen spoke via the virtual format (Zoom) regarding Bill No. 6365.1 stating this should be the resident’s choice, and not the City’s directive, as this does not represent the majority of citizens but only a select few.

CITY ADMINISTRATOR REPORT

Brentwood Bound Update – Owner Representative Craig Schluter, Principal, Navigate Buildings Solution gave a Brentwood Bound update on Construction costs, Soft Costs and Property Acquisitions. There were no other costs to report.

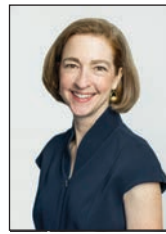

Request for Indemnification - Section 115.010 Update - Former Mayor Christopher Thornton is requesting indemnification of legal expenses and attorney’s fees incurred in connection with an investigation conducted by the Assistant U.S. Attorney for Eastern District of Missouri (AUSA) and the Federal Bureau of Investigation (FBI) from January 2018 through May 2021. the city’s insurance carrier AXA XL and information obtained by acting City Attorney Jones from Hal Goldstein, Office of the United States Attorney. Mr. Jones at the November 18, 2021 meeting had offered to contact Mr. Goldstein as City Attorney O’Keefe had sent him two letters previously without any response. Assistant US Attorney Hal Goldsmith confirmed that the documents compiled during a grand jury investigation are confidential. There is an exception which allows for a motion to be filed to produce documents for collateral litigation, but here there is none pending. An example would be a criminal investigation into fraud charges and a civil case for damages for misrepresentation. Hal did confirm that the investigation was actually conducted at the city’s request. Presumably, we have the Chief’s memos. He sent the attached articles from 40 South News. He also confirmed that Harness, Dickey performed an audit or review for the city and apparently determined that Mayor Thornton did not utilize proprietary IP data. In the end, the US Attorney’s office determined they could not readily prove any criminal charge and investigation was terminated.

Motion was made by Alderwoman Sims and seconded by Alderwoman O’Neill to deny the request for indemnification.

Motion carried by voice vote of 6(yes) to 2(no).

OLD BUSINESS

A. Bill No. 6356.1 - An Ordinance amending Section 500.820 of the Brentwood City Code and the City’s Energy Conservation Code to include the Electric Vehicle Supply Equipment (EVSE) in the New Dwellings - 2nd Reading

Alderman Wegge suggested modifications to the ordinance, and it was shared that the suggested revisions had already been made and incorporated in the amended Bill now being presented. A memo indicating the changes is available in Board Docs.

A motion was then made by Alderman Wegge and seconded by Alderwoman Sims to Amend Bill No. 6356 to 6356.1 with said changes.

Motion carried by voice vote of 7 (yes) to 1 (No). Alderman Lochmoeller was opposed.

City Attorney, Kevin O’Keefe did the second reading of the revised Bill No. 6356.1

Motion was made by Alderman Wegge and seconded by Alderwoman Sims to Perfect the amended Bill No. 6356.1 into Ordinance form.

Discussion took place.

Alderman Lochmoeller stated that the amended Bill was not presented or reviewed at Public Works for discussion and that it should have followed the proper channels and asked that his name be removed from the Bill.

Alderman Plufka felt there was no overriding interest for safety of residents and that per public comment, the Bill is too far out in front of the EV Readiness issue.

Alderwoman O’Neill respectfully disagreed and feels we should be out in front. She also noted that since the City of St. Louis is doing it, we should as well.

Alderman Gould suggested the market should drive public policy, not the other way around and that this should be fully vetted in Public Works and Public Safety Committees.

Alderwoman Tice noted that it was being reviewed and addressed by the full Board, and as such, was supportive of the new amendments.

Alderman Shelton stated that he is a champion for sustainability, however the masses are not there yet, and this may be a few years premature.

Alderwoman Sims noted we received feedback from developers and cost is not an issue for new construction. She wants the City to be in the forefront of change.

Alderman Wegge stated that he supports EV readiness.

Mayor Dimmitt noted that it is not required to go to committee and can be fully vetted at the Board, so procedure was followed.

Roll was called:

Alderman Plufka – No Alderwoman Tice – Yes Alderwoman Sims – Yes Alderman Wegge – Yes Alderman Gould – No Alderman Lochmoeller – No Alderwoman O’Neill -Yes Alderman Shelton – No Mayor Dimmitt – Yes (to break the tie)

Motion carried by vote of 5 (Yes) to 4 (No).

Upon the signature of Mayor Dimmitt, Bill No. 6356.1 will become Ordinance No. 4994.

NEW BUSINESS

Bill No. 6361 An Ordinance Adopting The Annual Budget For The City Of Brentwood For The Calendar Year 2022; And Providing For The Effective Date Of This Ordinance. First Reading

City Attorney, Kevin O’Keefe, read the Bill.

City Administrator Akande presented the FY 2022 Proposed Budget thanking all who worked diligently to bring this document forward. Ms. Akande noted some highlights:

The City’s sales tax is doing really well

The City was conservative in predicting the Use Tax, so projections are positive

The City will scale back capital improvement the next few years until some of the debts are completed in 2024.

We have received and will continue to receive Cares Act and American Rescue Plan Act funds

We present a balanced budget and plan for FY 2022.

The Ways and Means Committee recommends the Fiscal Year 2021 Proposed Budget be presented to the Board of Aldermen for consideration.

Alderman Plufka noted the Brentwood Bound money had been invested well and asked if the income from those investments could be spent on any capital improvement? With advisement, Ms. Akande noted that the 2019 money can be spent this way.

Mayor noted that the budget was balanced without using any reserves and thanked all who had helped make this happen.

Bill No. 6362 An Ordinance of the City of Brentwood, Missouri, authorizing the Mayor and/or City Administrator to execute the attached 2021 Community Development Block Grant (CDBG) Municipal Housing and Community Development Supplemental Cooperation Agreement - First and Second Reading

Kevin O’Keefe did the first reading.

City Administrator Akande presented the information that is available in Board Docs with the supplemental agreement, noting we have been doing his for many years. The City of Brentwood, through St. Louis County, participates in the Community Development Block Grant (CDBG) program. As part of this program, the City has elected to utilize the funds as part of the home improvement program. This program offers forgivable loans of up to \$5,000 annual to income eligible participants. This bill is for an ordinance authorizing the mayor and/or city administrator to execute the 2021 Community Development Block Grant Municipal Housing and Community Development Supplemental Cooperation Agreement between the City of Brentwood and St. Louis County. This program allows for income eligible homeowners to receive forgivable loans up to a maximum of \$5,000. Total amount available is \$20,000. Funds are generally used for roofs, heating and cooling, plumbing and electric work.

Motion was made by Alderman Plufka and seconded by Alderwoman O’Neill for the second reading of the Bill. Motion carried by unanimous voice vote.

City Attorney O’Keefe did the second reading.

Motion was made by Alderman Plufka and seconded by Alderman Gould to perfect Bill No. 6362 into Ordinance form. There was no discussion.

Roll was called:

8 (Yes) to 0 (No).

Upon the signature of Mayor Dimmitt, Bill No. 6362 will become Ordinance No. 4995.

Explore St. Louis Shares Activities for Black History Month

For Black History Month, Explore St. Louis has provided a list of activities below to honor the lives and accomplishments of St. Louis' most notable African American figures.

The St. Louis Walk of Fame is located along The Delmar Loop and honors notable people from St. Louis who made contributions to the culture of the United States. Stars include Maya Angelou, Tina Turner, and Chuck Berry. All were either born in the Greater St. Louis area or spent their formative or creative years here.

Nine PBS is sharing stories from the St. Louis community about trailblazing Black citizens who are from the region. Airing in February, these stories include *In Their Own Words: Chuck Berry* (February 1) and *My Journey with Annie Malone: James Agbara Bryson* (February 14).

Open year round, the **Scott Joplin House State Historic Site** plays some of his famous melodies in the modest flat on Delmar Boulevard. It is furnished and lit by gaslight as if it were 1902 when Joplin spent time there composing some of his famous songs.

The inspirational **George Washington Carver Garden** at the Missouri Botanical Garden honors the life and accomplishments of the famous scientist who greatly influenced 19th and 20th-century agriculture and education. The focal point of the garden is a life-size bronze statue of Carver sculpted by Tina Allen. The garden is one and a half acres and features inspirational inscriptions from Carver's writings and speeches, a reflecting pool and is landscaped with viburnums, hydrangeas, and holly trees to give it an intimate feel.

The Missouri History Museum has scheduled Black history programming throughout the month. Their newest addition of "See STL Walking Tours" includes a walking tour of "The Ville" which is home to several Grammy Award winners, rock and roll hall of famers, Kennedy Center honorees, one of the first Black woman millionaires, three Grand Slam titleholders, and the founder of the first Black collegiate sorority.

Ebony and Jet were the magazines to read for Black perspectives on lifestyle, culture, and politics during the heyday of the magazine industry. **The Contemporary Art Museum St. Louis** hosts a community conversation about these two iconic publications for its free program. They will also feature images from vintage editions of Ebony and Jet, enhanced with shimmering, watercolor hairdos on CAM's street façade.

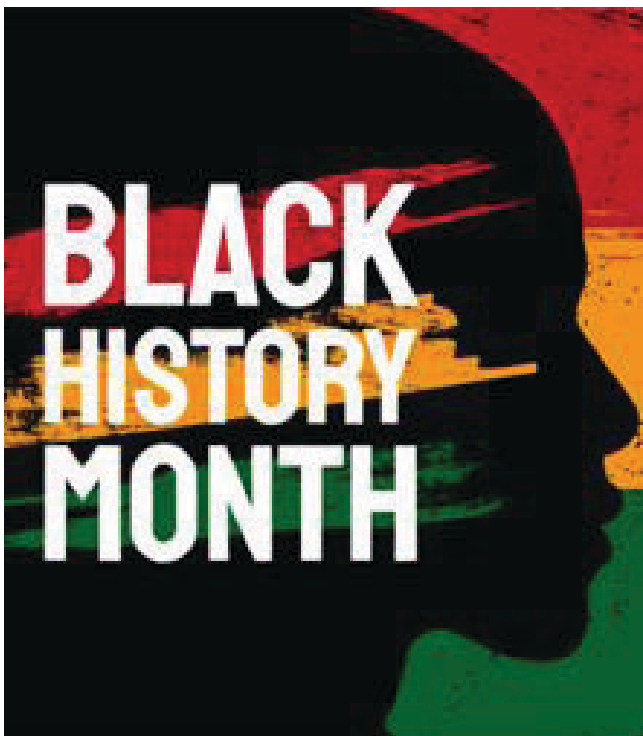

This intimate performance allows viewers to experience the powerful drama from Olivia's female-led perspective.

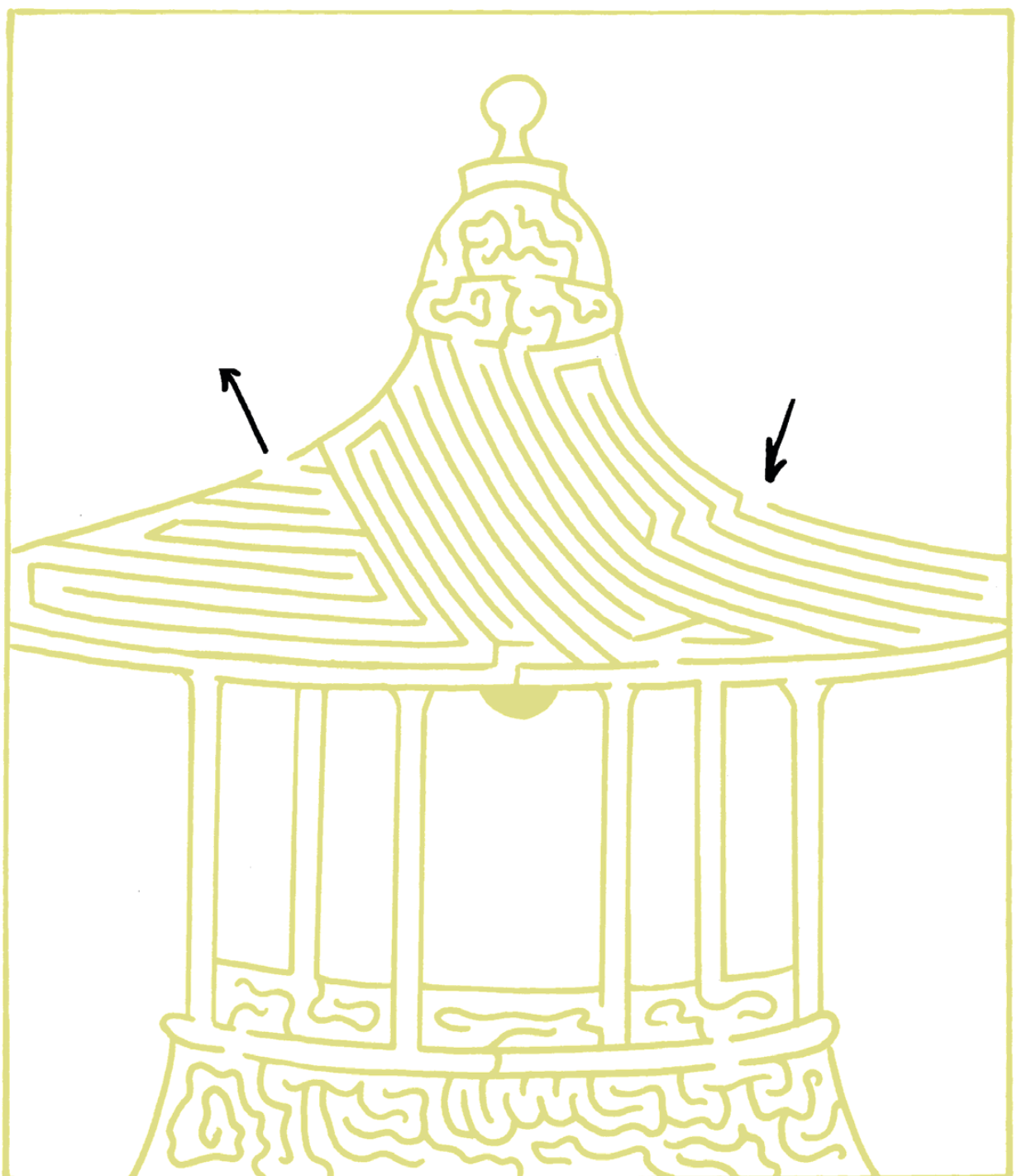

appreciating the changes she has

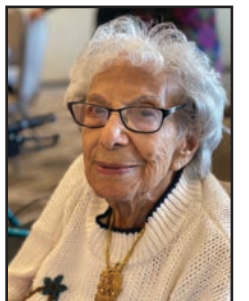
witnessed in her long and epic life. Even a recent bout with Covid didn't get her down.

By 1992 the Missouri Cameo Club was officially established with 36 members. Each time there was a pageant, the contestants were inducted into the Cameo Club. Through showcases and fundraisers, Cameo Club members raised funds and donated a percentage back to the community.

In 2014, the national Ms. Senior America organization disapproved of giving collected proceeds from Metro St. Louis showcases to Missouri charities using the "Cameo Club" name. Rather than risk legal action from the Ms. Senior America organization, the Missouri members changed the name to the Missouri Pageant Alumnae Club (MPAC).

By 2006, the Cameo Club was becoming well organized and envied by other state pageant organizers. The first Cameo Talk Newsletter

Under new guidelines from Ms. Senior America LLC, we have recently been advised that the Cameo Club name can once again be used, and that all proceeds raised by Showcases can be kept in Missouri. So, it is with great excitement that we rename our organization the Missouri Senior Cameo Club.

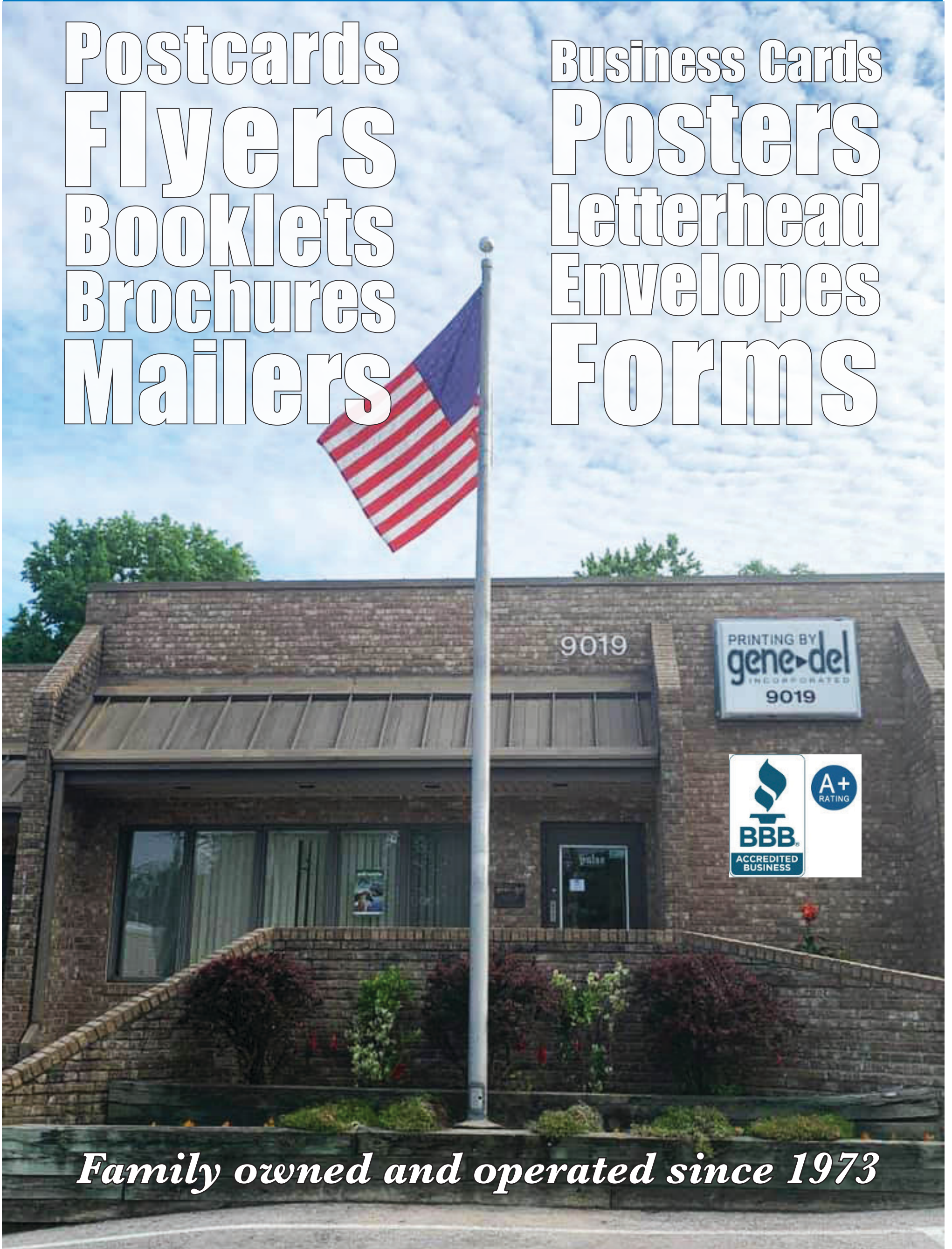

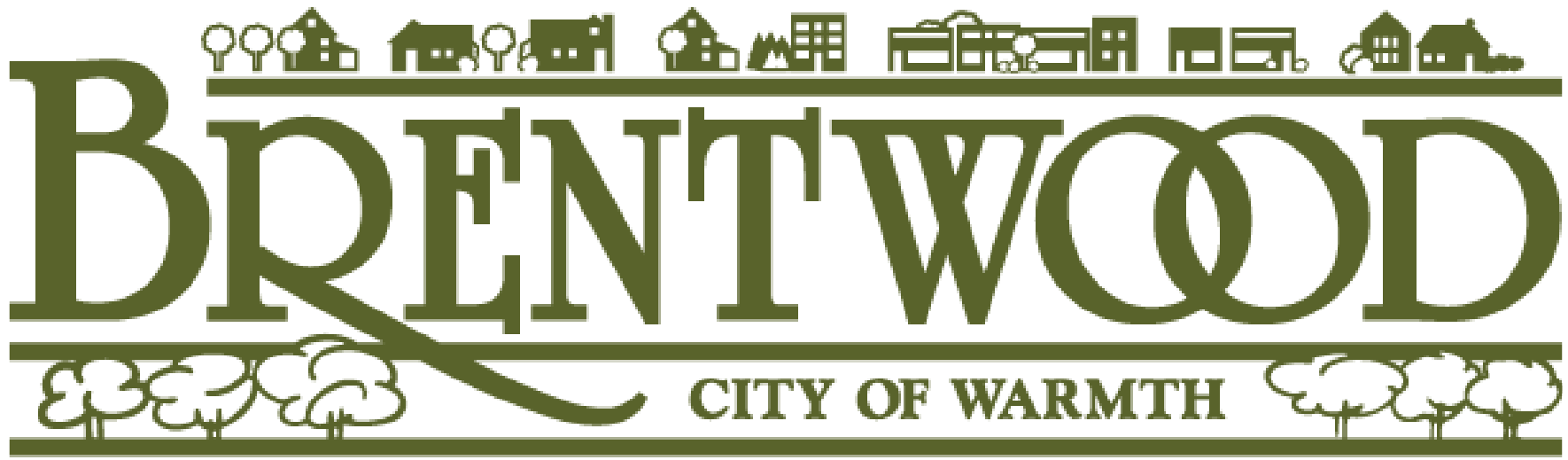

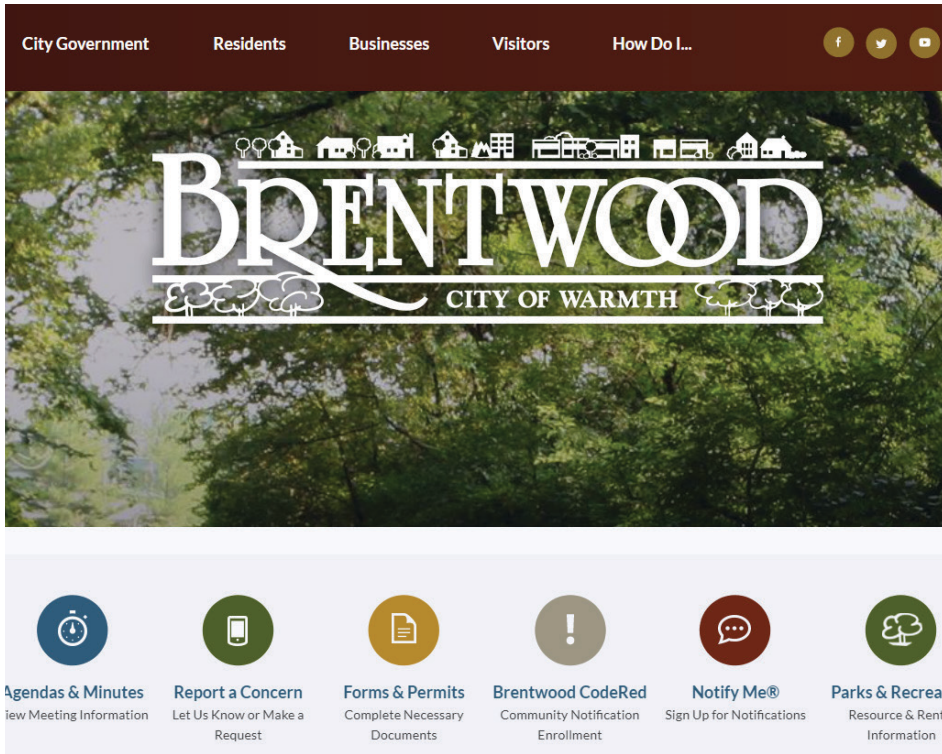

Brentwood Bound Construction Progress

The transformative projects of the Brentwood Bound Plan are taking shape in our community. Construction on the Deer Creek Flood Mitigation project and the Deer Creek Greenway Connector is on track to continue through December 2022.

In Summer 2021, members of the Brentwood Bound Community Engagement Task Force met to discuss the area formerly known as Farm West Park. The Task Force proposed a new name of Brentwood Park, to link the park's name to its location and to enhance residents' pride for their city. The new Brentwood Park will be the jewel of the Brentwood Parks system and a premier park in the metro area. The Board of Aldermen approved this name as well as the renaming of the current Brentwood Park (on Russell Avenue) to Brentwood Sports Complex. Construction of an event/laundromat station building in the new Brentwood Park is well underway. Find updates at BrentwoodBound.org.

RESTAURANT REVIEWS

As Seen On TV!



I went to the internet to find something “romantic” for valentines Day. My first choice was Bailey’s chocolate Bar. Unfortunately they are closed for repairs due to a broken water pipe. I was so looking forward to a few chocolate martinis.

Yelp suggested Sauce on the Side as a romantic restaurant with an almost 5-star rating across the board, so We decided to give it a try. Let’s face it the “eat more calzones” tag line to their commercials got me.

We found a local Sauce on the Side near us in the Streets of St Charles area, think the old Noah’s Ark as you cross the Blanchette Bridge. This is the site of a short lived pizza joint that lacked service and atmosphere. It hasn’t changed much. Sauce on the side still has the concrete floor, metal chairs and order at the counter service of the previous tenant. Romantic it s NOT!

Sauce on the side offers a number of Bite Side appetizers. These are baked cheese balls with pepperoni and basil, Jala-peno Cheddar,



Buffalo Chicken, and Spinach Artichoke. They are all price at \$7.00 and served with various dipping sauces. We choose the Spinach Artichoke that came with a queso pesto sauce. Five pieces was more than enough for both of us. Unfortunately, the were barley warm when they came to the table. They were not hot enough to soften the Parmesan cheese sprinkled on top. I asked the young lady that brought them to table if the were supposed to be served hot, rather than luke warm and she said they have a problem with the bottoms being burnt if cooked too long. I think they are pre-made and simply warmed up in an oven. They were a tasty way to start our lunch.

There are seventeen different calzones with every type of filling imaginable, so there is something for everyone’s taste. Priced at \$10.75



they turned out to be a very good deal. Sue had the Cock-A-Doodle Noodle. This was featured on the Travel Channel’s Food Paradise! It is Mac ‘n Cheese / Roasted Chicken / Pan-



cetta / Provel Cheese / Mozzarella / Green Onion / Garlic Oil and Buffalo Butter. The Buffalo Butter tasted as if it had been thickened with flour. I ordered the Magic Carpet Ride. A calzone filled with Button Mushrooms / Crimini, Portabella and Shiitake Mushroom Mix / Minced Garlic / Parmesan / Mozzarella / Ricotta /Garlic Honey Oil and Garlic Butter which again tasted as if it were thickened with flour. The portion sizes are more than enough for two people to share. We could only eat half of each one, so we took home another meal for free. The crust was perfectly baked, but the interior stuffing could have been much warmer. They were excellent, but again, I got the feeling they were pre-made and warmed over.

My only real complaint was the dishes they were served on. The lip on two sides of each dish turns down, so when I placed my knife on the side of the plate, it always feel off on the table, or floor. Also, the bottom of the plate is rounded, rather than flat making it very difficult to cut anything with your knife and fork as the plate moves all over the table. I guess I should have three hands, tow for the knife and fork, and one to hold the plate in place.

We saw some of their salads at nearby tables and they looked very nice and also larger than average servings

Desserts are also calzones such as Caramel Apple Pie, Nutella and Banana, and S’mores. We ordered the Caramel Apple Pie and it was huge. We only ate half of it and again, took the other half home. Unfortunately, they did not offer ice cream on the side, but it was still delicious.

Soft drinks, tea, and coffee are the only beverages available. There is no beer nor wine, both of which would be a great accompaniment to the menu of calzones.

My faith in Yelp stands at mediocre. Sauce on the Side is not a “romantic” restaurant, nor does it rate a 4.5 out of 5 rating. It is a 3 out of five fast food venue with reasonable pricing. We will go back. They have seven locations throughout the St. Louis area, so they are is close to everyone. And as they say on TV “Eat More Calzones”.

LUZCO Technologies, LLC Moves Its Headquarters to Maplewood, Missouri

LUZCO Technologies, LLC announced the opening of its new headquarters on January 3, 2022. The relocation to the Maplewood building is a response to the company's rapid growth and need for additional space. Upon designing the new 17,000-square-foot office space, LUZCO incorporated numerous environmentally sustainable and energy-efficient features.

"We want our new office to not only be a place where we can host our business partners and showcase our capabilities, but also where we can promote environmental sustainability, energy efficiency and carbon footprint consciousness," says Lusnail Haberberger, the founder and president of LUZCO Technologies, LLC. "Most of all, we want our headquarters to be where we can bring our children and, with pride, show them the impact we are making in our society."

The new LUZCO building uses T5 lamps, LED sources, low-power factor electronic ballasts, and low-mercury sources to achieve a 25% reduction in lighting energy. The primary lighting fixtures integrate holographic lenses and high-efficiency reflectors. The 10% up-light gives the perception of a lighted ceiling, while directing 90% of the light to the working plane. In addition, motion sensors were installed throughout the office to reduce lighting energy when spaces are unoccupied.

LUZCO's HVAC system has been zoned by orientation and differentiating interior – versus perimeter zones – to provide comfort and reduce energy consumption. Furthermore, the building's white roof reflects solar energy, thus reducing the energy required to cool ventilation air. This roof will reduce office cooling loads in the summer by 30%.

Additionally, the Maplewood location utilizes low-flow faucets, urinals and water closets to achieve a 42% reduction in water usage, in comparison to an office space of the same size that is not equipped with water-saving devices. Low-flow devices with automatic operating features provide enhanced savings with reduced maintenance.

Every LUZCO equipment and appliance is Energy Star rated. This includes the data network, laptops, monitors, docking stations, displays, copy machine, plotter, refrigerators, microwaves, dishwasher, water fountain and ice maker.

LUZCO maintained over 90% of the existing office space. This includes twelve offices, the cubicle area, the copy/plotter room, the large conference room, the IT room, the mothers' room, and the community room. Only the kitchen area was reconfigured and completely remodeled. The entire raised floor system was reutilized, as was 100% of the power wiring underneath.

Recycled materials were used in the construction of the new office. The carpet installed was manufactured in a carbon-neutral facility, using 40% recycled materials. The ceiling tiles are made of 39% recycled materials, and the door frames are made from 64% recycled materials. Other recycled materials applied include countertops, cabinets and laminate flooring. Moreover, LUZCO's Maplewood space is furnished with 98% used, reclaimed and repurposed furniture.

To regard employee safety, cleaning chemicals used in the office are stored in the janitor's closet, which is directly exhausted to the outdoors. A walk-off mat is located at the main entrance to reduce the amount of contaminants tracked into the office interior.

Lastly, the new LUZCO location is situated within close proximity to the Maplewood MetroLink station and the Deer Creek Greenway. For this reason, both interior and exterior bicycle storage racks were installed. Within a ½ mile of the office, there are numerous businesses, parks and public facilities that support sustainable lifestyles.

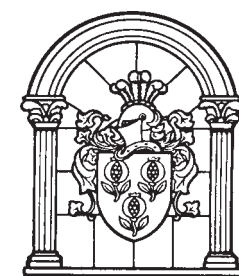

WESTERN GEORGIA ROAD TRIP

I usually have several international trips to report on, but with the COVID and eastern Europe conflicts I will be writing about destinations domestically we have traveled to.

I have always wanted to follow the Cherokee Trail and have been on parts of it in Georgia, Alabama, Tennessee and Oklahoma. This trip started out in northwestern Georgia.

NEW ECHOTA

This is one of the most significant Cherokee Indian sites and also where the tragedy of the "Trail of Tears" began. It was the capital of the Cherokee nation in 1825. It was the site of the first Indian language newspaper office. The signing of a treaty which relinquished Cherokee claims to land east of the Mississippi River and assembly of Indians for removal west on the infamous "Trail of Tears."

Visitors can visit 12 original and reconstructed buildings, including the Council House, Court House, Print Shop, Missionary Samuel Worcester's home and an 1805 store. There are also outbuildings such as smoke houses, corn cribs and barns. There is a visitor's center where you can buy souvenirs, books, music and view interpretive exhibits and a 17-minute film.

Chief James Vann in the 1790s was a Cherokee Indian leader and a wealthy businessman. He had the most prosperous plantation which covered 1,000 acres. In 1804 he constructed a 2 1/2 story brick home that was the most elegant in the Cherokee Nation.

Chief Vann was murdered in 1809 and his son Joseph inherited the mansion and plantation. Joseph was a leader too and he became more wealthy than his father. In the 1830s almost the entire Cherokee Nation was forced to move west by the state and federal troops on the infamous "Trail of Tears." The family rebuilt in Oklahoma Territory and today the Vann home is Georgia's best-preserved historic Cherokee Indian home. A guided-tour will show you the handcarvings, a "floating staircase", a 12-foot mantle and fine antiques.

A nearby visit to the Etowah Indian Mounds in Cartersville, GA proved to be another interesting stop at 813 Indian Mounds Rd.

Mound A – is a temple mound about 65 ft. high. Construction began in the early years of Etowah's occupation about A.D. 1000 and rose to prominence and reaching its peak in A.D. 1325. A staircase was added measuring 22 feet wide. Mound A has not been completely excavated. A broad ramp projects from the eastern side and a smaller terrace is attached to the southern side.

There are many places to visit along the route (Highway 27 or Martha Berry Highway) that runs along the western border of Georgia, next to Alabama, all the way from TN to FL. It is a nice uncrowded route for people traveling through Georgia for those wanting to miss the Atlanta traffic and take the backroads.
