To the reader;

You most likely have seen the request before; to come participate.

You most likely have seen the Red Cross vans and staff in a room working with others, drawing blood.

You are asked to come, get poked and siphoned for a pint.

Let me share what is behind the scene. Why the need is there and the appeals are so many.

What the motivating drive is to host a drive. How important you are to the whole process.

Each day approximately 36,000 units of red blood cells are needed every day in the U.S. Nearly 7,000 units of platelets and 10,000 units of plasma are needed daily in the U.S. Nearly 21 million blood components are transfused each year in the U.S. All of this has to come from somewhere. If you consider the screening process that the Red Cross goes through with the 50 question and the testing of the blood donated, the donors that are turned away and those who just decide not to participate; you can understand where all that demand has to come from to be filled. Thus the need for blood drives.

Now consider who gets these donated blood pints. Those throughout the US in need of medical attention where their bodies have lost blood or their own system is not capable of fighting infections and need blood or platelets to treat their disease..

My son was one of those. He fought Leukemia and his body could not create the blood cells to fight this cancer. So over the 22 months he had to rely on others to donate and provide lifesaving material to help him fight. If they had not donated, he would have lost his fight earlier and we would have lost the time with him even sooner. What parent would not do anything to help their child? To have another moment with them? By the grace and kindness of others we were given that moment.

So now, I have the opportunity to push blood drives so someone else may have /share what we were given. Our story did not end in success in beating cancer but we were given more time and that is priceless.

I am asking you to see how valuable you are and how much you are needed. We bring the drive close to your home to help those in need.

Most likely you may never meet the person receiving your gift, but know your donation will change, save, and give life to those that might be hanging on to hope and prayers and YOU are their answer.

I have given since I was 18 and was on the "Be the Match" list for 43 years because I believe this is how we help one another most.

Without you, the donor pool gets smaller but the need only grows. With you, comes hope!

The needle sticks are a very small discomfort. The pint drawn is replenished by our own body and you are able to donate another pint every 56 days; platelets every 7 days. The hour spent donating will make you feel good about yourself and then you can quietly go on with your day.

Our drive goal is 75 pints but we working to grow to reach 100 pints someday. That will only happen if we can reach more in Brentwood and get them to come out. You donating is a start and inviting a spouse, friend or neighbor to join you makes it more enjoyable.

Also during this drive we will have "POWER RED" donation stations. Power red is similar to a whole blood donation, except a special machine is used to allow you to safely donate two units of red blood cells during one donation while returning your plasma and platelets to you.

With just a little extra time at your appointment, you can donate more red cells and increase your impact on patients in need.

Who it helps: Red cells from a Power Red donation are typically given to trauma patients, newborns and emergency transfusions during birth, people with sickle cell anemia, and anyone suffering blood loss.

Time it takes: About 1.5 hours

Ideal blood types: O positive, O negative, A negative, and B negative

Donation frequency: Every 112 days, up to 3 times/year

Consider Maximize your impact and schedule a Power Red donation today!

The drive is part of the American Red Cross

Donors must be at least 16 years of age

Mask will be required

Temperatures will be taken upon arrival

Social distancing will be followed within both donation rooms

Disinfectant will be used between donors.



### Early Childhood Registration

In January, registration will open for the Brentwood Early Childhood program for children ages 2-5. Enrollment for current families will be on January 21st and will then open to all Brentwood families on January 22nd. On January 8, registration documents and information will be shared on the Early Childhood Center website: [ecc.brentwoodmoschools.org](http://ecc.brentwoodmoschools.org).

The Brentwood School District's Early Childhood Center offers a developmental/constructivist program designed to meet the educational needs of the young child, ages 2 years to kindergarten. This program offers the following unique opportunities:

- Project Construct, an Early Childhood Curriculum approved by the Missouri Department of Education. Our curriculum is enhanced through the constructivist philosophy.
- Goals are set according to the Missouri Early Learning Standards. These directly flow into the standards which are used by all Missouri Public Schools to guide education from kindergarten through 12th grade.
- Experienced, certified early childhood teachers guide learning through current research and best practice.
- On-site nurse
- Through our partnership with Special School District we offer a variety of early intervention services/resources.

#### C BUILDING (High School/Science Wing)

C Building has been turned over to the district and remaining punch list items were completed over holiday break.

### New Websites Coming This Spring



# COVID and its Impact, From a Brentwood High School Student's Perspective

Covid-19 has generated problems for everyone. Although people's circumstances vary widely, it all comes down to the same two troubles: food and isolation.


This is a good friend of mine, Zach, eating lunch alone. Before coronavirus, I would sit with him at lunch along with another twelve or so kids; there were so many of us, we would have to push multiple tables together just so we could fit. Now that we are living in this Covid world, our school has two lunch periods and divides the kids based on their classes. The split lunches have made it so my good friend has to sit alone at lunch every day with just his thoughts. When we did online school, that gave us the chance to meet in small pods and do class together, or go grab lunch with a couple of friends. Although we are back in person, I notice the isolation just as much.



I'm sure everyone can guess, the restaurant industry is really hurting during this pandemic. It wasn't until I spoke to veteran restaurant owner Qui Tran, who runs Mai Lee and Nudo House in St. Louis, did I truly understand how much they were suffering. As soon as I sat down to talk to him, the first thing he told me was how his business is down 60% from last year. "The cost of doing business has gone up, but our capacity has gone down," Tran said. Most restaurants are wondering if they will even make it through the winter. Tran's business has been completely turned upside down. Before the virus, his restaurants tended to be 80% dine-in and 20% carryout, but it has now turned into 20% dine-in and 80% carry out. It was sad to see so few people at a restaurant in a prominent location, such as The Loop.



Most restaurants are already clean, but they now have to spend even more money on sanitizers, along with providing masks to the employees. Tran is also struggling to provide fair hours amongst his crew. His team is mostly adults with families they need to provide for, so they must take the CDC guidelines seriously and truly isolate outside of work. Luckily for them, Tran has not had a single case at either of his restaurants.



For the first time ever, my high school had a live stream of a sporting event, and not because there was some extra room in the budget, I was the only spectator allowed because

I brought a camera. The wrestlers only have their team to cheer for them. As a former wrestler, I know having your family and friends there to cheer you on while you are on the mat alone, makes a huge difference. Now when they win, the referee is not allowed to raise their hand, and that was my favorite part of winning a match. The pride you experience from getting your hand raised and having all the spectators know that you fought hard for the pin has been stripped from the wrestlers this year.

High School wrestlers aren't the only wrestlers in St. Louis who have been affected by the pandemic. UFC champion Tyron Woodley, had to make the best of the unfortunate situation. He's done this by picking up cooking, as I'm sure many others have done also. Woodley, as well as his family, were always busy before the pandemic; whether that was because of sports, school, or work, they weren't home very much.



Now that they need to isolate to the best of their ability for Tyron's career, they can finally enjoy home-cooked meals regularly and the circumstance has given Tyron a chance to really learn how to cook.



Woodley told me, "I have to be very serious about this stuff. Other people, if they get sick, they can just work from home, but if I get sick, I can't fight and provide for my family." The fact

that we are currently living in a world where going to the grocery store can have serious consequences on someone's career is absolutely insane. That is why you see Woodley shining a Ultraviolet-C light on all of his groceries. UV light can be used as a disinfectant; he also sprays everything Lysol as an extra precaution.

Grocery stores are like the minefields of the coronavirus pandemic, trust me I work at one. People dig through the products until they find the perfect bag of carrots, and who knows if someone is sick. Some stores, like Trader Joe's Brentwood, have people wait in a line so they can limit the amount of people in the store, but they are the only grocery store I've seen do that. Grocery stores are doing absolutely great right now, but at what cost? Do you think all the customers, as well as the stores, take the necessary precautions? Would doing the same as Tyron Woodley help lower our rates? Maybe since grocery stores are doing so well right now, they should help lower the curve by selling Lysol and UV lights at a discount.



At the start of the pandemic, emergency shelters were forced to drastically reduce their capacity, so they could safely help people without the curve growing. Emergency meal programs that hundreds relied on shutdown completely for lack of a safe way to operate. It has always been hard for unhoused St. Louisans to get adequate food and shelter, but the pandemic brought basic services to a halt when people needed them most. A small group of friends of the unhoused now known as Tent Mission STL came together and found ways to safely distribute tents to hundreds sleeping outside, so they had some shelter from weather and a space to isolate, while the rest of us stayed in our homes for safety. Tent Mission also brought food and water daily and continues to do so several days a week, now that some services have reopened. They get all of their donations from friends and neighbors through Venmo. They get donated hot meals from black and brown owned restaurants local to St. Louis who, despite the strain on their businesses, have given and given. Every Sunday at 10:30 in the morning in front of



City Hall, Tent Mission volunteers, and the unhoused gather for their weekly "Family Breakfast." Tent Mission hands out breakfast food and coffee. They also give out winter coats, socks, hats, and gloves, all packed into the back of two SUVs. Tent Mission STL has been doing this every Sunday since the city shut down the large tent community that sprung up in the early weeks of the pandemic in the same park across from City Hall, dispersing those living there to places they were less noticed; places more isolated from those who do not want to see the unhoused.

Believe it or not, the unhoused members of our community that I talked with said they haven't been as hurt from the pandemic as you would think. Life for the unhoused comes with many troubles that are life or death. COVID-19 is just another health risk on the list of health risks faced daily. I spoke to a woman who will soon be housed; she was there volunteering, as she regularly



does, cleaning up trash during Tent Mission events. She told me that in the past six months, people in need have become more dependent on the crutches of non-profit organizations because more people have been donating and volunteering. Opportunities to help themselves have shrunk as jobs disappear. I was amazed when I saw how much food there was. They had boxes of warm doughnuts, breakfast sandwiches from McDonald's and gallons of coffee. There was so much food. People are slow to take any more than they need because others in need may come behind them. By the end of it, Tent Mission had leftover coffee and doughnuts that an unhoused man took back to his emergency shelter to share with others. The unhoused woman who made time to talk to me while she remained focused on cleaning up the park shared her concern that the handouts have allowed people with very little income to cope with the stress by spending what they have on things that can result in violence. The woman told me that sometimes someone in an unhoused community won't have enough money to pay for their drugs and the dealers will start shooting, without caring about the other people around that had nothing to do with it. Sometimes those other people around include children much younger than me.

## Artist Statement;

Being an essential worker at Trader Joe's and a high school student, I have seen firsthand how the pandemic has affected completing everyday tasks. That got me thinking about how nutrition and social interaction are a part of everyone's life. This thought made me want to discover how people are coping with the challenge to reach these basic necessities from all ends of the spectrum. My goal with most of these photos was to make them seem as organic as possible, so in order to get the picture of my friend at lunch I had to sneak into the lunchroom and hide and capture the picture without him knowing. For the pictures with Tyron and Qui, I first talked to them about how the new world has affected them. I then had them both go through their routine, so I could capture photos of the moment. To achieve that with the less fortunate, I first observed the scene, spoke to different people there, and took the photos based on the information I gathered. I also made sure to keep the faces of the unhoused hidden to protect their privacy. As you can see, acquiring basic necessities has changed for everyone, whether it's been for better or worse, that's up to you.

To ensure the health and safety of Rep patrons, artists and staff, The Repertory Theatre of St. Louis will postpone the March production of Little Shop of Horrors due to recent coronavirus surges in the region.

"We are committed to keeping our Rep patrons, artists and staff safe so we can continue to bring the magic of theatre to St. Louis for many years to come," said Hana S. Sharif, Augustin Family Artistic Director at The Repertory Theatre of St. Louis. "We are disappointed that health conditions require us to postpone our reunion, but we are fueled by the enormous generosity, patience and support of our patrons and filled with optimism, energy and excitement about the future."

## Keeping Our Artwork Safe, Too Laumeier Sculpture Park Announces Conservation Projects on Three Major Works

Laumeier Sculpture Park proudly announces conservation projects on three of its outdoor artworks: *The Way* by Alexander Liberman, *Pool Complex: Orchard Valley* by Mary Miss and *Intricate Wall* by Sol LeWitt. Care and conservation are ongoing needs for any art collection, but arguably the most pressing for those that are located in outdoor settings like Laumeier, where works are exposed daily to extremes of temperature and precipitation.

At 50 feet high and 100 feet long, Alexander Liberman's *The Way*, 1972-80 was the first massive sculpture purchased for Laumeier's collection. Over the years, it has become Laumeier's signature work and a favorite of park visitors. *The Way* is made of 18 salvaged steel oil tanks and will undergo a major restoration over the next year in a multi-phased project.

Phase one of this conservation project started in October 2020 and includes a structural, material and concrete base assessment. A Faro Laser Scanner was used to create a 3D scan of the sculpture that will be used to evaluate the structure and metal materials of the oil tanks. Phase two of *The Way* conservation will include sandblasting and metal repair. Phase three involves painting and ongoing care.

The *Way* conservation project is funded in part by the National Endowment for the Arts, Art Works grant. Laumeier will launch a funding campaign in 2021 to complete the work.

Dana Turkovic, Curator at Laumeier Sculpture Park, says, "Having recently celebrated its 40-year anniversary as the most iconic sculpture at Laumeier, we look forward to working with our external partners to regain the condition in which *The Way* was seen by the public on the day of its dedication, June 7, 1980."

In October, Laumeier also began conversation work on *Pool Complex: Orchard Valley*, 1983-85 by artist Mary Miss. Once the site of the Hedenkamp family's Orchard Valley Estate, Miss converted the abandoned 1929 pool into a newly built and landscaped environment. Surrounding the pool basin are treated pine pavilions, platforms and staircases meant to highlight the existing ruins within Laumeier's acreage. This ongoing project will help ensure that visitors will be able to enjoy the unique, expansive and multi-level space, deep within the Nature Trail, for years to come.

The conservation of *Pool Complex: Orchard Valley* by Mary Miss is funded by the Sarah A. Kaufmann Charitable Fund of YouthBridge Community Foundation.

"As one of the first and largest dedicated sculpture parks in the country, Laumeier has set many of the standards for combining curated public art with the interpretation and stewardship of a traditional indoor museum," says Turkovic. "Maintaining the integrity of the artist's intentions and responding to the materials and our environment are very important when completing conservation work."

Sol LeWitt's site-specific *Intricate Wall*, 2001-04 uses his iconic repetitive modular pattern and was originally created as part of a solo exhibition at Laumeier in 2004. Temporarily decommissioned in 2018, the piece required a complete rebuild after water damage compromised the structural integrity of the sculpture. Recognizing the importance of LeWitt as a pioneer of minimal and conceptual art, *Intricate Wall* was rebuilt with the help of the St. Louis County Parks carpenters. Each layer of concrete block was installed per the artist's instructions and in reference to the first installation. Completed in October 2020, the newly rebuilt work can be viewed on the southeastern edge of the Ferring Family Foundation Museum Lawn.

Laumeier was awarded a National Endowment for the Arts Artworks grant in 2020 to reconstruct *Intricate Wall* on its original site.

"We are excited to reintroduce this artwork by a historically significant artist to our visitors," says Turkovic. "Bringing this work back on view is also a great illustration of our partnership with St. Louis County and our commitment to the outdoor artworks at the Park."

### New Ordinance and City Code Update for Stormwater Control in Infill Development

In August 2020, the Board of Aldermen adopted an ordinance establishing requirements for stormwater drainage control for infill development.

Any individual who conducts activity that disturbs one acre or more must:

- obtain a site disturbance permit from both the State of Missouri and the City of Brentwood
- submit a Storm Water Pollution Prevention Plan to the State and the City
- obtain a permit from Metropolitan St. Louis Sewer District (MSD), following MSD's Rules and Regulations and Engineering Design for Sanitary Sewer and Stormwater Drainage Facilities

A new section in the City's Municipal Code (Chapter 500, Article XVII) addresses the requirements for stormwater management and for infill development.

The **Best Management Practices for Stormwater Control** manual serves as a supplement to the new City ordinance for stormwater management. This document can be found on the City's website, [brentwoodmo.org](http://brentwoodmo.org). The manual will assist Brentwood property owners in the selection and installation of appropriate stormwater management measures.

Stormwater management technology alternatives referenced in the manual include the use of dry wells, rain barrels, modified French drains, permeable pavement, bioswales, vegetated filter strips, rain gardens, amended soils and providing credit for existing trees.

These stormwater management measures will foster the creation of an eco-friendly environment for present and future generations, which is a community-wide goal for the City of Brentwood.

### Online Business License Renewal

All businesses operating in Brentwood are required to obtain an annual business license. In 2019, the City of Brentwood transitioned to business license renewal online instead of via mail. Business license fees are due by **February 15, 2021**. Late fees will accrue after this date.



### Operation Food Search Receives Hydroponic Flex Farm Donation Nonprofit is the first St. Louis organization to acquire portable growing systems

Operation Food Search (OFS), a non-profit hunger relief organization, recently received two Flex Farms, which are fully self-contained hydroponic growing systems that will enable OFS to grow fresh, affordable produce. The vertical indoor farms cost \$5,000 each and were donated to the nonprofit by UnitedHealthcare Community Plan of Missouri and Fork Farms, an agriculture technology social enterprise based in Green Bay, Wisconsin. OFS is the first St. Louis organization to receive Flex Farms, which are currently located in 26 states and Canada.



Flex Farms create 25 pounds of produce per month based upon a 21 to 28 day harvest cycle. The harvest—ranging from nutritious leafy vegetables to herbs—requires a minimum of only two hours of care per month. The energy-efficient Flex Farms operate with a standard electrical outlet, occupy less than 10 square feet of space, and utilize zero pesticides and herbicides. Each farm can serve up to 1,900 families per year with a harvest of nearly 3,400 plants.

“Having access to fresh foods is vital to a healthy lifestyle and combating chronic disease. That is why we invented the Flex Farm, to break down the barriers to healthy food and empower people, organizations and communities to unleash the power of fresh food production,” said Fork Farms president Alex Tyink. “As part of our mission, we seek to develop strategic partnerships with organizations that share our values and work to create happier and healthier communities. We are thrilled for the opportunity to call Operation Food Search and United Healthcare Community Plan of Missouri partners in change.”



“We know that non-medical factors, including access to nutritious affordable food, safe housing, and transportation have an enormous impact on a person’s health,” said Jamie Bruce, CEO of UnitedHealthcare Community Plan of Missouri. “We are proud to support an innovation like Flex Farms, that makes it easier for our communities to access healthy foods and live healthier lives.”

## New Year - 10 People To Watch

The start of a new year might never have been more anticipated than waiting for the clock to strike midnight on Thursday so everyone could waive goodbye to 2020 and welcome in 2021.

To say that the last year has been a challenging one is a vast understatement for everyone in the world because of the effects of the coronavirus pandemic, and that was certainly true in the St. Louis sports world.

Dealing with stops and starts to their seasons, having players and staff members become ill with the virus, facing the economic realities of not being able to allow fans to attend their games became a fact of life for the Cardinals, Blues and Saint Louis University Billikens.

As the new year begins, some of those same obstacles remain as the course back to normalcy remains a work in progress. That will be something every athlete, coach and fan in St. Louis will have to deal with.

Some athletes, however, know that 2021 will pose more challenges for a variety of reasons. In what has become a New Year's Day tradition @STLSportsPage, we present our list of the 10 most important people to watch in St. Louis sports for the new year, presented in alphabetical order:

**Dylan Carlson** – The Cardinals top prospect made his major-league debut in 2020 and progressed enough in two months to find himself, at 21, batting cleanup in a playoff game. Whether he remains in that spot in the batting order this season is to be determined, but he will be in there somewhere on a daily basis. The hopes for improvement in the team's offense might be riding on the outfielder's young shoulders, especially if no moves are made to bring in outside help before the season begins. How he handled all of the obstacles in 2020 only reinforced the Cardinals opinion that Carlson is ready to play, and have success, in the major leagues.

**Yuri Collins** – There might be other players on the Saint Louis U. Billikens who will score more points or generate more headlines, but Collins has developed into one of the team's leaders. The sophomore point guard has the ability to make other players around him better and his success will go a long way toward determining how deep the Billikens can play into March. The Billikens are the best team in the A-10, should be a top 25 team and it isn't a stretch to predict this could be one of the best seasons in school history.

**Tommy Edman** – Even though it was based primarily on economics, the Cardinals' decision to not pick up Kolten Wong's \$12 million option for 2021 was also due in part to their confidence that Edman can become an above-average replacement as the starting second baseman, both offensively and defensively. Edman, 25, became a virtual regular in the lineup the last two years even if it came at a variety of positions. Being asked to play just one primary position, especially one where he should be quite comfortable, might provide a solid base that will allow Edman to become even more of a threat on offense in 2021. He also is mature enough that trying to succeed a two-time Gold Glove winner will not affect him mentally.

**Jack Flaherty** – The ace of the Cardinals' pitching staff found himself involved in a lot of the chaotic developments that became front-page news in 2020 beyond the pandemic. He was outspoken with his opinions about the Black Lives Matter movement, civil unrest and racial injustice, finding himself on the receiving end of criticism from some fans for perhaps the first time in his life. Flaherty will no doubt be involved again with those issues this year, but he also faces the challenge of proving he can be a better pitcher than he was in 2020, especially as he begins the climb to a higher spot on baseball's economic ladder. With questions about how good the Cardinals' offense will be, for the team to have the

success it wants the pitching staff will need to be dominant, starting with Flaherty.

**Jordan Goodwin** – One of the picks as the pre-season player of the year in the Atlantic 10, Goodwin is enjoying a solid senior season as he continues to climb the ranks of the all-time leaders in several categories in Billikens history. Goodwin, like Collins, also is a smart player, knowing that they have several teammates who could be on this list and that they are both just part of a quality team which will make the Billikens even more dangerous as the season progresses.

**Jordan Hicks** – He hasn't thrown a pitch in the major leagues since June 22, 2019, after opting out of the shortened 2020 season because of being a higher risk candidate to contract coronavirus as he was completing his recovery from Tommy John surgery. The extra months of not pitching might have a positive effect on Hicks' return, but he also was not able to complete a normal minor-league rehab assignment in preparation for returning to his spot as the Cardinals' closer with the minor leagues being shut down in 2020. If Hicks can return early in the season, and become dominant again, it will make an already above-average bullpen even better.

**Torey Krug** – When the Blues could not reach an agreement with Alex Pietrangolo on a new contract, they turned to Krug, signing the former Boston Bruins defenseman to a seven-year deal. The comparison between the two will be predictable, even though Krug figures to fill a different role with the Blues than did their longtime captain and defense anchor. The team hopes Krug will provide a boost to their power play even if he likely won't come close to logging as much ice time as Pietrangolo did on a nightly basis. Over his last four seasons with the Bruins, Krug tied for the most power-play points by a defenseman in the league.

**Yadier Molina** – There are two reasons why Molina makes the list this year. The first is the question of whether he will be back for another season with the Cardinals. After becoming a free agent for the first time in his career, the 38-year-old Molina has spent the last two months exploring his options even though he reportedly has said his preference is to return. He is said to be seeking a two-year deal and if he does return, then the focus will shift to his on-field performance, proving again that he can defy Father Time for at least one more year. If Molina does depart, then Andrew Knizner will inherit not only the catching role but Molina's spot on this list.

**Vladimir Tarasenko** – One of the best players in the NHL when he is healthy, Tarasenko's performance has been limited for the last two years because of an injury to his left shoulder that has required three operations in the last three years. He played only 10 games last year, and has at least two months left on his latest rehab assignment before possibly rejoining the active roster. The injury snapped a string of five consecutive seasons scoring 33 or more goals and there is no way to predict whether Tarasenko will be able to match that level of success when he comes back. Coming close, however, would provide a major offensive boost for the Blues' playoff chances.

**Adam Wainwright** – As is the case with Molina's future, the first reason Wainwright is on this list is because of the question of whether he will be pitching for the Cardinals or a different team in 2021. A bounce-back season which included a complete game on his 39th birthday in 2020 showed that Wainwright still has something to offer on the days he pitches, in addition to the leadership role he provides to the team's young pitchers every day of the week. As is also the case with Molina, the Cardinals need to know if Wainwright will be back before they can move on to other possible roster moves before the season begins.



Brentwood Blvd., Brentwood MO 63144. The filing hours are 8:00 a.m. to 5:00 p.m. Tuesday, **December 15, 2020**, through Tuesday, **January 19, 2021**. The office of the City Clerk will not be open on Saturdays and Sundays or those days designated a holiday by the City of Brentwood.

All qualified candidates are hereby notified of the statutory requirement to provide to the City Clerk, at the time of filing, proof of identity such as social security card, Missouri driver's license, or must be recognizable to the City Clerk.

Candidates must have filed the required Campaign Finance Disclosure reports, and the Financial Disclosure Statement for Political Subdivisions (Ethics) for any prior elections before they can file as a candidate for another office.

All candidates' names shall appear in the same form in which the candidate is registered to vote except that, when certified by the candidate as a necessary means of identification, the following may be allowed:

1. Commonly used nicknames
2. Commonly used abbreviations
3. Parenthetical reference to married names

Persons who, after filing their names as candidates, wish to withdraw as such candidate, must file their notice of withdrawal with the City Clerk in the City Clerk's office no later than 5:00 p.m. on Tuesday, January 19, 2021.

The filing fee for each elective office shall be \$5.00 payable by check or cash. In case of withdrawal of a candidate, there shall be no refund of filing fee. All filing fees shall be paid to the City Clerk and or Deputy City Clerk at the time of filing. Provided however, if a candidate files a sworn affidavit with the City Clerk/Administrator stating he/she is financially unable to pay the filing fee, the candidate shall not be required to pay the fee.

The City Clerk shall be responsible for the oversight of the filing of candidates and shall clearly designate where candidates shall form a line to effectuate such filings and determine the order of such filings; except that, in the case of candidates who file a declaration of candidacy with the City prior to 5:00 P.M. on the first day for filing, the City Clerk shall determine by random drawing the order in which such candidates' names shall appear on the ballot. Deer Creek Greenway Connector – Negotiated with MoDOT (traffic signals mostly), memo included in Jacobs Change order. Brentwood only pays 10% of improvements, saving City over \$100,000.





You can enter a cell phone number, landline number and email address and select the types of weather warnings you wish to receive. There is no charge to residents or businesses for this service.

# RESTAURANT REVIEWS



## Italian Revisited

It has been four years since we last reviewed Fratelli's in St. Charles and since today is National Spaghetti Day, we said why not? And as expected, it is still great.

St. Louis is truly blessed when it comes to reasonably priced great restaurants, especially Italian restaurants.

I somehow envision a lowly clerk at Ellis Island processing newly arrived immigrants telling Jewish immigrants to move to New York and open a deli and Italian immigrants to go to St. Louis and open a restaurant.

If that scenario ever did exist, we should erect a monument to that clerk and declare him a National hero!

Like many other great Italian restaurants in the area, Fratelli's well respected reputation had its genesis with the arrival of Tommaso and Francesca Alagna to America's shores in 1948. It is said that memories of the old country always brought them back to the extended family sharing their family recipes for great food.

In 1970 Tommaso opened a self-named restaurant, Tommaso's, on Airport Rd. in Ferguson. Son's Joe and Tom grew up in the kitchen and by the mid '70's they had started a small pizza place on First Capitol Drive in St. Charles. I once tore their door off the hinges, but that is another story for another time.

As with most family owned, Italian restaurants, success was followed by a relocation and expansion that became Fratelli's Ristorante. Located just off I-70 on Zumbel, Fratelli's is a superb example of a family friendly restaurant that is suitable for any dining experience. There is comfortable dining room with booths and tables, a private dining area and a cozy bar where you can have your favorite drink if you have to wait for seating.

In this age of COVID-19, they are super dedicated to a safe dining environment. When we arrived we saw them sanitizing their menus after each use. They also use a YELP app that allows you to make a reservation online and it will keep you updated on how long it will be until your table is ready. You can stay at home, or go shopping etc., and arrange to go to Fratelli's as your table is being prepared. It is a very handy way to not have to wait at the restaurant with other customers. They are also limiting their seating capacity to 50% for your safety. We did notice that all employees were masked at all times. Drive up service is also available.

While I understand St. Louis county's requiring you to fill out a COVID tracing information form for indoor seating, this is not the case in St. Charles County at this time. So if you are hesitant to give out your private information, this may be more to your liking. Fratelli's is proud to say they still use those family recipes and all of their sauces etc. are made in house every day. They have added a few new items to satisfy a younger customer such as the Fratelli Burger a Grilled Chicken Panino and a Rustic salad with mixed greens, balsamic vinigarette, dried cranberries, candied pecans and feta cheese, but all of their classic Italian items are still there as well.

Fratelli's is proud to say they still use those family recipes and all of their sauces etc. are made in house every day. They have added a few new items to satisfy a younger customer such as the Fratelli Burger a Grilled Chicken Panino and a Rustic salad with mixed greens, balsamic vinigarette, dried cranberries, candied pecans and feta cheese, but all of their classic Italian items are still there as well.

Fratelli's menu has something for everyone and it took us a few minutes decide on what delicacy we would chose. A basket of warm Italian Bread with soft butter and a dish of olive oil started our service. The basket was lined with what looked like an Italian newspaper, a very nice touch.

Sue had the Grilled Chicken Panini with a side of red pasta, after all, it was National Spaghetti Day. Both items were excellent.

I started with a dinner salad with their creamy Italian house dressing. This dressing is so good, they serve more than 25 gallons of it each week!



My main dish was the Tuto Mare; linguine with shrimp, scallops and lobster. You have your choice of



a garlic cream sauce or a pomodoro sauce. I decided on the cream sauce. This was the real deal. Real cream, real shrimp, real lobster and real scallops. A lot of restaurants use fake scallops and lobster, not Fratelli's, and for \$19.00, this was a masterpiece.

If you are looking for a veggie main dish, I highly recommend the Egg Plant Parmigiana.



We were too full to even consider any of the homemade desserts, but they all looked fantastic.

All portion sizes are above average and we actually couldn't finish our meals. We were give cute little cardboard boxes rather than styrofoam plates with a lid to take our leftovers home. We have more than enough for lunch tomorrow.

Fratelli's wine list includes imported and domestic wines priced from \$6 to \$8 per glass, or \$24 to \$32. per bottle The selection is more than adequate and reasonably priced.

When you want a great Italian diner in a pleasant atmosphere, for any occasion, it's definitely Fratelli's.





## Bites of Arkansas

We recently interviewed Kat Robinson on her new book "A Bite of Arkansas: A Cookbook of Natural State Delights." Normally Kevin is the foodie of the two of us, but when I see a good cookbook filled with tantalizing photos and recipes it just makes me want to share it with others. This book is a masterpiece of southern baking. Enjoy dozens of pies that you will find throughout the state of Arkansas, many of them you will recognize as your childhood favorites. One of my favorites was fried apple pies. Memories of this half-circle pie takes me back to my Grandma Dorothy's cast iron pot-bellied stove with her cat curled up at the bottom for warmth. She grew her own peaches too, so at times we would have peach fried pies.







## OPEN SPACE COUNCIL UPDATE

This year, conserving, improving and restoring our public lands was as important as ever. In the midst of the COVID-19 pandemic, the Open Space Council adapted our on-the-ground programs to offer quality opportunities for community members to volunteer safely and make a difference to our parks and rivers.

We remodeled Operation Clean Stream as a 9-day event of self-guided cleanups throughout the Meramec Watershed and conducted plantings and invasive honeysuckle removal in small socially-distanced groups.

As our community took refuge in the great outdoors, we are grateful to our volunteers and supporters who helped enhance and restore parks, waterways and trails in the region, making it a better place to live, work and recreate.

With your support, the Open Space Council made a big impact on our region this year by:

### Operation Clean Stream

Coordinating 538 self-guided volunteers who removed 141.95 cubic yards of trash, 1,735 tires and 2,981.5 lbs of metal from the Meramec River Watershed in August.

### Operation Wild Lands

Engaging 45 volunteers who planted over 1,200 willows in Lower Meramec Park to help fight erosion along the riverbank in February and December.

Hosting 15 participants in a workshop on the root docking method to remove invasive honeysuckle on the AI Foster Trail in December.

### Land Trust

Conserving 70 forested acres of land in LaBarque Creek which was added to the Young Conservation Area in March.

### Community Stewardship Alliance

Working with regional partner organizations to develop the Community Stewardship Alliance. This program will officially launch in 2021 and will establish long-term volunteer leadership to steward natural areas in St. Louis County Parks.
