## Saint Mary Magdalen Embarks on Improvement to the Parish Complex

The Saint Mary Magdalen Dominican Garden/Park will provide a green space:

- Safe recess area for the Saint Mary Magdalen school children
- Outdoor classroom for Saint Mary Magdalen
- Weekend gathering place for parishioners
- Spot to sit during the Parish Picnic, Food Truck Night, Mass in the Grass and other parish events

The convent that had been on the property since 1937 was in total disrepair. The cost to repair it:

- asbestos removal
- lead paint removal
- complete sewer replacement
- complete slate roof replacement
- complete electrical replacement
- brittle water lines
- broken HVAC systems: air conditioning and boiler
- Mold in the second floor of the convent ceiling

To repair all of that with no specific purpose was deemed inconceivable.

Again, with no specific purpose and such repair costs, the three parish boards and the parish contractors made the decision to tear down the convent and replace it with a much needed green space.

The total cost for this project is \$400,000. \$200,000 dollars has been raised and the parish is working to secure the additional \$200,000. Given that Brentwood Bound will do much to beautify the Manchester Road area of Brentwood, Mo this seemed like the ideal time to create this beautiful green space.

Phase 1 of the project has been completed, the takedown of the convent.

Phase 2 and 3 are next, which is to fill the hole with dirt and let the area settle and build a Sacristy onto the Chapel. We will take this project in phases and as money comes in we will continue to complete the Dominican Garden.

The Garden plans to resume the Whitaker Music Festival in 2021.

## Drive-In St. Louis to Extend Two More Weeks Largest Drive-In Concert Venue in America Adds More Bands

Who: Drive-In St. Louis

What: Due to the positive public response, new Drive-In Concerts and Movies have been scheduled along and one new high school graduation event.

When: Five new event dates added through mid-June. Tickets go on sale today, June 3, at noon at [www.driveinstl.com](http://www.driveinstl.com).

Where: POWERplex – former St. Louis Mills Mall, Hazelwood, MO.

How: Covid-19 Health restrictions are being met through social distancing as patrons at the events will have their own “party pods” next to their vehicles for the concert and movie nights.

With this weekend nearly sold out for Trixie Delight on Friday, and red-hot Blues artist, Jeremiah Johnson on Saturday, all eyes turn to the next two weeks. Today at noon, the tickets will go on-sale for five new concert dates:

Thursday, June 11 - The Schwag, a Grateful Dead Experience, followed by the cult film “The Big Lebowski” on the big screens.

Friday, June 12 - will be an exciting private event with more information to come.

Saturday, June 13 -- the Steve Ewing Band (lead singer of The Urge). Special Guests Hounds will get the lot rockin’, followed by the film, “Coming To America.”

Thursday, June 18,-- Everett Dean and the Lonely Hearts will bring Elvis back to life with “Jailhouse Rock” as the movie to end the night.

Friday, June 19, -- Boogie Chyld, a great 70s Disco and Funk dance band, with special guests Arionne followed by the movie, “House Party.”

Saturday, June 20 – Brushville, one of the hottest country rock bands in the Midwest, comes to St. Louis with special guest Molly Lovett, a young and talented St. Louis country artist.

In addition, Drive-In St. Louis has added another high school graduation date to the commencement line-up, as Incarnate Word Academy will celebrate their class of 2020. This graduating class will bring our total number of seniors crossing the stage up to 2,806.

Overview:

The overwhelming success of the largest Drive-In concert and movie venue in country, has prompted the promoters to extend another two weeks into mid-June.

The great diversity of local and regional bands helped to sell out 6 of the 11 concerts and the weekday family nights during the week attracting an average of 300 cars. “The sense

of community and getting back to a level of ‘normalcy’ was really incredible each and every night,” said Bill Fogarty of Fogarty Services, the lead production team on the concerts. At Saturday’s Super Jam sold out concert, the crowd was asked if they wanted to continue the concerts and movie nights. “The horns honked non-stop for a minute. I guess that’s the new standing ovation,” said Fogarty.

General Admission parking passes each night are \$40 per car in advance and \$50 at the gate with a six person per-car limit.

## WGU Missouri Donates \$15,000 in Grant Funding to K-12 Teachers Across Missouri

To celebrate teachers who have worked diligently to adapt to new ways of educating and connecting with students amid the COVID-19 pandemic, WGU Missouri has announced it has awarded \$15,000 in grant funding to teachers across the state to fund their innovative classroom projects. The grants are made possible through WGU’s “Fund My Classroom” initiative, and 29 classroom projects were selected for funding.

The grants will go a long way toward making several K-12 classrooms a more engaging environment for students when they return to school. Projects set to receive funding include a 3D printer at Frontier STEM High School in Kansas City, which will allow students at this high-poverty school to learn many abstract chemistry concepts and provide them with real-life, hands-on experience; alternative seating options at Elliott Middle School in Boonville, which will challenge and encourage students to learn in any environment; technology that will allow students at El Dorado Springs Middle School in Cedar County, Mo., to create and record podcasts over information covered in class as an alternative to traditional tests; and a Butterfly Garden at East Elementary in the Jerseyville Community School District, located in St. Louis’ Metro East area.

Teachers often spend their own savings to cover the costs of classroom projects. To thank them for their efforts, WGU Missouri issued a call in March for K-12 teachers to submit their project ideas on the university’s website for consideration for full or partial funding. The online, nonprofit university sorted through over 100 nominations for classroom projects and selected 29 for funding. This is the second year WGU Missouri has made the ‘Fund My Classroom’ initiative available to teachers across the state. Last year, the university was able to award \$10,000 toward 15 classroom projects.

“We are so pleased with the response this year and are happy we can bring so many of these innovative projects to life through our ‘Fund My Classroom’ initiative and give the impacted teachers something to look forward to in the midst of all the uncertainty COVID-19 is causing for schools across the region,” said Dr. Angie Besendorfer, Chancellor of WGU Missouri. “This initiative is an opportunity for WGU Missouri to celebrate teachers, and it’s a great way to thank them for the lasting, positive impact they have on their students. We were excited to hear from so many great teachers with excellent ideas that will enhance learning both in and out of the classroom.”

In addition to donating funds to deserving teachers across the state, WGU Missouri is also offering up to \$50,000 in scholarships to those who wish to further their education. Each WGU Teacher Appreciation Scholarship is valued at up to \$2,500, which is applied at the rate of \$625 per six-month term for up to four consecutive terms. To be eligible, scholarship applicants must be officially admitted to WGU Missouri, complete the scholarship application, and be interviewed by a WGU scholarship counselor. Recipients will be selected based on their academic records, financial need and readiness for online study at WGU Missouri, among other considerations. New students can apply online now through June 30 at [missouri.wgu.edu/teachers](http://missouri.wgu.edu/teachers).

## Scam Alert! How to Protect Yourself from Fraud

There is no doubt that now more than ever we are spending our time glued to our screens. With every social media account we sign up for, every picture we post, and status we update, we are sharing information about ourselves with the world.

While the majority of people using these sites do not pose a threat, malicious people may be drawn to them because of the accessibility and amount of personal information that's available. The more information malicious people have about you, the easier it is for them to take advantage of you.

### UNSOLICITED CALLS & TEXTS

The credit union will NEVER call you asking for personal, sensitive information, such as full social security number, full bank account number, debit or credit card numbers, CVV or PIN. If you receive an unsolicited call asking this, it is probably a scam.

- Never offer personal or account info over the phone without verifying the caller's identity.

- If you are uncertain of the identity of a caller, hang up and initiate the call yourself using a known phone number.

- Do not call any phone number received in a voice message or email asking for personal information. It could lead you to a phony answering system.

As a general guideline, be highly suspicious anytime you are requested to provide personal information over the phone.

### SHARING YOUR PERSONAL INFORMATION

While most of us are under stay-at-home orders, many more are turning to social media as a fun distraction, but it could actually be a chance for scammers to steal your personal information.

- Think before you post.

- Do not accept friend requests from people you do not know irl.

- Be wary of viral "get to know you" copy & paste posts & quizzes. They might seem like a fun way to kill time while we're cooped up at home, but they are used by scammers to get you to share personal information and then steal your passwords and identity. A lot of the time they are personal security questions for your accounts like "first pet" or "first job."

- To keep your information as secure as possible from strangers, avoid any "public" settings and only accept friend requests from people you know IRL.

- Do not share things that would make you vulnerable, such as your address or info about your schedule or routine.

- Be wary of third-party applications.

If you suspect you've become a victim of a scam or you have any questions about a transaction that you think might be fraudulent on your account, contact your financial institution right away. ## Saint Louis Zoo Plans to Reopen June 13

Guests have to make reservations in advance

Today, the Saint Louis Zoo has announced Saturday, June 13 as its reopening date for the public. As part of its commitment to the continued well-being of guests, staff and animals, and in an ongoing effort to assist the community in preventing the spread of COVID-19, the Zoo has implemented enhanced protocols and procedures.

"I am excited to share the news about our reopening and I hope everyone knows that the Saint Louis Zoo values safety," said Jeffrey Bonner, Ph.D., Dana Brown President & CEO, Saint Louis Zoo. "I am amazed at the incredible care our staff has provided to the animals during this pandemic as well as the diligent work underway in preparation to provide our guests with safe and memorable experiences."

Zoo Leadership has closely monitored the developments of the global outbreak of COVID-19, following regular updates from the U.S. Centers for Disease Control and Prevention (CDC), World Health Organization (WHO), as well as information provided by federal, state and local authorities and health officials.

The unique characteristics of the Zoo campus and vast outdoor experiences provide the opportunity to safely implement numerous safety measures. While specific details pertaining to those measures as well as Zoo policies and protocols for guests will be shared closer to reopening, there a few outlined below:

First, in order to better ensure good social distancing, the Zoo will limit attendance and require timed, free reservations in order to enter the Zoo. The Zoo will be open seven days a week and guests can make reservations at stlzoo.org beginning at 9 a.m. on Monday, June 8. The Zoo also will provide a phone number for those unable to access the Zoo's website.

Next, at the direction of the Department of Health for the City of St. Louis, it is mandatory for Zoo staff to wear masks/face coverings and the Zoo will require all guests over the age of 9 to wear masks/face coverings while visiting. Guests with preexisting health conditions unable to wear a mask/face covering for medical reasons are exempt. Guests are allowed to remove or lower their masks/face coverings when practicing good social distancing of 6 feet or more when eating or drinking.

"Face coverings can help minimize virus transmission from asymptomatic individuals. Keeping our animal and veterinary care staff safe and protected is the best measure to keep our animals safe and at minimal risk of exposure to a virus that we know very little about," said Dr. Bonner.

"On behalf of everyone at the Saint Louis Zoo, we appreciate your support and we look forward to seeing you soon," said Dr. Bonner. "Until then, we encourage you to follow us on social media or on our blog to stay connected as we do our best to share stories and photos."



## Senior Harvests First Tom with a Bow

Eighty years old Henry Tupper Drane of Brentwood was deer hunting on a partially wooded farm in Adair county last November when he took his first turkey ever, and he did it with his compound bow. Here is how it happened in his own words.

The ground blind was almost perfect for turkey hunting, although it was set up primarily for deer with turkey in mind. Everyone in the club had tried their luck in the blind, to no avail; but the day the turkeys came out, they assigned it to me! With a draw weight of 52 pounds, my Hoyt bow nailed a tom at 15 yards.

I got to the blind about 2 pm, and had just settled into my chair, after discarding my gear and adjusting the chair for my two shooting windows. While indulging in a swig of water after walking 1000 yards to the blind, I glanced up. Plodding directly towards my left corner shooting window was a line of six hens! The blind set up was just a few yards down slope from a ridge top foot plot 25 yards across by about 100 yards long and surrounded by an acorn grove (pin oaks). The hens paid no attention to the blind as they sashayed past me enfilade at 10 yards.

As quietly as possible I set down my water bottle, unslung my bow, un-quivered an arrow, nocked, attached my release and drew back, just as the last hen cleared my right corner shooting window. No sense trying to open a side window because they would be beyond my 15 yards shooting limit for hitting as small a target as a turkey's kill zone.

Oh well, I sighed to myself, I came here to deer hunt, and I set my bow down. But for fun, I texted my wife, "Next time, Dear, when you send me six hens, ask them to walk more slowly!" Then I picked up my binoculars and started scanning the woods around the plot for deer.

It was just after 4 pm when I saw movement to the far right of the oblong food plot. Emerging from the woods at about 50 or 55 yards were some more turkeys. I quickly focused my binoculars and counted ten toms! As I watched, they started feeding, meandering slowly my way. After five excruciating minutes they were almost at my shooting lane. Quietly picking up my bow, I prepared to draw.

The first tom passed at the far side of the food plot, 25 yards; I let him pass. But the unfortunate third bird was feeding slowly just at 15 yards. I drew back, and with all the experience of shooting 3-D turkeys at the South County Archers range at Jefferson Barracks in St Louis, I framed the sight, set the 15 yard pin on the kill zone and slowly squeezed the release. Zip! Thud! Squawk! And the whole flock was fluttering their wings. They all turned and ran down the wooded ridge just to the right of my blind.

Only the one that I hit kept flopping his wings; I watched, along with about six of his buddies. "How sweet", I thought, "the flock is so concerned about their wounded pal!" Not so, I learned later, they were not there to console him but to kick his butt and move themselves up the pecking order! But old number three just kept on flopping. After about two minutes I thought I had better go put a coup de grace on the old boy who had by now flopped about 50 yards down the ridge.

Stealthily I emerged from my blind, traced the line of my shot and picked up my arrow. As I descended the ridge and approached to 15 yards, the tom I had shot stopped flopping, the other toms vamoosed, and I got busted by a doe working her way up through the woods! Oh well, a more experienced turkey hunter would have sat tight a little longer and maybe gotten a shot at the doe as well!



I hefted the bird, brought him back to the blind, and set up again in the hopes that the doe's warning bleat had not been heard by all the deer in the woods. That was not the case, so when shooting time had elapsed, I lugged my fresh harvest back to camp smiling ear to ear. My gobbler weighed in at seventeen pounds, had a 7 ½ inch beard and one inch spurs! Medium tom, but still a wonderful harvest for a senior deer / turkey hunter.

The turkey breast and legs went to my cooler and the tail fan, beard and one wing went to Schwartz Studio to be mounted.

Final anecdote: at a dinner party serving wild turkey to my guests I bragged, "I shot my first deer with a bow when I was 70; my first turkey with a bow when I was 80; I wonder what I will get when I turn 90!" My dear wife, Lena Fish, immediately quipped, "If you are lucky, you may get me with Cupid's arrow!"

## Clayton Garden Club Receives Grant

Celebrating its 80th year, the Clayton Garden Club is the proud recipient of a National Garden Clubs, Inc., Plant America Community Project Grant. The grant has been awarded to the Clayton Garden Club as part of their collaboration with EarthDance Organic Farm School, to further develop and support their Seven Generations Garden and educational programming on the EarthDance farm.

EarthDance Organic Farm School operates at the site of the oldest known organic farm west of the Mississippi river. It is located in Ferguson, Missouri, and has been a seat of organic food production since 1883. EarthDance built the Seven Generations Garden as a testament to the Iroquis philosophy that decisions made today should result in a sustainable environment seven generations into the future. This small-scale learning garden adjoins the commercial-scale organic farm. EarthDance uses their entire 14-acre property as a school, and they grow food for the general public during all seasons of the year.

The mission of EarthDance is to grow food, farmers, and community through hands-on education and delicious experiences. Beds in the Seven Generations Garden are designed with ready-to-taste and smell opportunities that are ripe for exploration. Adults enrolled in agricultural training programs at EarthDance use the Garden to practice home-scale growing techniques, companion planting, forest-gardening, and seed saving. The Garden is also an experiential learning opportunity for thousands of youth, including school and homeschool groups, and summer camps.

Brianna Harris has been named a Washington University 2020 College Prep Scholar. The University has admitted 50 rising high school sophomores to its innovative College Prep Program, a multiyear initiative that prepares high-achieving students with limited financial resources for college.

The students represent public, private and charter schools from across the region. Due to the COVID-19 crisis, summer programming will move online. However, students still will have opportunities to study with top faculty, learn about the college application process and reflect on their own goals and interests.

“This is an exceptionally talented group of students, and though they won’t be together at Washington University, they will still be connected and engaged,” said Courtney E. Brewster, College Prep Program director, who leads the program with support from Ashley Vinson, program coordinator, and LaEisha Meaderds, administrative assistant, as well as several graduate and undergraduate fellows.

## WGU Missouri Announces up to \$100,000 in Scholarships for Students Impacted by the COVID-19 Pandemic

In response to the unprecedented economic hardships millions of American families are now facing due to the COVID-19 pandemic, fully online, nonprofit university WGU Missouri is offering up to \$100,000 in scholarships to impacted individuals looking to strengthen their skills by earning a degree online, from the safety of their homes. 



## C.A.R.E.S. ACT

On March 27, 2020, the president signed the Coronavirus Aid, Relief and Economic Security Act (CARES) Act into law. The CARES Act is a \$2 trillion relief package to address the economic fallout related to the COVID-19 public health emergency. Section 18003 makes funds available from the Education Stabilization Fund for grants to State Education Agencies for elementary and secondary school emergency relief. Section 18005 of the Act provides that Local Education Agencies (LEAs) receiving funds from the Elementary and Secondary School Emergency Relief Fund must provide equitable services to non-public schools as required under section 1117 of the ESEA. However, control of these funds and title to materials, equipment and property purchased with such funds must remain with the public school district, and be administered by the public LEA. Public school districts will need to consult with non-public school officials to determine how the services will be provided to the non-public schools. Allowable Uses Applicable to Non-Public Schools 1. Any activity authorized by the ESEA of 1965, including; • The Individuals with Disabilities Education Act (20 U.S.C. 1400, et seq.) ("IDEA"), • The Adult Education and Family Literacy Act (34 U.S.C. 463, et seq.), • The Carl D. Perkins Career and Technical Education Act of 2006 (20 U.S.C. 2301, et seq.) ("the Perkins Act"), or • Subtitle 8 of title VII of the McKinney-Vento Homeless Assistance Act (42 U.S.C. 11431, et seq.). 2. Coordinating the preparedness and response efforts of local educational agencies (LEAs) with state and local public health departments and other relevant agencies to improve 1 Brentwood School District 1201 Hanley Industrial Court, Brentwood, MO 63144 May 12, 2020 - coordinated responses among such entities to prevent, prepare for and respond to COVID-19. 3. Providing principals and others school leaders with the resources necessary to address the needs of their individual schools. 4. Developing and implementing activities to address the unique needs of low-income children or students, children with disabilities, English learners, racial and ethnic minorities, students experiencing homelessness, and foster care youth through activities that include how outreach and service delivery will meet the needs of each population. 5. Developing and implementing procedures and systems to improve the preparedness and response efforts of LEAs. 6. Training and professional development for LEA staff on sanitation and minimizing the spread of infectious diseases. 7. Purchasing supplies to sanitize and clean the facilities of the LEA, including buildings operated by such agency. 8. Planning for and coordinating during long-term closures, including how to: • provide meals to eligible students, • provide technology for online learning to all students, • provide guidance for carrying out requirements under the IDEA; and, • ensure other educational services can continue to be provided consistent with all federal, state and local requirements. 9. Purchasing educational technology (including hardware, software and connectivity) for students who are served by the LEA that aids in regular and substantive educational interaction between students and their classroom instructors, including low-income students and students with disabilities, which may include assistive technology or adaptive equipment. 10. Providing mental health services and supports. 11. Planning and implementing activities related to summer learning and supplemental afterschool programs, including providing classroom instruction or online learning during the summer months and addressing the needs of low-income students, students with disabilities, English learners, migrant students, students experiencing homelessness and children in foster care. The CARES Act funds are for the 2019-20 school year and will be available to LEAs for use until September 30, 2022. While the Missouri Department of Elementary and Secondary Education has a number of nonpublic schools registered for participation in federal programs, there may be additional nonpublic schools that wish to receive an equitable share of services funded by the CARES Act. Nonpublic schools not registered with the Missouri Department of Elementary and Secondary Education (DESE) may contact the Federal Programs Section to participate in the CARES Act services. It is important to note that the non-public school will not receive funds, but rather services from the public school district. 





# RESTAURANT REVIEWS

## A Long Drive To A Nearby Diner

I wanted to write about an Asian restaurant I heard about in Maryland Heights But found them only open for carry-out. We then drove to the Brentwood area to find a place for lunch. It was at that point that I realized St. Louis County still doesn't allow sit-down dining.

We headed out I-64 to St. Charles County. Sue was hungry for Chinese food, so I googled nearby restaurants and found a highly rated restaurant just off Highway 94 at Pittman Hill Rd. Their door was open and the sign said "open" but we found out it was still carry-out only. Apparently St. Charles County still does not allow dining in.

Almost 70 miles later, we found ourselves back in St. Charles City, where inside dining is now OK.

It was 2:30 in the afternoon and at that point we were hungry for just about anything. The perfect destination turned out to be a

St. Charles tradition since 1991, Gingham's Homestyle Restaurant.

You may have recognized Gingham's for their huge flag pole just south of I-70 on Hiway 94, But you need to know they have recently moved about a 1/2 mile south to 1566 Country Club Plaza. They now have a lot more, much needed, parking than before. This location is where the Tilted Kilt used to be.

Unfortunately, they did not move the flag pole with them. I understand it was too costly to move, although there is a discussion about a Go Fund Me account from their regular customers to try to help with a relocation effort.

Gingham's is open 24 hours a day, (see below for adjusted times) and with more than 177 items on the menu, there is definitely something for everyone.

The best part about Gingham's is that all items are available at all times, so if you want pancakes and eggs in the middle of the afternoon, or liver and onions at 7:00am it's no problem.

Sue ordered the Tilapia dinner with fresh



corn and green beans with bacon. It came with two fresh baked dinner rolls. She finished it off with some turtle cheese cake. Everything was large portions, and perfectly prepared. I am a sucker for biscuits and gravy, and the Italian Biscuits and gravy with garlic, onions and green and red peppers caught my eye, but I decided on Country Eggs Benedict; biscuits, sausage, American cheese, poached eggs and country gravy. Does it get any better? I don't think so!

The dining room has been adjusted to have tables and booths more than 6 feet apart, servers all wear masks and gloves and there are automatic hand sanitizer dispensers all around the dining area.

The décor is dineresque with a couple of side rooms for meetings or large groups, booths and tables as well as a counter area.

Gingham's has daily specials, Senior Citizen discounts as well a discount for paying cash. We scored on both and saved almost \$5.00.



This is a family friendly restaurant that serves great food. It's like going to Grandma's for dinner. We highly recommend eating at Gingham's for any occasion at any time of the day or night.

Sunday morning after church, and 1:00 - 2:00am gets pretty crowded and at this point in time there is no waiting inside the restaurant. They will take your cell phone # and call you while you wait in your car when your table is ready. Groups are limited to 6, or no more than 10 from the same family. At this time they do close between 2:00am and 7:00am for sanitizing and cleaning, so govern yourself accordingly. They currently use disposable paper menus, tables and chairs are cleaned after each customer, servers do not handle cash and those who take payments are required to sanitize their hands after each transaction


The committee announced that public health and safety concerns related to the coronavirus pandemic forced the cancellation of the 2020 festival scheduled for July 17-26. Rodeo contestants rely on the event to be one of the largest payouts on the annual PRCA rodeo circuit. It also features some of country music's biggest stars performing before sold-out crowds at the Frontier Nights concerts.

In addition, the event raises funds for the CFD Old West Museum, a year-round attraction that showcases artifacts celebrating Cheyenne Frontier Days history western culture. It also supports The Volunteer Crisis Fund, which provides emergency monetary assistance to event volunteers when needed and the Cheyenne Frontier Days Memorial Foundation, which provides scholarships for volunteers and their dependents.

## ST. LOUIS AQUARIUM, ST. LOUIS WHEEL PREPARE FOR RE-OPENING AT ST. LOUIS UNION STATION

The indoor and outdoor attractions at St. Louis Union Station will reopen on June 8, 2020 after receiving clearance from the City of St. Louis.

### ST. LOUIS AQUARIUM

The St. Louis Aquarium at Union Station will resume regular hours from 9 a.m. to 5 p.m., Monday through Thursday and 9 a.m. until 8 p.m. on Fridays and Saturdays.

New physical distancing protocols will be in place along with enhanced sanitation measures and extensive team member training to ensure the health and safety of guests and workers.

The St. Louis Aquarium and other St. Louis Union Station attractions have been closed in accordance with Missouri and St. Louis City COVID-19 regulations.

### Aquarium Ticketing Changes

All guests, including annual pass holders, will be required to reserve timed tickets in advance to keep within City of St. Louis regulations for significantly reduced capacity in the Aquarium.

Advance reservations will guarantee guests' admission on the day of their visit. No tickets will be available for same day visits at the ticket counter and no guests will be admitted to the Aquarium prior to their reservation time.

Guests who are feeling unwell on the day of their visit can contact the Aquarium and have their tickets exchanged for another date.

### Aquarium Safety Protocols Added:

The health and safety of guests and team members is the highest priority of the St. Louis Aquarium and St. Louis Union Station. Enhanced safety and sanitizing procedures have been enacted for the Aquarium reopening, including:

- All team members will wear masks

and guests over the age of 9 are required to wear masks at the direction of the St. Louis City Department of Health. Guests with pre-existing health conditions unable to wear a mask for medical reasons are exempt. Guests may remove or lower their masks when they are able to stay six feet or more away from others or when eating or drinking.

- A one-way flow has been established through the Aquarium to help with social distancing.

- The Aquarium is maintaining its existing high standards of cleanliness and all high-touch surfaces such as windows, doors, railings, restrooms, and elevators will be cleaned continuously by the Aquarium's Clean Team. Hard surfaces will be sanitized throughout the attraction, lobby and restrooms continuously.

- Additional hand sanitizer stations will be found throughout the Aquarium including at the entry, exit and in the restrooms.

- Employees will be screened daily to verify that they do not have fevers or other COVID-19 symptoms. Guests will walk through an infrared scanner at the entrance to verify their temperatures and will take a survey to confirm their health. Those with temperatures of more than 100 degrees will be asked to return on another day.

- Guest services associates will refer guests to signs listing COVID-19 symptoms to verify that everyone in their party is symptom free.

- Floor decals have been added throughout the queue lines and inside the aquarium to help guests maintain six feet of separation from others. At touch pools and interactive areas, guests can step up and enjoy the experience when floor decal spaces are open.

- The Aquarium's touch pools, Otter Chat and animal presentations will continue to be available along with a new dive show at Shark Canyon.

- For now, the Fish ID touchscreens, Scav-

enger Hunt touchscreens, the Train Experience and the Virtual Reality Sandbox are not available due to their high touch nature and the difficulty in maintaining adequate social distancing during their use.

- No cash payments will be accepted at attractions and restaurants throughout St. Louis Union Station; all major credit cards will be accepted.

### St. Louis Ropes Course and Mirror Maze

The indoor attractions at Union Station also will reopen on June 8. Queue markers will help guests at the St. Louis Ropes Course and the Mirror Maze maintain their distance from each other to at least six feet. Gloves will be offered to guests and the areas will be continuously sanitized throughout the day.

### UNION STATION RESTAURANTS AND RETAIL

The Aquarium gift shop and Wheel retail kiosk will be open but will limit the number of guests allowed inside at any time. Guests will be asked to touch only what they intend to purchase.

No cash payments will be accepted at this time. Plexiglass barriers have been erected to separate guests and team members at Aquarium gift shop checkout counters.

Restaurants Trainshed and 1894 Cafe are expected to reopen to the public at reduced capacity and with enhanced sanitizing and health checks for regular hours on June 8.

Soda Fountain reopened at reduced capacity and with added sanitizing, health checks and social distancing on May 18, 2020.

### THE ST. LOUIS WHEEL

The St. Louis Wheel at Union Station also reopens to the public on Monday, June 8, 2020.

With physical distancing protocols, enhanced sanitizing and extensive team mem-

ber training in place, the St. Louis Wheel will welcome riders with a resumption of regular hours, 10 a.m. to 10 p.m., daily.

The Wheel has been closed in accordance with Missouri and St. Louis City COVID-19 regulations.

### Wheel Safety Protocols Added:

The health and safety of guests and team members is the highest priority of the St. Louis Wheel and St. Louis Union Station. Enhanced safety and sanitizing procedures have been enacted for the Wheel Park reopening, including:

- Team members will wear masks and guests are encouraged to do the same.

- Employees will be screened daily to verify that they do not have fevers or other COVID-19 symptoms.

- Guests will take a survey to confirm their health.

- Signs in the Wheel Park will list COVID-19 symptoms and guests also will be asked to confirm their health statuses in person.

- Pavement markers will be placed to guide guests to stay at least six feet apart to maintain social distancing.

- Gondola loading and unloading cycles will be spaced to allow physical distancing between guests and between cleaning cycles.

- The Wheel's gondolas will be sanitized between groups. Clean Team members will continuously sanitize surfaces on and around the Wheel, in the Wheel Park and at the other attractions.

- All team members will be required to wash and sanitize their hands frequently. Hand sanitizing stations will be in place throughout the Wheel Park.

Effective June 1, Brentwood City Hall is open to the public by appointment only. Please call 314.962.4800 to make an appointment.

Visitors who need to drop off items for Planning & Development or other departments may place the items in the designated bin inside the main entrance to City Hall (the entrance that faces Brentwood Boulevard).

Entry by members of the public into City Hall is by appointment only.

Any member of the public requesting entry to City Hall must fill out the St. Louis County Public Health information sheet and have their temperature taken.

Anyone symptomatic (per the Public Health form) or with a temperature equal to or greater than 100.4 F (38 C) will be denied entry into City Hall.

Anyone granted entry into City Hall will be required to wear a mask and will be offered gloves and asked to use hand sanitizer.

Anyone refusing to adhere to these guidelines will be asked to leave and referred to the Brentwood Police Department.

Public restroom usage at City Hall is at the user's own risk.



## MISSOURI BOTANICAL GARDEN TO REOPEN JUNE 16



The Missouri Botanical Garden plans to reopen to the public on June 16. To continue efforts to prevent the spread of COVID-19, the Garden will implement additional health and safety protocols. The safety of the visitors, volunteers and staff is our top priority.

"We are delighted that we will soon be able to welcome visitors back to the Missouri Botanical Garden," Garden President Peter Wyse Jackson said. "The Garden recognizes the importance of public gardens and outdoor spaces as indispensable to community healing. We are eager to once again have visitors strolling Garden grounds as they take in the fresh air and enjoy the rich diversity of the Garden's plant collections and displays."

To ensure the safety of all, the Garden will implement new procedures, including limiting capacity. 
Garden hours will be 9 a.m. to 4 p.m., Tuesday-Sunday. The Garden is closed Mondays until further notice.

As part of our enhanced safety protocols, visitors will enter and exit Garden grounds through separate one-way paths to allow for safe proper social distancing. Indoor spaces including the Climatron and all conservatories, the Sachs Museum, and Tower Grove House will remain closed. The Children's Garden and water play areas will be closed as well. There will be increased frequency of cleaning and disinfecting throughout the Garden.

With the opening of Schlafly Bankside also comes the reopening of Schlafly Tap Room and Bottleworks for limited service with the following safety protocols in place (schlafly.com/covid-19). Schlafly guidelines include: seating at just 25% of the available capacity with table-only service (no bar seating); credit card payments only for the foreseeable future; all staff members required to wear masks, actively use hand sanitizer upon greeting their tables; routine sanitation and cleanliness measures, following all CDC guidelines and more. Additionally, when ordering a beer, guests have the option for it to be served in glass, plastic, or as packaged beer (bottle or can, if available). Food and packaged beer can also be purchased online for curbside service from all three brewpubs.

In the 16th century, a street by the river was known as a "banke syde," which is where the neighborhood got its name. Now, Schlafly Bankside will call its own neighborhood home in St. Charles.

## Brentwood Plastics Inc. Providing Vital PPE Materials

Plastic sheet film becomes impermeable isolation gowns for healthcare workers; 1.6 million gowns produced in April alone

Brentwood Plastics Inc. (BPI), the Brentwood, Mo.-based manufacturer of custom polyethylene plastic film, is providing flexible plastic sheet film to manufacturers across the U.S. for the production of impermeable isolation gowns for healthcare workers. In April alone more than 1.6 million gowns were made from BPI plastic, and orders are at a similar pace for May.



On March 23, BPI and its employees were recognized by the U.S. Cybersecurity and Infrastructure Security Agency as "workers essential to critical infrastructure during the COVID-19 response."

"Our work with Lockheed Martin is a good example," said BPI President Sam Longstreth, who owns the company with brother Joel, the company's marketing manager. "When Lockheed Martin called, they were not really sure what specific material they needed to make the gowns. At that time, we were very busy with a full truckload order for a legacy customer. We found a roll of what we knew would meet their requirements, and it was put on a plane that night. The film ran perfect on the test run. They then placed an order for enough film to make 110,000 gowns." To date Lockheed Martin has produced more than 200,000 gowns from BPI plastic.

BPI is not new to the healthcare business. For years the company has been providing flexible plastic film for a variety of medical supplies, including ostomy bags, ophthalmic drapes, laparoscopy drapes and more.

"In an industry filled with commodity providers, we're known as problem solvers," added Longstreth. "When a life or death challenge like this comes along, it's gratifying to put our lifetime of experience to work to deliver a solution."


