


### SNEAK PEEK

## Brentwood School District Recognizes Three Eagle Eye for Equity Recipients

The Brentwood School District recently recognized three members of its school community for earning the Eagle Eye for Equity Award. ## MISSOURI BOTANICAL GARDEN ANNOUNCES RETURN OF WHITAKER MUSIC FESTIVAL

Free Wednesday evening concerts take place June 1 to August 3

One of St. Louis' favorite summertime traditions is back as the Whitaker Music Festival returns to the Missouri Botanical Garden this June after a two-year hiatus.

The Whitaker Music Festival offers a 10-week lineup of free Wednesday evening concerts under the stars. Pack a picnic and enjoy the beauty of the Garden grounds in summertime bloom as you listen to the tunes and rhythms of an eclectic rotation of artists from week to week. Live music will begin at 7 p.m. on Wednesdays, June 1 to August 3. Free admission entry begins at 5 p.m. Last entry is at 8:15 p.m. Free admission to the Doris I. Schnuck Children's Garden is available from 5-7 p.m.

New this year: free advance reservations are required for admission to the Whitaker Music Festival. Tickets for the June 1 show will be available on May 11. Tickets for each subsequent concert will be available one week in advance at noon the Thursday before the concert. Maximum of 10 admissions per reservation. Reservations will remain available until the concert's start time or until capacity is reached.

### June 1: Jeremiah Johnson Band

Jeremiah Johnson blends the sounds of the south with Mississippi River blues and a touch of country flair. Emotionally charged southern blues rock, powered by the common man's passion for life, and all the struggles in-between.

### June 8: Karen Choi

Rooted in the Americana tradition, Karen's music explores the common human experience from a rich lyrical perspective. Her newest studio release, "Lost County," leans into the stylistic freedom that the Americana genre has to offer, rich with harmonies, multiple varieties of organ, piano and guitar.

### June 15: Old Souls Revival

Three albums and four stand-alone singles into an already incredible career, Old Souls Revival stands ready to play with the best of them. With their latest series of singles, they are approaching the 21st century with honesty, simplicity, and determination resembling the idols who paved the way for them.

### June 22: Annie and the Fur Trappers

Annie and the Fur Trappers are an energetic traditional jazz and blues band that currently includes clarinet, trumpet, trombone, tuba, piano, banjo, and washboard. Annie and the Fur Trappers is dedicated to performing and preserving the music of the 1920s and 30s today. The band plays traditional jazz, delta blues, ragtime, and swing music.

### June 29: Arcadia Dance Orchestra

The Arcadia Dance Orchestra is an 11-piece band led by bandleader T.J. Muller. Named after the once famous Arcadia Ballroom ("On Olive, near Grand"), The Arcadia Dance Orchestra specializes in recreating the music of St. Louis' 'Roaring Twenties.'

### July 6: We Are Root Mod

We Are Root Mod brings inspiration through their soulful hip hop and funk inspired music, known for its grooving, cultured and gospel-infused sounds. The band comprises members who are all family that grew up playing music together in church.

### July 13: Sweetie & the Toothaches

Specializing in 1940s through 1960s R&B, Jump Blues and Blues Ballads, Sweetie & the Toothaches will have you stomping your feet and shaking your hips. Be prepared to sink your teeth into this hot jump blues band's personal brand of fresh smoked rhythms, sweet & salty harmonies and lip smackin' solos.

### July 20: Mo Egeston All-Stars

Maurice "Mo" Egeston is a pianist, band leader and educator. The All-Stars have developed a unique sound around Egeston's originals and vocal arrangements, influenced equally by traditional jazz improvisation, modern soul, Latin grooves, electronic music and studio style production.

### July 27: The Soulard Blues Band

Formed in 1978, the Soulard Blues Band (SBB) has worked steady at the Blues for more than 40 years. The SBB has produced ten CDs, including "Live in Stuttgart" which was recorded when the band was invited to play in St. Louis' sister city, Stuttgart, Germany for their "one hundred years' celebration."

### August 3: Old Salt Union

Old Salt Union is a string band founded by a horticulturist, cultivated by classically trained musicians, and fueled by a vocalist/bass player who is also a hip-hop producer with a fondness for the Four Freshmen. It is this collision of styles and musical vocabularies that informs their fresh approach to bluegrass and gives them an electric live performance vibe.

Whitaker Music Festival concerts will be held outdoors on the lawn of the Cohen Amphitheater, just west of the Climator dome on the grounds of the Missouri Botanical Garden. Guests are encouraged to bring lawn chairs or blankets.

The concert series is the only time of year when picnicking is allowed on Garden grounds. Visitors are welcome to bring their own picnic supper, baskets or coolers; no barbecue grills, fireworks, sparklers or pets. No glass bottles or firearms are allowed on Garden grounds. Security bag checks will take place at each entry location.

Free entry for those with advance reservations begins at 5 p.m. on each performance evening. Last entry is at 8:15 p.m. Live music begins at 7 p.m. Free admission to the Doris I. Schnuck Children's Garden available from 5-7 p.m. (advance reservations not required for Children's Garden entry.)

### Set up for success from the start

Getting pre-approved will make the whole process go more smoothly and make your offer more desirable to a seller. There are a few things that can affect pre-approval like your credit score, employment history and income, assets, and current debt-to-income ratio. Once your loan information is approved, you will receive a pre-approval letter that is good for 90 days.

If your credit report shows that you do not have a good credit history, talk to your lender. Not all credit issues will keep you from being pre-approved. Your lender can give you suggestions on how to re-establish credit. It is important to keep in mind, though, that adverse credit information may affect your interest rate.

### Finding an agent



### Pictorial St. Louis A Topographical Survey Drawn in Perspective A.D. 1875

This is a reprint of the 1971 version of the original book. The book was painstakingly scanned from the original in my collection. Each page is reproduced in high resolution and coil bound so the pages lay flat while viewing. Printed on 12" x 18" high quality acid free paper. A nice edition to your historical book collection. Perfect coffee table book as people are attracted by the cover art.

PICTORIAL ST. LOUIS: The Great Metropolis of the Mississippi Valley A Topographical Survey, Drawn From Perspective 1875.

Illustrations by Camille N. Dry and designed & edited by Rich. J. Compton.

Over 220 pages of illustrations and descriptions of life in St. Louis in the late 1800's. The preliminary drawings for this work were made early in the spring of 1874. After a careful consideration of the subject, it was determined to locate the point of view so that the city would be seen from the southeast, believing that to be the most advantageous in all respects. Accordingly, the point of site was established on the Illinois side of the river, looking to the northwest, and at sufficient altitude to overlook the roofs of ordinary houses into the streets.

A careful perspective, which required a surface of three hundred square feet, was then erected from a correct survey of the city, extending northward from Arsenal Island to the Water Works, a distance of about ten miles, on the river front; and from the Insane Asylum on the southwest to the Cemeteries on the northwest.

Every foot of the vast territory within these limits has been carefully examined and topographically drawn in perspective, by Mr. C. N. Dry and his assistants, and the faithfulness and accuracy with which this work has been done an examination of the pages will attest. Absolute truth and accuracy in the representation of the territory has been the standard and in no cases have additions or alterations been made unless the same were actually in course of construction. In a few cases, important public and private edifices that are not yet finished are shown completed, and as they will appear when done.

All the buildings within the limits of the survey in July, 1875, are shown; and a very large number of those executed or commenced since that date have been also introduced, the pages having been constantly corrected up to the last possible moment before publication.

The group was originally based in Springfield, Missouri. Their acclaimed 1973 debut album, recorded in London under the direction of producer Glyn Johns, contained the U.S. Top 30 single "If You Wanna Get To Heaven," while a second success, "Jackie Blue," came from the band's follow-up collection, "It'll Shine When It Shines." A 1978 release, "It's Alive," fulfilled the band's obligation to A&M Records and two years later they made their debut on CBS Records with new members Buddy Emmons and Rune Walle as part of the line-up.

Following a brief hiatus, OMD were reactivated in the late 1980s by Dillon, Cash and Granda, with Steve Canaday (drums/guitar/vocals) and D. Clinton Thompson (guitar). The resulting album, "Modern History," found OMD with a new lease on life. The band carried on into the millennium with a new line-up featuring Dillon, Cash, Granda, Ron Grep (drums) and Bill Brown (guitar/vocals). In 1997 the group recorded and released their first album in many years titled "13."

In 2000, an effort was begun to reissue all of their works. "Time Warp: The Very Best Of The Ozark Mountain Daredevils," is a 21 track compilation from all of the A&M studio albums. Following that was a concentrated effort by New Era Productions to accomplish the long-awaited reissue of their individual A&M albums "It'll Shine When It Shines," "The Car Over The Lake Album," "Men From Earth," "It's Alive" and "Don't Look Down." The CBS (Columbia) self-titled album "Ozark Mountain Daredevils" was released in November 2005, thus completing the reissue series of A&M and CBS recordings. 

City Attorney O’Keefe did the first Reading of the Bill.

Information was presented by the Director of Planning and Development, Whitney Kelly, who shared that the applicant is seeking an addition to the existing building (a second story) and requesting a text amendment for a conditional use permit. Sarah Javier, President and CEO of Animal Protective Association of MO, spoke stating that they are an animal adoption agency that has been in Brentwood since 1947. She shared a power point presentation showing the building that was built in 1947 and the need for updates to the facility to provide better care for the animals and also the employees. She shared statistics and historical data along with project needs. They provide a great service to the community – 108 volunteers from our community and over 1000 residents have adopted from the APA.

They have raised several million dollars for this project to complete the work that needs to be done.

Tracy Pupillo, legal counsel for applicant spoke. The APA is a legal non-conforming use, and it needs to be a conditional or permitted use to make the renovations. The ordinance would modify the urban district regulations to allow as a conditional use animal rescue, shelter and adoption services which provides custodial veterinary care for domestic animal pets, and pet owner resources, support and educational programs but not including farm, exotic, or other wild animals not normally kept as household pets. This use is consistent with the comprehensive plan and provides valuable public service. Use is also consistent with surrounding districts.

They respectfully request Board approval of this ordinance allowing for the text amendment. Also asked to enter into the record the City’s comprehensive plan Municipal Code Section 400.1400, 400.1370, 400.1380, 400.1390, and the proposed ordinance.

Alderman Plufka clarified that what is before them tonight is only the text amendment – not an application for conditional use or zoning variance. Director Kelly is still reviewing whether a variance is needed or not. The text amendment has to go first to review for the CUP. If no variance needed, it is tentatively scheduled for the May meeting.

Alderman Lochmoeller asked why they did not seek a rezoning of the parcel as opposed to a text amendment?

Director Kelly responded that the property was rezoned in 2017 for the hotel use and for various reasons don’t want to go back. It was also noted that the plan failed in 2017 as a permitted use but Planning and Zoning unanimously approved the plan this time.

Resolution No. 1351 - A Resolution Approving a Change Order to the Contract with HOF Construction Inc, for Additional Work Needed for the Brentwood Park Pavilion and Event Lawn Project

Director Gruenfelder and Craig Schluter with Navigate Building Solutions presented this information stating that during MSD’s final site review, they indicated that the site utilities cannot run underneath the parking lot. The change order is to move all the utilities that were under the parking lot. Design cost is covered. This is only a construction cost. Moving the utilities that may go under the trail path is not a cause for concern.

Motion was made by Alderman Gould and seconded by Alderwoman Tice to approve Resolution 1351. No further discussion, Roll was called:

### Manchester Road Construction: Summer 2022 Closure

Black Creek Bridge on Manchester Road (just west of the intersection with Hanley Road) closed on **May 2 and will remain fully closed through August 2022.**

This full roadway closure will prevent traffic from going west from Hanley Road to Manchester Road. The closure also will prevent traffic from going east on Manchester Road to Hanley Road.




# INSIDE BASEBALL

## A dozen years after being drafted by Cardinals, Seth Blair is still pitching, working to make major-league dreams come true

It would have been so easy for Seth Blair to quit, to just give up and concede that his career in baseball wasn't going to work out the way it had played out in his childhood dreams, and move on with his life.

A supplemental first-round pick of the Cardinals in 2010, after a stellar career pitching at Arizona State, it seemed back then that Blair was on a direct path headed to the major leagues.

The journey took a different direction, however. A dozen years later, Blair is still trying to reach his destination. His story includes being released by the Cardinals in 2015, going through the mental, emotional and physical challenges of being out of professional baseball for four years, and spending the Covid summer of 2020 pitching on a mound in the backyard.

All along the way, however, there was one constant: Blair's dream never died.

"It was always just this feeling I had as a little boy that I wanted to be a major-league baseball player," Blair said. "There was like this deep-rooted belief that for whatever reason never went away."

If Blair, as a 21-year-old, had been told everything that would happen to him over the next 12 years, "I don't know if he would have believed it," Blair said.

"If you had told a 21-year-old that he would miss four full years of baseball, I think when you are young, the thought of that sounds like too much to overcome," Blair said. "I'm just super grateful to wake up and know that all of the experiences I've had have kind of built the character into me to look forward to the next challenge. Ultimately it never really stops."

"There are times you feel like you have been through hard stuff and then you realize you are still not where you want to be. You stop feeling sorry for yourself and you're like, 'It doesn't matter how far I've come until I actually get to where I want to be.'"

Blair's journey has led him to Durham, N.C., where he is a 33-year-old sidearm reliever on the Durham Bulls, the Triple A affiliate of the Tampa Bay Rays.

He is now a phone call away from the major leagues. Blair says he tries to live in the present and not think about all of the different events that could have derailed his journey, and ended his dreams, somewhere along the way.

"There's a lot of things that have happened on and off the field that are experiences I've had to learn from and grow from," Blair said. "I feel like I just continuously try to live in the moment and keep going, and hopefully will end up where I want to be, which is in the big leagues."

### The first detour

The first detour on Blair's road to the majors came on April 30, 2015.

Blair was at the Cardinals' complex in Jupiter, Fla., rehabbing his right shoulder, when he was told that he was being released.

"It came as a complete surprise," Blair said. "I was such a young naïve kid that I didn't think you could even get released while you were in rehab. I don't remember exactly what was said but it was along the lines that it was a numbers thing. I can't remember them saying anything more than that."

Blair had reached Triple A Memphis for about a month in 2014, making six relief appearances, but his four years pitching in the organization overall were disappointing for him as well as the Cardinals after he was ranked as the eighth best prospect in the farm system by Baseball America before



his first pro appearance in 2011.

He made 84 appearances in the system, including 60 starts, and had a career record of 15-22.

"I was frustrated with myself for not being able to do what I thought I could do," Blair said. "I had the yips. It wasn't like the worst version of it, but it was a small version of that and it ended up causing me to throw with restrictions. Over time it started making my body hurt."

Blair spent all of 2013 and most of 2014 at Double A Springfield, where Mike Shildt was the manager.

"I always had respect for Seth because he was a tremendous worker and was a really, really strong competitor," Shildt said. "I always appreciated how he competed and how strong his desire was, which is clearly still a part of him."

"He was always battling the ability to repeat quality pitches. A lot of guys have trouble with that in the minors, but in his case, he was battling trusting his ability to throw consistent pitches where he wanted to. He was working, he was trying to figure it out. I admired his tenacity."

In 2014, Blair struck out 48 batters at Springfield – but issued 51 walks.

The Cardinals decided they couldn't wait any longer for Blair to overcome that issue. Still, his competitive nature and tenacity was on display the day he was released.

"When I left the field (after getting the news) I was like, 'No big deal,'" Blair said. "Somebody will pick me up and I will sign with them and be back playing this year. I was like, 'Maybe they are doing me a favor. Maybe I'm not meant to be here in the Cardinals' organization. I will get healthy somewhere else and start playing.'"

Blair returned home to Arizona, continued his rehab, and soon realized his expectation that he would get healthy and quickly sign with another team wasn't happening. Months turned into a year; one year turned into two.

His girlfriend, then and now, Abby McGuire, saw what was happening.

"It was very hard," said McGuire, a native of St. Louis who met Blair when he was pitching in Springfield. "He shut the world down for a couple of years. He was in a pretty dark place emotionally."

Friends and family kept encouraging Blair to keep going, but he knew his shoulder was hurt. He just didn't know what was wrong. It took close to two years of training and rehabbing before he finally felt healthy enough to think about trying to play baseball again.

"There were times where you were like, 'I don't know why I am even thinking about baseball. I'm not even close to playing right now,'" Blair said.

Said McGuire, "We all encouraged him to keep trying and go for it again and he was always like, 'I'm not ready yet. I will let you know when I'm ready.'"

"I remember the entire time I never felt like baseball was out of our lives. It was still there, no matter what. None of us cared if he worked part-time, just to make sure he could train. We told him, 'Don't give up.'"

In addition to being physically ready to pitch again, Blair knew he also had to be emotionally ready. He was dealing with a child custody case involving his son, Beckham, that wasn't easy.

While training in a local gym, he met and became friends with Jordan Pacheco, who spent six years in the majors, mostly with the Rockies. Pacheco also was rehabbing an injury at the time.

"We were together every morning," said Pacheco, now the hitting coach for the Rockies' Triple A team in Albuquerque. "When you find somebody who will hold you accountable, you just kind of stay with them. We did that."

Pacheco saw Blair decide to take the first steps in his return to baseball, beginning to pitch in sporadic games with a team in an adult men's league, the Denver Royals.

His journey took another turn during a game he was pitching for the Royals in the fall of 2018.

"I was getting hit, facing a good team, and I ended up telling the coach after the third inning that I didn't want to play anymore," Blair said. "I said, 'I'm done. I'm good. I'm over it. I can't do this anymore.'"

"He said, 'I will give you \$1,000 if we win this game.' At that point I didn't have any way of making \$1,000 that easily. I said to myself that no matter how I feel I have to buckle up and figure out a way to finish this game. I ended up throwing harder at the end of the game than at the beginning. It kind

of propelled me into the next level of whatever was to be. That was really a big turning point through the journey of my time off.

"I found that real deep competition mode that allowed me to feel more like my childhood self. When that feeling came, I was like, 'Ooh, I want more of that.' It was financially motivated but ended up teaching me a lesson much deeper than money."

The Royals won the game. Blair got the promised payment. He doesn't remember what he did to celebrate, but said it probably included a post-game meal at In-N-Out.

It was time to see where the journey was going to take him next.

"What I've come to realize is that you never really know when you are ready," Blair said. "I had just been doing it for so long, and it gets to the point where you are 30 years old and you need to test yourself to see if it's something you are going to be able to do or if you need to move on with your life."

### The next steps on the comeback trail

The test came in the summer of 2019. Blair posted a video on the Internet, which found its way to MLB Network's Harold Reynolds, who called and offered to help.

"It was like three days later, I threw for the Padres and they signed me," Blair said. "It was kind of surreal. I wasn't really expecting to play, I was just trying to get ready for another adult league experience."

Blair was sent to the Padres' Class A team in the California League, a 30-year-old competing against much younger players. He pitched in 17 games, which was enough to come to another realization.

"I enjoyed the competition the most," he said. "That was the thing that really hit me. I enjoyed it. I felt like I could control my emotions better than when I was with the Cardinals."

Even when Blair was released by the Padres, he now had even more support and encouragement from family and friends to keep going. He asked his brother to pay to build a pitching mound in his backyard in early 2020. Two weeks later, the pandemic shut down the world – but not Blair's backyard.

"Nobody had any place to go because all of the facilities were closed," Blair said. "All the guys I had played with in the past and anyone I knew started coming over to my backyard."

Two of those friends were Pacheco and Cubs pitcher Danny Hultzen, who became a big part of Blair's support group.


"We had some awesome conversations about basically everything," said Hultzen, who had his own long journey through the minors before making it to the Cubs, where he now works as a major-league pitching strategist.

"He and I kind of related over the mental part of the game, the challenges that come along the way and everything that baseball brings; dealing with pressure, outside influences that get in your head and take you away from just playing baseball."

"That was one of the beautiful things about being in that backyard all the time. It was just baseball. For all of the terrible things that were going on, it was a refreshing time in both of our lives to kind of settle down and rethink about what was important to us and why we play the game and why we love it so much."

Pacheco also was part of those conversations, and a big part of those who kept encouraging Blair to keep going, to keep trying.

"I know just being able to watch him taught me a lot about the game of baseball and a lot about life," Pacheco said. "You don't just give up on things that you love. It's a testament to everything. You don't give up on your family, you don't give up on yourself, you don't give up on anything that you love."

McGuire was there too, and she saw a change in Blair over those few months.

“Everyone’s life slowed down a little bit at the same time,” she said, because of Covid. “When he was in that dark time, no one else’s lives were slowing down it felt like except his. Now he felt like, ‘I have time. I’m not working from behind anymore. Baseball has kind of paused. I can try to catch up and come back.’ Working around those guys motivated him.”

As part of their workout routine, the group – mostly pitchers – often went to a nearby park in Scottsdale to take groundballs. One particular day, Blair was playing shortstop, with Hultzen at first base, when the next big step in Blair’s journey occurred – by accident.

“There was a slow roller and he charged it and picked it up, fielding it clean, and threw it underhand,” Hultzen said. “It was just as hard, maybe harder, than any ball he threw overhand. It kind of caught me off guard and I said, ‘Dude that was kind of cheezy.’ He just kind of looked at me.

“Then he did a couple more, and started to mess around with it. He was throwing 96 to 100 from down there. It was completely by accident. It wasn’t on purpose. I was like, ‘Holy moly, there’s something there.’”

With the minor-league season canceled, Blair set his sights on signing with a team that would let him go to their alternate site camp. He got offers from the Red Sox and Rays and picked Boston because they gave him a two-year deal.

“All the guys who came through that backyard were able to see what he could do,” Hultzen said. “It was the opposite of ‘don’t try.’ It was like, ‘Dude you should be in the major leagues. You should be living your dream. You have to do this.’ It was insanely encouraging and very powerful to see how he went about his business and how he approached everything with passion and drive. It was an incredible environment for us to be in.

“The guy signed a professional baseball contract throwing baseballs in his backyard. That’s something I will never forget. It was one of the most impressive things I’ve ever been around.”

Pacheco was impressed too – but he also wasn’t surprised. “When you believe in yourself that much and you don’t catch some breaks along the way, you just know, ‘I still have it in the tank and I can still do it,’” Pacheco said. “That’s what he believed. He’s an unbelievable athlete with an unbelievable arm and an unbelievable mind.

“He found a way to keep getting better. He learned more about himself and made himself a better baseball player. I’ve seen him evolve as a person too ... He’s an easy guy to root for.”



**Getting closer to his destination**

Blair split the 2021 season between Double A and Triple A with the Red Sox, pitching in 32 games. The passion that was fueling his comeback was now being boosted by another source as well – his son.

“Getting to see him start his baseball journey kind of really lets you be innocent toward the game,” Blair said. “You kind of acknowledge that it really is just a game. That’s what makes it so fun, and why we love it so much. The competition, the camaraderie among teammates, that’s something you take for granted as a kid but as you get older, if you ever have a time where you don’t get to have it, you miss it.”

Before this season, Blair sent a text message that included data from a bullpen session to the Rays, who still had their reports on him from 2020. Within a couple of hours Blair had a contract offer, including an invitation to the major-league spring training camp.

“They said they wanted to give me an opportunity,” Blair said.

As he has gone through the first few weeks of this season, Blair has become even more aware of all the steps he has taken on his journey – and of all the people who have gone along on the ride with him.

“I think a lot of times people don’t realize how many people around you have helped you get where you are,” he said. “One thing I am super grateful for is the supporting cast I’ve had throughout my journey. The people who were the closest to me – my family, my girlfriend, my friends – they were all supporting me.

“There could have been many times when they could have said, ‘Hey you need to stop ... this isn’t worth doing.’ That never happened. No one ever said that to me. They were always supporting me and believed in me. That’s a huge reason

why I’m where I am right now.”

Blair also believes he has been assisted by another source.

“I don’t really have any way to describe it, but I just always feel like there’s been a higher power that’s guided me throughout this entire process,” he said. “That’s kind of given me the strength to have the belief that keeps you doing things in the face of adversity.


“When other worldly thoughts want to derail you from becoming who you want to become for some reason, I’ve found the strength to try to keep going. It’s definitely felt like there was a higher power on my side.”

Hultzen and Pacheco both use the word “when” instead of “if” about Blair finally being able to realize his dreams of making it to the majors.

They both know that had Blair stopped at any point during the last seven years, there would have always been a feeling of regret – that he didn’t work hard enough, that he gave up too soon.

“If,” as in, “what if I had done this, or what if I had done that,” is a powerful word, Hultzen said.

“One of the things that we’ve talked about at length is the knowledge that you did everything within your absolute worldly power to achieve your dream,” Hultzen said. “You can live with the results. We want the results to be pitching in the big leagues ... When he makes it, it will be one of the most special moments in my life. I think everybody feels that way who has been around Seth.”



Pacheco certainly shares that opinion.

“Everybody has a different journey, especially to get to the big leagues,” he said. “You never know what the game can bring if you just keep going ... He’s doing it for himself, but also to show his son that you don’t give up on things and you don’t quit because some things don’t go your way. That’s a testament to who he is as a person.

“Selfishly I would be ecstatic when it happens. I know all the work he’s put in. I will probably cry a little bit for sure.”

Blair might be even happier for all of the people around him than he will be for himself when – not if – that day comes.

“There were probably people saying that I shouldn’t do it, but I didn’t really know who those people were,” he said. “Maybe the people closest to me felt that way, but they just didn’t say it to me. I never felt like I had haters. I just felt I had a bunch of people supporting me, always trying to lift me up ... The appreciation that I will have will be on another level. “It’s definitely been an interesting journey.”

The new lineup started April 4, ahead of KSHE marking its 55th anniversary as a rock station on Nov. 7, 2022.



**Brentwood Bound Construction Progress**

**Manchester Road Closure: May Through August 2022**  
 Black Creek Bridge on Manchester Road (just west of the intersection with Hanley Road) will close on May 2 and remain fully closed through August 2022.

This full roadway closure will prevent traffic from going west from Hanley Road to Manchester Road. The closure also will prevent traffic from going east on Manchester Road to Hanley Road.

Throughout the closure, vehicles will still be able to access businesses and residences along the Manchester Road corridor from Brentwood Boulevard.

During the same time, work will take place on the pedestrian tunnel near Mary Avenue. This work will reduce Manchester Road traffic to one lane in each travel direction.

**Knox HomeBox Loan Program**  
 The Brentwood Fire Department offers a 90-day Knox HomeBox loan program for residents who have a temporary special need or physical disability preventing them from opening their front door to Brentwood fire and medical personnel in event of an emergency. Call 314.963.8612.

**MAGIC Bus**

**From Brentwood Fire Department: It's OK to Call 911**  
 The Brentwood Fire Department staff enjoys speaking with residents, but there are times when it is best to call and speak with the 911 dispatchers. Instead of calling the fire station to report instances of someone injured or not feeling well, powerlines down, smell of smoke in a home, fire alarms "beeping" or activated, calling 911 is the best option.

Area 911 dispatchers are trained to quickly determine the severity of a reported situation and to direct the closest and most appropriate resource to manage these situations, whether help is needed quickly or not. **It is OK to call 911.** Fire and medical units regularly train away from the firehouse or can be away helping others and would be unavailable to answer the phone. Rather than calling the Brentwood firehouse for help, save precious time and call 911 to report an emergency or request for service.

**Be Warned About the Weather: CodeRED Notification System Weather Warning Alert Option**  
 Brentwood's CodeRED Community Notification System includes CodeRED Weather Warning, which provides residents and businesses with automated severe weather alerts. Those who choose to opt in to this service will receive flash flood, tornado and severe thunderstorm warnings just moments after an alert has been issued by the National Weather Service.

Residents and businesses who have already signed up for Brentwood CodeRED notifications and wish to activate the Weather Warning Alert options will need to register for CodeRED again. To activate these severe weather warnings, click on the "Brentwood CodeRED" icon on the home page of [brentwoodmo.org](http://brentwoodmo.org) or text WARMME to 99411 from your mobile phone. **There is no charge to residents or businesses for this service.**

Residents and businesses who have not previously signed up for CodeRED notifications may do so at any time by clicking on the "Brentwood CodeRED" icon on the home page of [brentwoodmo.org](http://brentwoodmo.org).

The City of Brentwood will continue to send other public safety notifications, such as road closures or specific emergency situations, through the CodeRED system. The City of Brentwood CodeRED Assistance Line is 314.963.6710. Please leave your name and phone number, and a staff member will return your call as soon as possible.

**Report a Concern, Make a Request**  
 Make requests (such as vacation checks or household item pick-ups) or submit concerns through the MyGov request-tracking system via the home page of [brentwoodmo.org](http://brentwoodmo.org). Click on the "Report a Concern" button, choose a category and submit your request. You'll receive feedback when the request is received and also will receive updates as the request is investigated by City staff.

**Reminders to Homeowners**  
 Brentwood homeowners are responsible for mowing and maintaining the area between the street and the sidewalk along their property. Overhanging brush, overhanging tree limbs and high weeds need to be cut back to ensure a clear and safe passage along the sidewalk, per Municipal Code sections 505.070 and 505.090.

Brentwood's Municipal Code also prohibits short-term rentals.

## Our Favorite Italian Restaurant Re-visited

Serving great food and with great service in a comfortable and pleasant atmosphere is what makes Erio's Ristorante such a popular dining spot in the St. Peters-St. Charles area.

Erio's is a small, friendly restaurant that was owned and operated by Pietro (Pete) Pulizzi and his wife, Joan.

Pete arrived in the St. Louis area from Sicily in 1960 and in 1970 opened his first restaurant in Florissant. In 1991, Pete and Joan relocated the restaurant to St. Peters.

Their menu offers a large variety of delicious pastas, hand cut steaks, chicken, veal, seafood and, of course, their hand tossed pizzas. All food is cooked to order. Pete prided himself in using the highest quality and freshest ingredients. You'll find a special menu for the children and you'll want to be sure to save room for dessert. homemade creations include New York Style Cheesecake and Murder by Chocolate Cake (a rich flour-less cake).

Although Erio's has no separate bar, they do offer full liquor service - Mixed drinks, cocktails, wines (by the bottle, carafe, or glass) and beer.

During the past two years we have seriously curtailed our restaurant dining due to Covid. But as we have rejoined the living, we were joined by fellow radio personality, Casey Van Allen, and his wife Stephanie. Casey first introduced me to Erio's in St. Peters. Pete and his wife, Joan were the perfect host's and great friends.

When Pete decided to retire, he sold the restaurant to his long time protege. Joe Creech. No, he is not Italian, but he served an attentive tutelage at the the feet of the Master/. He began his culinary career as a dishwasher at Erio's, then a waiter and sous chef. And finally owner/

For almost 15 years, Joseph, "Joe" Creech, ( he was our favorite waiter) 33, learned the business at the owner's side. Joe said "I worked at Erio's all through college and real estate school, but I just really felt that the restaurant is where I wanted to be."

To maintain the family operation of a great restaurant, Joe shares the duties with his brother and four other siblings. This means that the transition of ownership has never missed a step.

While the business may be under new management, it is still the same Erio's that customers have come to know and love with a few more offerings such as lunch on Fridays and Saturdays.

"We make everything fresh," says Joe. "Our seafood is fresh. We cut our own chicken, and we do everything the old-fashioned way."

We were very satisfied with our dining experience at Erio's. We began with a shered platter if calamari, flash fried with fresh lemon and spices. It was an exquisite beginning to a wonderful dining experience.

Sue had the tilapia dinner with a side of tortellini pasta. The fish was perfection with a caper butter dressing and the tortellini is amazing, a meat filled pasta in a cream sauce with peas and prosciutto. It is definitely the best I have ever had, even in Italy.

I began with a house salad with anchovies. My main course was a seafood linguine in a clear clam sauce. Fresh ocean clams, scallops and gulf shrimp served with mushrooms, fresh tomatoes and garlic tossed with linguine noodles. This is a perfect combination of culinary delights.



Our friends had a Chicken Marsala with a side of pasta with a red sauce. Again, and as always, another great Erio's entree.

We finished off with a lemon-cello ice. It was the perfect pallet cleanser and dessert for another wonderful dining experience at Erio's Ristoranti in St. Peters.

If you enjoy great Italian dining, there is no reason to go to "The Hill". Come to St. Peters and enjoy the real deal!

## St. Louis Area Diaper Bank Presents Fantastic Father's Benefit Concert

The St. Louis Area Diaper Bank will host its Fantastic Father's Benefit Concert on Thurs., June 16 from 6 to 8 p.m. The fundraiser will be held at Scene Event Space located at 3333 Washington Ave. Tickets start at \$60 per person, and proceeds will benefit the nonprofit's diaper program.



The concert will feature jazz vocalist Denise Thimes, whose multi-faceted career has spanned nearly three decades. The native St. Louisan has performed with such jazz notables as Wynton Marsalis and the Jazz at Lincoln Center Orchestra, the late Clark Terry, Dr. Billy Taylor, Earl May and many more. Thimes has more recently appeared and toured Paris with David Sanborn, sung for the Queen of Thailand, Queen Elizabeth, President George W. Bush, and was hand-picked by Aretha Franklin to perform at her 72nd birthday celebration.

The St. Louis Area Diaper Bank collects, stores, and distributes 250,000 free diapers per month to struggling families through a network of 56 community, nonprofit, educational and health care partners serving low-income women and children. To date more than eight million diapers have been distributed in St. Louis including nearly 900,000 diapers during the height of the pandemic.

The Diaper Bank also has a period supply program that collaborates with the Alliance for Period Supplies to ensure access to menstrual hygiene products. The program distributes period supplies through community partners, as well as advocates for the elimination of "period poverty." To date more than 450,000 period supplies have been distributed in St. Louis, with 10,800 period supplies allocated each week. Last year two-thirds of low-income women in St. Louis could not afford menstrual hygiene products, with 46% of low-income women having to choose between food and period supplies.

Founded in 2014, the St. Louis Area Diaper Bank provides diaper access to the region's low-income families, as well as raises community awareness about the causes and consequences of diaper need. The nonprofit is a member of the National Diaper Bank Network, a nationwide nonprofit dedicated to eliminating diaper need and "period poverty" in America. The St. Louis Alliance for Period Supplies (STL APS) – a program created in 2019 by the diaper bank – ensures access to menstrual hygiene products, which allows full participation in daily life with dignity.



## 2022 Explore Missouri's German Heritage

Kevin and I were invited to attend an event put on by Missouri Life magazine's, "German Heritage Video Premiere" held at Stone Hill Winery in Hermann, MO.

The book, Explore Missouri's German Heritage, by author W. Arthur Mehrhoff, tells the story of Germany settling in the Rhineland area along the Missouri River. The town of Hermann was founded and platted in 1837. The city's main street is ten feet wider than Market St. in Philadelphia. The new town was named after a legendary tribal leader, Hermann der Cherusker. Currently more than 80 blocks of Hermann are listed on the National Register of Historic Places. There are more than 130 wineries along the weinstrasse.


In 1965, Jim and Betty Held with their four young children purchased the original winery and began restoration of the property. The old-world buildings had vaulted underground cellars. Stone Hill became the second largest winery in the United States and are world renowned; they won gold medals in eight world's fairs and by the 1870's the winery was shipping 1,250,000 gallons of wine per year. With a brief hiatus during prohibition the wine cellars became known for raising mushrooms. After 1965 the labyrinth of arched underground cellars were returned to putting Stone Hill back on the map as a world-class wine producing area. Throughout the next 50 years they again gained recognition as Missouri's oldest and most awarded winery. Stone Hill's yearly wine production is approximately 300,000 gallons of wine and they are once again receiving international acclaim...and no more mushrooms.

The Missouri Norton is the state's official state grape. Visitor's can take a free tour of the cellars with a tour guide and tastings are available for a small price. The carriage house and the barn stalls have been restored and turned in to the Vintage Restaurant.

There are over 200 B&B's and we stayed at the Harbor Haus.
