**ANNOUNCEMENTS, APPOINTMENTS, PROCLAMATIONS & RECOGNITIONS**  
**Presentation by Open Space Council**

David Wilson, President of the Board of the St. Louis Regional Open Space Council was present to share the focus and mission of water quality for the Open Space Council. He introduced Bonnie Harper, Executive Director, who presented the City with a \$50,000 cash gift toward the purchase of the Bi-State property at 3000 S. Brentwood Blvd. and Marshall for the remnant wetland in partnership with the Deer Creek watershed Alliance and the Mo Dept. of Conservation, for open space land that will protect Deer Creek and the water quality of Deer Creek. They will continue to have partners on this project with us in the future for restoration of plants and maintenance. She gave special recognition to the Robert J. Trueledge, Jr. Family Foundation that helped make this gift possible through the Open Space Council.

Appointment of a New Brentwood School District Board of Education Representative to the Brentwood Redevelopment Corporation

Mayor Dimmitt shared that Keith Rabenberg has decided to step down from the Redevelopment Corporation- 353, leaving a vacancy on this Board. He noted the City’s appreciation for his service. The school Board recommended Keith Slusser to fill the vacancy.

Motion was made by Steve Lochmoeller and seconded by Alderman Plufka to approve the appointment of Keith Slusser to the Brentwood Redevelopment Corp. Board.

Motion carried by unanimous voice vote.

**Public Hearing 2022 Property Tax Rates**

Mayor Dimmitt gavel opened the public hearing. No one addressed the Board on this matter. The mayor then gavel closed the hearing.

**CITIZEN COMMENTS**

The Mayor shared that tonight we are only looking to approve an applicant as a master developer, and that we are not voting on incentives or what the development may look like. This is just an appointment of a master developer and that any negotiation on an agreement will come back before the Board for review and discussion.

Both Jamie Allen, School Board Member, and Lindsay Spencer, School Board President, were present representing the Brentwood School District, stating that the Board of Education is in favor of redevelopment and proposal. The schools have the capacity to bring on additional students, so they are looking forward to the added tax revenue. They are supportive of Green Street as a partner. The School Board operates on a 5-10 year operating plan, and they are concerned about the next 5-10 year impact. They welcome an opportunity to be engaged on this project.

**OLD BUSINESS**

Resolution No. 1382 - Greenstreet Real Estate Ventures - Manchester Road Redevelopment Area - A Resolution Selecting Green Street Real Estate Ventures, LLC As Preferred Developer For Redevelopment Of An Area Along Manchester Road Between Mary Avenue On The West And Hanley Road On The East; Authorizing The Execution Of A Preliminary Funding Agreement; And Authorizing City Staff To Negotiate A Redevelopment Agreement For Consideration By The Board Of Aldermen.

Motion was made by Alderman Shelton and seconded by Alderwoman O’Neill to approve Resolution NO. 1382.

Alderman Wegge asked if Green Street will start engaging businesses now or wait until there is a negotiated development agreement? Joel stated that if selected, they can do whatever we want – but would typically wait until there is an agreement, but they will be proactive when time to reach out.

Alderman Lochmoeller stated that he is in favor of Green Street and the fact that they are a local developer and will stick around to maintain it and be members of our community.

Alderman Plufka echoes this, stating that redevelopment cannot continue as before so a decision for a comprehensive developer instead of piece-meal development is favorable. He is in favor of giving them a try to make a plan with greater potential for the area. He noted that in Wisconsin they did not give up and kept working to put a plan together that the community accepted and was approved.

Alderwoman Tice noted they are developing lots of properties and asked what is our assurance that we get the “A” Team for our project? Joel responded that they will not over promise or under

perform. They are intentional in assembling the best development team in the region and partnering if needed.

Alderwoman Sims stated she is in support of the Resolution as well. She noted that we dialogued with 42 developers and Green Street responded to our proposal. She looks forward to working with them.

Alderman Shelton also shared his support. He is confident we can work with them and looks forward to what they can do and what they have done in re-vamping St. Louis – while still listening to our citizens.

Alderman Gould stated that the city has taken on bold, visionary objectives and we have done things the right way – not the easy or cheap way. And we will look at this project in the same way. He has confidence that Green Street will listen to the community and make adjustments. He reminded that this is a concept plan and asked Joel to speak to their modification process.

Joel shared that they truly followed the RFP and were responsive to the project. They feel they have a good partner with PGAV and will work collaboratively. Needs are changing since 2020 when the RFP was put out and they can be responsive once there is an agreement.

Alderman Gould noted this is a critical point of preparation and is confident we can do it.

Information was presented by Dan Gummersheimer, noting that this is needed for the person living there who is in a wheelchair.

Motion for second reading was made by Alderman Plufka and seconded by Alderman Lochmoeller.

Motion carried by unanimous voice vote.

Second Reading by City Attorney.

Motion was made by Alderman Plufka and seconded by Alderwoman Sims to perfect this Bill into Ordinance form. Roll was called: By a vote of 8 (Yes) to 0 (No) Bill No. 6414 will become Ordinance No. 5045

Bill No. 6415 - An Ordinance Approving an Easement with the Metropolitan St. Louis Sewer District for the Brentwood Park Destination Playground Project. First and Second Reading

First Reading by City Attorney, Kevin O’Keefe.

On behalf of the Parks Director, the city Administrator presented the information stating that we are seeking approval of a utility easement and MSD permits.

Motion for second reading was made by Alderman Lochmoeller and seconded by Alderman Shelton.

Motion carried by unanimous voice vote.

Second Reading by the City Attorney.

Motion was made by Alderman Lochmoeller and seconded by Alderman Plufka to perfect this Bill into Ordinance form. Roll was called: By a vote of 8 (Yes) to 0 (No) Bill No. 6415 will become Ordinance No. 5046

Resolution No. 1399.1 – De-attachment of Corporal Lang to the St. Louis County Policy Academy - A Resolution Of The City Of Brentwood Missouri, Approving An Amended Contract Agreement Entered By And Between Saint Louis County, For And On Behalf Of St. Louis County And Saint Louis County And Municipal Police Academy Board Of Managers And Its Past And Present Officers, Elected Officials, Employees And Legal Representatives For The Services Of The Of Brentwood’s Police Officer Corporal Lang.

Major Jim McIntyre presented the information, noting that this particular agreement triggers a CALEA standard (their accrediting body) and we just had to make the agreement compliant.

The City Administrator shared that the county prefers we use their specific language in the contract, so they rejected the first one we had sent to them. The labor counsel wanted us to point out that there is a cap on compensation that St. Louis County will cover and that if we go over that, the City will have to cover that gap. There is also a cap on overtime at \$15,000. We don’t believe that either will be a problem. We will not exceed either and county agreed. Regarding the torte – if there is a claim or injury on their facility, but otherwise, the city is responsible. This just needed to be outlined.

Alderman Plufka does not understand how you can work for one entity and get the compensation from another for injuries that may arise out of that. He does not feel that this is how law was written.

Motion was made by Alderwoman O’Neill and seconded by Alderwoman Sims to approve Resolution No. 1399.1.

Alderwoman Tice asked if we are going by what the County says for legal responsibility? City Administrator replied, “yes”. Alderman Plufka said it really won’t matter – it will be covered.

Roll was called: Motion carried by a vote of 8 (Yes) to 0 (No)

**Citizen Comments**

Ryan Marshall, 2810 Lawndell (Ward 1) is a 3rd generation Brentwood resident. He supports Green Street an wanted to be on record. He works in commercial real estate, and they are locally based and understand St. Louis. They are a high quality, cohesive development.

Anthony George, resident, thanked the Board for doing this for redevelopment. He asked that we please create a process/procedure for landowners and businesses to stay in Brentwood and be involved in the process.



#NoFilter on these photos — her hair really is pumpkin orange! Francois’ langurs, (pronounced frahn-SWAH LANG-err), a species of monkey, are born with bright orange hair. Adult female members of the group will assist in caring for and carrying the young, known as ‘allomothering’, and the baby’s stand-out color helps the adults in the group keep track of the newborn. After about six months, they have fully transitioned to their less-conspicuous adult coloring, which is mostly black.

Dolly developed some health issues shortly after giving birth and both she and Rhubarb (pronounced ROO-barb) required round-the-clock care and supplemental feedings at times. The entire team of dedicated primate keepers altered their schedules in order to provide 24-hour care for this new baby, making sure that she was healthy, comfortable and well-fed until Dolly was healthy enough to care for her on her own again.

Throughout the process, staff consulted regularly with other zoos across the country and were able to utilize their valuable langur expertise to successfully navigate the complications of the birth. Dolly is now fully caring for and feeding Rhubarb on her own and the bond between the two is strong.

“Dolly has been a phenomenal mother and, through the benefit of her having a great relationship with the keeper staff, has been incredibly accommodating to the supportive care that she and Rhubarb needed to get back on track,” said Ethan Riepl, Primate Keeper and Francois’ Langur Species Survival Plan Vice Coordinator, “She deserves all the credit in the world for our success.”

The pair was recently reintroduced to the other langurs: Sydney, a 15-year-old female Francois’ langur, who helps out with Rhubarb giving Dolly a break now and then; Deshi, (pronounced DEH-shee), the 10-year-old father, who is not as hands-on, but watches over and protects the group; and Marc, an older spectacled langur male.

Dolly, Sydney and Deshi were introduced in 2014. Deshi was paired with each female in a breeding recommendation in 2019 by the Association of Zoos and Aquariums Francois’ Langur Species Survival Plan, a program responsible for maintaining a genetically healthy population of Francois’ langurs in North American zoos. Breeding was on hold until the new, spacious outdoor Primate Canopy Trails habitat opened in 2021. “For any species like langurs that practice allomothering, proper maternal care is an important skill for females to learn and to gain experience in,” Riepl stated, “With this being our first ever langur birth here at the Saint Louis Zoo, Rhubarb has been a valuable addition to our langur troop and has provided both Dolly and Sydney with a great opportunity to develop those skills.”

WHAT IS IT?

“REAL ID” comes from the REAL ID Act of 2005, a federal law that focused on fraud protection, anti-terrorism, and driver license and nondriver license identification card (ID card) security. The REAL ID Act prohibits federal agencies from accepting driver licenses and ID cards from states that do not meet these standards. Access to federal facilities open to the general public for purposes of applying for or receiving federal benefits will continue to be allowed. Beginning **May 3, 2023**, every air traveler **18 years of age and older** will be required to present a REAL ID-compliant driver license or ID card, or another form of ID accepted by the Transportation Security Administration, to board federally regulated domestic flights. **Travelers who do not present a REAL ID-compliant license or acceptable alternative will not be permitted through the security checkpoint.**

Why You Should Avoid Opening a Retail Store Credit Card Just for the One-Time Discount (Hint: It Could Hurt Your Credit Score)

Store credit cards can be very enticing because they offer immediate value, typically in the form of a one-time discount or bonus cashback, but it can do more harm than good. Here are some things to consider before signing up:

First Comes the Credit Pull

When you apply for any credit card, your credit report is pulled by lenders so that they can check your creditworthiness. Unfortunately, this impacts your credit score negatively by a few points. By spacing out your credit applications, you’ll assure that your credit score won’t take a serious hit. But many pulls in a short time frame can definitely bring your score way down. And it could be worse for your score if you apply and are denied.

Lowens Your Credit Utilization

How much of your credit limit you use has a major influence on your credit scores. The only thing that matters more is paying on time. The credit limits on retail cards that you use only at one store or chain are typically about 10% of those on comparable general-use credit cards, so in order to keep your credit utilization low, it’s suggested to pay your bill before the issuer reports the balance to the credit bureaus.

High Interest Rates and Undesirable Terms.

While the average interest rate for an American credit card is around 15%, those for retail credit cards are usually upwards of 20% to 30%, and some cards can be even higher than this. Not only are rates high on this card, but they are variable and at the whim of the lender. This means you could start with what you think is a decent rate that is only increased a couple months later. It’s definitely not something you want to maintain a balance on and with interest rates like this, it won’t be long before your “discount” is canceled out by interest charges and your so-called bargain turns into a nightmare.

Approval Can Decrease Your Credit History.

The “length of credit history” means how long any given account has been reported open. Generally, the longer an account has been open and active, the better it is for the credit score. Credit History calculates the average of how long all your accounts have been open. That average age of accounts is your “credit age.” Opening a new account often causes the average age of your credit accounts to decrease.

**IMPORTANT NOTE:** If you already have a store card? Don’t close it — that also would hurt your average age of accounts. Better to use it lightly and pay on time. Both actions have a positive effect on your credit scores.

\* MILITARY POLICY CHANGE

The U.S. Department of Defense (DoD) recently finalized an update to its DoD-wide installation security policy and is in the process of no longer accepting noncompliant marked cards across all of its facilities and installations. This means the military is in the process of no longer accepting driver licenses or nondriver identification cards marked as being noncompliant with REAL ID for the purposes of accessing a military base. This policy change impacts DoD installations in all states, not just Missouri.

Prior to May 3, 2023, military bases will accept licenses and ID cards marked as being REAL ID-compliant or Missouri licenses and ID cards issued prior to March 25, 2019, which have no REAL ID marking, compliant or noncompliant. In Missouri, a license or ID card that is noncompliant with REAL ID will have “Not for REAL ID Purposes” in the upper right-hand corner. Anyone attempting to access a military base with a Missouri-issued license or ID card marked as “Not for REAL ID Purposes” may be denied entry.

# INSIDE BASEBALL

## Original plan had to change, but Cardinals' prospect Masyn Winn is still on a path toward the major leagues

There has always been a plan.

From the time that Masyn Winn was 13 years old, the plan was to make Winn's dream of playing professional baseball and becoming a major-leaguer a reality.

The plan was the reason Winn's mom, Tiffany Rawson, had him take "Money Matters" as a freshman in high school, so he wouldn't one day become a bankrupt professional athlete. It was the reason she told one teacher why Winn wasn't going to play football in high school – because "he's got a million-dollar arm."

It was the reason Andrew Guerrero has known Winn since he was a sophomore in high school in Kingwood, Texas, two years before he officially became Winn's advisor and agent.

It was the reason why, when Winn's school guidance counselor told Rawson, "I don't think you are getting him ready for college," Winn's mom agreed with her.

"You are correct," Rawson told the counselor. "I'm getting him ready to be a professional athlete out of high school ... Her and other people thought I was that crazy mom."

By the time Winn was a junior, the plan seemed to be progressing well. He split time between pitching and playing the infield, going 13-0 with an 0.67 ERA on the mound, striking out 117 hitters in 76 1/3 innings. At the plate he hit .417 with eight homers.

The plan next called for Winn to spend that summer, in 2019, playing for USA Baseball, where he was expected to be the starting shortstop for the national team. A good summer, with success in the showcase events and tournaments, would hopefully set him up for his senior year and a strong chance to become a first-round pick in the 2020 amateur draft.

Winn's future could not have been any brighter – until the day all of the planning was upended with what Winn says now was "a bad decision."

"I personally thought my career was over, just being young and naïve," Winn said.

Kicked off the national team as a result, Winn returned home. "To say he thought his career was over is definitely an understatement," Rawson said. "He came home and wallowed in it for a while, and I let him, for about six weeks.

"It was tough, it was absolutely heartbreaking. But first of all I have to say I was very proud of the fact that he was honest from the beginning. The kids that he was with were not, and they didn't get quite as severe a punishment as he did."

Said Guerrero, "Masyn was honest and owned up to his mistake. He didn't run away from it. He's learned from it, and I think ultimately in the long run it's made him a better person."

At the time, naturally, Winn was more concerned with what he had lost, the opportunities that had been taken away from him that he didn't know if he could get back. The life lessons that would come out of the experience would come later.

### "A new plan"

After giving her 18-year-old son what she thought was enough time to be depressed, Rawson told Winn it was time for "a new plan."

She told Winn, "You're going to have to work a hell of a lot harder. Now you're going to have to prove yourself more.

"At first he didn't want to. The plan he had had was gone. Then he started to have a little success. He found out, 'I can still run. I can still hit. I still love baseball.'"

With the renewed guidance of his mom, and the help of a close circle of friends, Winn accepted the challenge to not let one teenage mistake derail his years of hopes, dreams and hard work.

"She's played the mom and dad role my whole life," Winn said. "She's had the biggest impact on my life in baseball and everyday life in general. She pushed me as hard as she could in school and whatever sport I was playing at the time. She was always on top of things."

Rawson knew that if Winn worked hard enough on the field, given another chance, his God-given ability was still there. So too were aspects of his personality that had not been lost, the leadership skills and outgoingness that Winn had displayed all of his life.

The youngest of her five children, Rawson saw early on that Winn "was different" than his older siblings.

"All of my kids were athletes," Rawson said. "My daughter played basketball in college but she did just exactly what she had to do. My oldest son had the heart and the drive but didn't have the body. He's had three knee surgeries and two shoulder surgeries. My second son had awesome athleticism and the body but not the heart or the drive.

"It was pretty clear when Masyn was eight or nine years old that he was different. You could just tell. He was built differently. He was wired differently. You could just kind of tell he might be the one who has it all."

Rawson remembers taking Winn to a doctor's appointment on his first birthday. Waiting in the room, the two were playing catch with a small, squishy basketball when the pediatrician walked in and saw them.

"She goes, 'You know that's not normal right (for his age)?'" Rawson said. "She said, 'He should not be able to throw and catch like that at 12 months old.' I said, 'Yeah, we've been doing this for two months.'"

It took a few more years before Rawson began to encourage the development of Winn's other skills.

"I have challenged all of my children," she said. "We're all outgoing. We all talk. We all have great personalities. I tried to make them understand what a gift that is, how difficult it is for shy people. I walk into any room and find the one person who isn't talking to anybody and pull that person into a conversation. Any new kid that joined any team my kids were on, it was their responsibility to bring them in and make them part of the group.

"I pushed Masyn. Masyn was so popular at 4. He was popular at daycare. He's bright. He's funny. I've always made him do things. They used to play a football game with shirts and skins before the season started and kids would only throw the ball to kids they knew. After practice one day I told him, 'See that little kid over there? Tomorrow, throw him the football please.'

"He threw it to him twice and the other parent was crying. I told Masyn, 'You will never remember that kid's name but he will never forget you. Those little things you can do because you're popular, because everybody follows you or listens to you, can be a huge difference.' He was really good at it."

Because of that personal history, Rawson – and Guerrero – believed that when Winn got back on the field his ability would take over. Getting to talk to scouts, and explain what had happened truthfully without making excuses, would be an important aspect of his recovery path as well.

"It was not a representation of who he was or what his character was," Guerrero said. "I told him to go work his tail off and prove to everybody this is not going to define you."

The first part of that process was to find a place for Winn to play.

### "The best leader I've ever been around"

Winn's former summer team had disbanded. Committed to Stanford at one point, keeping his college options open, Winn had changed his choice to Arkansas. One summer travel team, the Arkansas Sticks, had a roster that included several other future Razorbacks.

The coach of the Sticks, Chase Brewster, met with Winn and his mom. It didn't take long before Winn joined the team.

It also didn't take long for Brewster to learn, as others had, what Winn brought to his team above and beyond his ability to hit, run and throw.

"He was the best leader I've ever been around," Brewster said. "Masyn's motives were always Kobe Bryant-ish. You hear stories and they are hard to believe, but that's who Masyn was. He was going to win everybody over either by working



hard or his character. He left an impression on everybody he was around.

"He was one of the greatest kids I've ever been around. I wish I had a hundred of him ... He knew what he wanted to do. He was well-educated, he was talented. He loved to play baseball, he loved to compete at the core, and he loved to see other people who were not as talented as him do well."

The first chance for Winn to show a large group of scouts he had not lost any of his talents since leaving the USA team came in October 2019, at a Perfect Game tournament in Jupiter, Fla.

"It was a big tournament for me, especially with everything that had happened," Winn said. "I had something to prove there."

Brewster still has a video he took on his cell phone one morning of Winn, in full uniform, taking dry swings at 6:50 a.m., hours before the team's game was scheduled to begin. Winn was determined to make the most of this opportunity.

"He was embarrassed and used that as fuel," Guerrero said. "I think that's a good lesson for a lot of kids coming up in this day and age. He went out and put on a show that scouts to this day call the best performance they've ever seen."

On the mound Winn threw a fastball that registered 98 miles per hour on the radar gun. One of his three hits in the game was a home run. All three of his hits had an exit velocity greater than 100 miles per hour.

While that performance was a boost to Winn's confidence, he soon found out the repercussions of his mistake were going to linger a while longer.

Word about what had happened had reached his high school, and when officials asked for an explanation, Winn again told the truth. He was suspended for the first 12 games of his senior season, an important time for him to try to make an impression on scouts getting a final look at players before the draft.

"They said if I had lied I actually wouldn't have been suspended," Winn said, "but I told them what happened and we just kind of went from there."

### "I like to talk a lot"

Winn's strong junior season and earlier success already had made him well known to Jabari Barnett, then the Cardinals' area scout in Texas and now their Midwest crosschecker.

"Coming into the spring we knew that Masyn would have to serve a suspension but he would be allowed to play in scrimmages," Barnett said. "Our plan was to get to more scrimmage and practice looks than we would normally get.

"Masyn is one of those players where you hear about him before you actually meet him, and there was no shortage of opinions. The more we got to know him we realized that some perceptions were harsher than our perceptions of his makeup. He was highly charismatic, had a great sense of humor and confidence in himself on and off the field."

Barnett remembers one of those pre-season scrimmages in particular in part because it was cold, at least by Texas standards, about 40 degrees.

"It was a 13-inning scrimmage," Barnett said. "I remember the competition wasn't great and the game was a bit slow but Masyn was locked in the whole game, all 13 innings. I know because I heard him the whole time. He didn't stop talking; on the field, on the edge of the dugout, for 13 innings.

"That night stands out because it gives some insight into who he is. In a meaningless scrimmage, in cold conditions, in a non-competitive environment, he provided the energy, found a way to compete and encourage those around him."

Winn remembers that night, and he's not surprised that what stood out to Barnett was how much he talked during the scrimmage.

"I'm real energetic," Winn said. "I like to talk a lot. I'm a real positive guy and I would say I talk more than most people. I like being the vocal leader out there, always keeping everybody on their toes, always trying to be positive when I can. I think it feeds to the other guys. I've always loved talking. It's just natural."


Winn remained positive during his suspension, using his time to encourage his teammates. What nobody had any way of knowing, however, was the challenge that was about to affect the country and the world.

Winn was able to play one game after his suspension ended before the rest of his team's season was canceled because of the pandemic. Every team pulled their scouts off the road. There were no games to watch, no chance to evaluate players in the critical final weeks before the draft.

"The biggest challenge was not being able to watch workouts, game, etc.," Barnett said. "There were months between the last time we saw him in person and the draft."

What neither Barnett, Winn or anybody else knew at the time, however, was that the shut-down probably worked to the benefit of the Cardinals. Relying on what they knew, aided in part by the evaluation of another scout, Dirk Kinney, who doubles as a coach for the Sticks, the Cardinals were able to draft Winn with their second round pick, the 54th overall selection.

“In my honest opinion, if there had been a normal season, Masyn might not be a Cardinal right now,” Barnett said. “I was concerned if he would get to our second pick. If there was a normal season I think there is no way he gets there. I’m not sure how other teams evaluated him but with a full schedule I assume it would have given more time for teams to buy in.”

As he has learned on other occasions in his life, Winn still believes it was another reminder of a lesson his mom taught him years ago – that everything happens for a reason.

“Personally, I think if I wouldn’t have gotten in trouble I would have gone closer to the first round,” he said. “That’s not something I can really control now. It could have changed everything. I doubt if I would be a Cardinal. All that doesn’t even matter at this point. Now it’s all about playing ball and trying to get to the big leagues.”

**“You can’t take your eyes off him”**

As Winn sat in the dugout before a recent Fall League game at the Peoria Sports Complex, he preferred to look ahead, not behind. After spending the summer of 2020 at the Cardinals’ alternate site training camp, two good seasons in the minors have put Winn on the doorstep of the major leagues.

“I knew there were for sure going to be some character questions coming in (to pro ball),” Winn said. “I wanted to, and I’m still trying every day, to prove to them that I’m the guy they drafted and the guy they want to lead their team in the future.”

Rawson has seen a change in her son over the last two years.

“He is incredibly focused on the end game,” she said. “It is interesting to talk to what is a 20-year-old child whose goal is to get to the big leagues. Nothing is getting between him and that goal. He knows exactly what he has to do to get to the show. That’s his goal.

“It’s quite fascinating, his singular focus on this. There are so many temptations. There’s so many things that can derail you ... I’m not as worried about him as I used to be. He knows what the goal is and he knows what the boundaries are now.”

Kinney spent a lot of time with Winn during the summer of 2019, including staying in the same house along with some of the other players on the Sticks. The two reconnected this summer.

“We had lunch in Springfield,” Kinney said. “I was able to witness the growth he has made.”

Guerrero remembers a conversation with Winn when his pro career was just getting started.

“He said he was in the clubhouse looking around at grown men,” Guerrero said. “He was like everyone who has the questions of, ‘Do I belong here? Am I good enough to compete with these guys?’ He said, ‘You know what? I thought to myself, they’ve still got to pitch me the ball. It’s still baseball. They’ve got to bring it to me and I can show them what I can do.’ I thought that was the perfect attitude to have.

“Baseball is a game of failure. It’s an individual game within the context of a team sport. There’s a guy on the mound and a guy at the plate. It’s one-on-one. You have to be able to put the outcome of your last at-bat behind you and still say, ‘I’m the man, I’ve got this’ and find a way to succeed.”

Guerrero believes Winn already is doing that – and will continue to do so.

“He’s going to be able to impact a ball club in numerous ways,” Guerrero said, “with his bat, his glove, his speed, with his five-tool approach. He’s someone who if you are on the other team, you have to game plan around him.

“You can’t take your eyes off him when he is on the field because he can impact the game in so many different ways.”

Barnett has paid close attention to Winn’s journey since his high school days.

“I know that whenever Masyn steps on a field that he believes he’s the best player out there,” Barnett said.

That’s been the case this fall, just as it was the last two years. Splitting this season between Peoria and Springfield, Winn hit .283 with 36 doubles, 12 homers, 63 RBIs and 43 stolen bases in 119 games. In his first 16 games in Arizona, he hit .320, drawing 12 walks while striking out only nine times in 50 at-bats.

“Masyn has a ton of energy and plays the game at a really high rate,” said Tyger Pederson, Winn’s hitting coach at Springfield and also with the Salt River Rafter this fall. “He cares. That’s the biggest takeaway for me; when you get a player who really plays hard and cares, that’s what you want.”

The Cardinals drafted Winn as a two-way player, interested in seeing how he would develop as both a hitter and a pitcher. He has played so well at shortstop that the idea of also pitching – he has thrown only one inning as a professional – has at least for now become an afterthought.

“It’s in my back pocket right now and probably will end up staying there,” Winn said.


When the Fall League ends soon, he is going to go home and rest over the holidays. Then he and fellow top prospect Jordan Walker, now one of Winn’s closest friends, already have plans to arrive in Florida in January to begin preparing for next season.

“Masyn will have other goals,” his mom said. “Getting to the big leagues is the first goal. He’s already planning.”

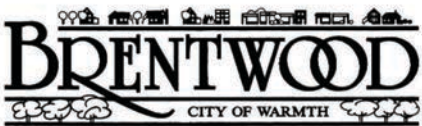

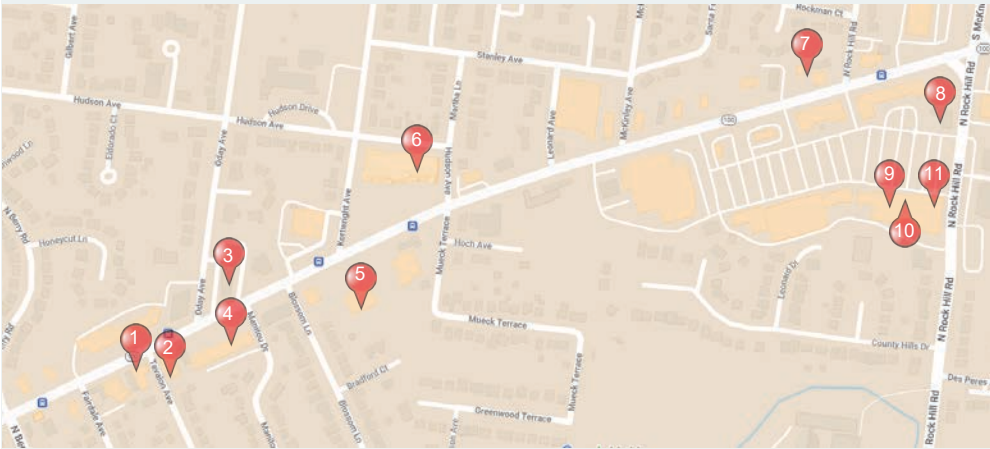


## A Letter from the Mayor

## BRENTWOOD OCTAGENARIAN HARVESTS DEER



An 83 years old senior resident of Brentwood harvested a deer at Mark Twain Lake in mid-October. Henry Drane was on a Club Hunt and Fish Camp with the South County Archers at the Si Colborn group camp facilities in Mark Twain State Park (MTSP). The club makes an annual outing to MTSP as part of their activities. From Spring to Fall, club members and guests practice archery on life sized 3-D targets at the Jefferson Barracks County Park archery range.

Practice paid off for the octogenarian as twilight began on the last day of the hunt. Sitting in a comfy patio chair in his well concealed ground blind, he watched a deer approach down the wood line from the left. At a distance of only five yards, he had to very quietly hoist the twelve-pound

crossbow. The deer crossed downwind, but the confines of the tent partially blocked any human scent; the rest was consumed by ozone from the Ozonics machine attached near the blind. Finally, at 15 yards, the deer presented a shootable profile, and Drane harvested a yearling (1 ½ years old) buck with two-inch tines. Under three inches is legal in Missouri since at that size it is almost impossible to tell doe from buck. In fact, he thought it was a doe when he released his bolt with a well-placed shot that dropped the deer quickly.



The shot is just the first step of a long process of turning a wary denizen of the forest into venison for the table. With the help of club members Malcolm Grundy and Douglas Spalding, Drane carted the harvest 300 yards uphill to his van where he field-cleaned the carcass in the headlights. Since it was a cool night they packed the carcass with bags of ice and wrapped it if a tarp so it would be fresh and preserved in the morning. Then the three hunters retired to the facility’s spacious dining hall for a delicious and hearty steak dinner prepared by other club members. After dinner there was an animated discussion of all the exciting events experienced by the member/hunters over the past three days.

The next morning, club members Tony Taylor, Doug Spalding and Ildar Sadukov saved Drane a butcher’s fee by hoisting the deer on a gambrel whence, with their experienced hands, they skinned and butchered it in only an hour and a quarter. Carving carefully, they produced 40 pounds of venison and 10 pounds of scraps (for Drane’s Boxer dog). The hide went to Schwarz’s Taxidermy on South Grand for tanning – makes a great chair cover or throw.

The hunter/butchers finished their work in time to take part in a very important activity – clean up time. In hopes of coming back next year, members must leave the facility as clean as they found it. All hands working is part of the very reasonable fee for renting the Si Colborn ample facilities. In little more than an hour the club had the place ready for inspection by the Park Ranger.

The South County Archers will apply to the Missouri Department of Natural Resources to rent the Si Colborn group camp facilities next fall. Club members and guests are welcome to participate.

Hunters help the Missouri Department of Conservation (MDC) control the population of this prolific cervid species. Last year, Missouri archers harvested 67,000 white-tail deer while firearms hunters reported an additional 230,000. That represents one third of the estimated deer population in the state, which is what the MDC recommends for herd control.

## WGU Missouri Delivers Appreciation Kits to St. Louis Area First Responders Working an Extra Hour Over Daylight Saving Time



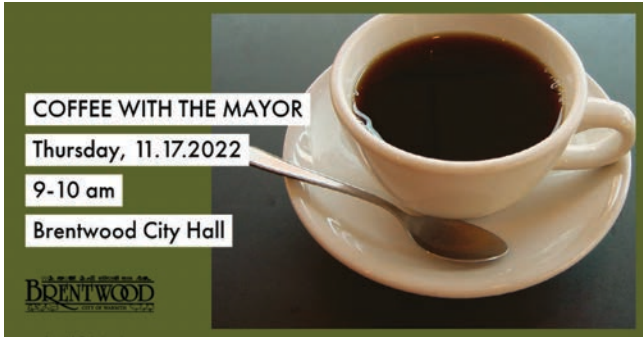

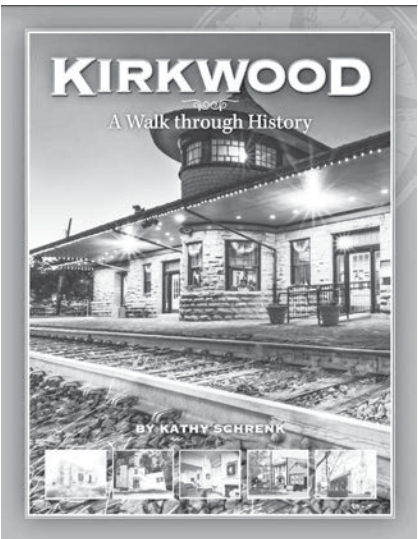

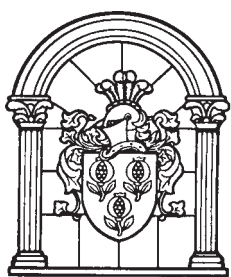

## St. Louis Area Diaper Bank Kicks Off “The Big Ask” Year-End Campaign

Nonprofit needs community’s help to provide diaper and period supplies



The St. Louis Area Diaper Bank is asking the community for assistance during the upcoming holiday months with its “The Big Ask” year-end campaign starting Nov. 15 through Dec. 31.

The St. Louis Area Diaper Bank – which provides access to diapers and period supplies for low-income families – needs to raise \$100,000 to successfully provide essential services in the upcoming new year. Fundraising efforts will alleviate the growing diaper need that continues to be a burden for families. The efforts will also include support for its period supply program, St. Louis Alliance for Period Supplies, to help end period poverty for many struggling to afford those basic need items. Specific campaign goals include financial assistance for the Diaper Bank’s many programs and services including:

· The Diaper Bank’s first period kits – each includes approximately 20 menstrual hygiene products for girls experiencing their first period – are distributed through schools and partner organizations. To date more than 800,000 period supplies have been distributed in St. Louis, with 10,800 period supplies allocated each week. Last year two-thirds of low-income women in St. Louis could not afford menstrual hygiene products, with 46% of low-income women having to choose between food and period supplies.

Partners include the St. Louis County and Public Libraries, organizations (Assistance League of St. Louis, I Define Me Movement, The Little Bit Foundation, and Youth In Need) and schools (Gateway Science Academy, Parkway School District, Pattonville Heights Middle School, and Riverview Gardens School District.)

· The St. Louis County Library distribution program, which began in 2020, partners with the Diaper Bank to provide families with 25 diapers and one period kit per month. This year the partnership has already served approximately 14,000 families by distributing nearly 700,000 diapers and 3,489 period kits to those who need emergency products.

There are six participating St. Louis County Library branches (Florissant Valley, Grand Glaize, Indian Trails, Lewis and Clark, Natural Bridge, and Weber Road) and two city branches (Central Library and Julia Davis.)

· The need for pull-ups – which are potty training pants – continues to increase in the community. The Diaper Bank’s cost is 23¢ to 25¢ per pull-up, which is nearly 10¢ more than a single diaper.

To date more than 10 million diapers have been distributed in St. Louis including nearly 900,000 diapers during the height of the pandemic. The Diaper Bank offers both emergency and long-term diaper distribution. This service is a much-needed resource since government programs – including food stamps and WIC – do not provide funding for diapers or period supplies. These items cannot be obtained with food stamps and are classified as luxury items along with cigarettes, alcohol, and pet food as disallowed purchases.

“Access to basic hygiene items has been growing since even before the pandemic,” said St. Louis Area Diaper Bank Executive Director Muriel Smith. “The struggle is real, which is why our work is critically important. We elevate the issues of diaper need and period poverty to a national level so we can receive essential resources for our community.” Smith added that on average women and girls “miss four days of work or school each month because they simply cannot afford the necessary hygiene products to live their daily lives.”

Founded in 2014, the St. Louis Area Diaper Bank provides diaper and period supplies to the region’s low-income families, as well as raises community awareness about the causes and consequences of diaper need and period poverty. Located at 6141 Etzel Ave. in Wellston, Mo., the nonprofit is a member of the National Diaper Bank Network, a nationwide nonprofit dedicated to eliminating diaper need and “period poverty” in America. The St. Louis Alliance for Period Supplies ensures access to menstrual hygiene products, which allows full participation in daily life with dignity.





PICTORIAL ST. LOUIS: The Great Metropolis of the Mississippi Valley A Topographical Survey, Drawn From Perspective 1875.

Illustrations by Camille N. Dry and designed & edited by Rich. J. Compton.

Over 220 pages of illustrations and descriptions of life in St. Louis in the late 1800’s. The preliminary drawings for this work were made early in the spring of 1874. After a careful consideration of the subject, it was determined to locate the point of view so that the city would be seen from the southeast, believing that to be the most advantageous in all respects. Accordingly, the point of site was established on the Illinois side of the river, looking to the northwest, and at sufficient altitude to overlook the roofs of ordinary houses into the streets.

A careful perspective, which required a surface of three hundred square feet, was then erected from a correct survey of the city, extending northward from Arsenal Island to the Water Works, a distance of about ten miles, on the river front; and from the Insane Asylum on the southwest to the Cemeteries on the northwest.

Every foot of the vast territory within these limits has been carefully examined and topographically drawn in perspective, by Mr. C. N. Dry and his assistants, and the faithfulness and accuracy with which this work has been done an examination of the pages will attest. Absolute truth and accuracy in the representation of the territory has been the standard and in no cases have additions or alterations been made unless the same were actually in course of construction. In a few cases, important public and private edifices that are not yet finished are shown completed, and as they will appear when done.

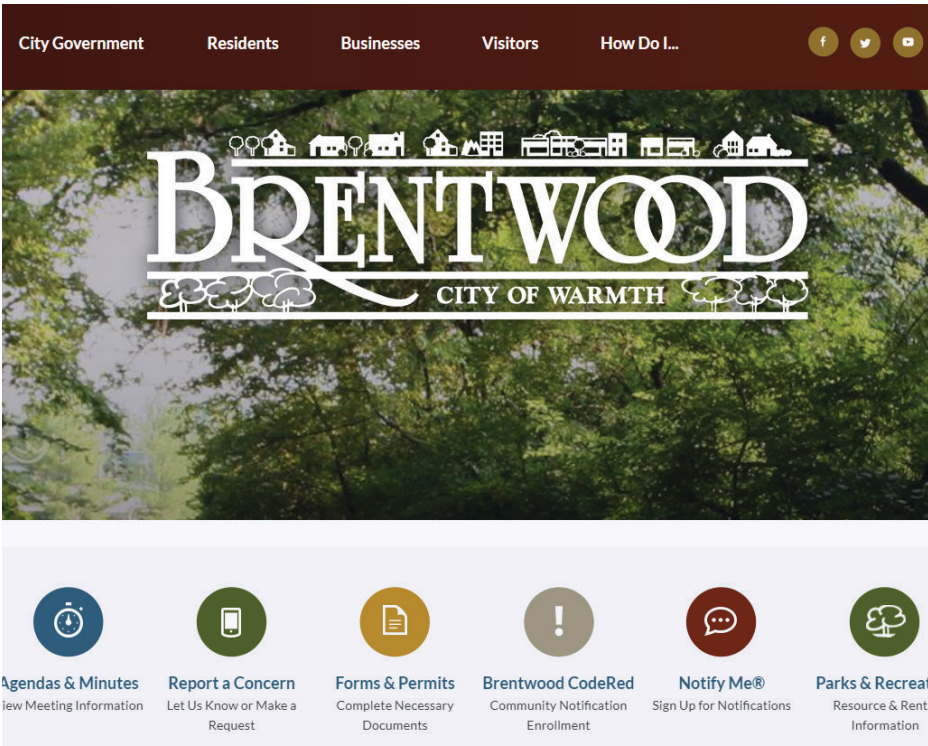
All the buildings within the limits of the survey in July, 1875, are shown; and a very large number of those executed or commenced since that date have been also introduced, the pages having been constantly corrected up to the last possible moment before publication.

**Breaking Ground on Brentwood Bound: Deer Creek Greenway Connector**

The City of Brentwood and its partner Great Rivers Greenway officially broke ground on the Deer Creek Greenway Connector on Thursday, April 28.

When complete, the Deer Creek Greenway Connector will create a paved, accessible walking and biking trail linking Brentwood's Memorial Park (with sidewalk access to Brentwood Promenade and Brentwood Pointe shopping centers) to Lorraine Davis Park, Barnickel Park and Deer Creek Park in Webster Groves, Deer Creek Park in Maplewood and the Deer Creek Shopping Center at Big Bend Boulevard.

The Deer Creek Greenway Connector will also link to multiple parks and amenities within Brentwood.

City officials ceremonially break ground for the project.



**Manchester Road Closure: Through August 2022**

Black Creek Bridge on Manchester Road (just west of the intersection with Hanley Road) closed on May 2 and will remain fully closed through August 2022.

This closure will prevent traffic from going west from Hanley Road to Manchester Road. The closure also will prevent traffic from going east on Manchester Road to Hanley Road.

Throughout the closure, vehicles will still be able to access businesses and residences along the Manchester Road corridor from Brentwood Boulevard.

During the same time, work will take place on the pedestrian tunnel near Mary Avenue. This work will reduce Manchester Road traffic to one lane in each travel direction.

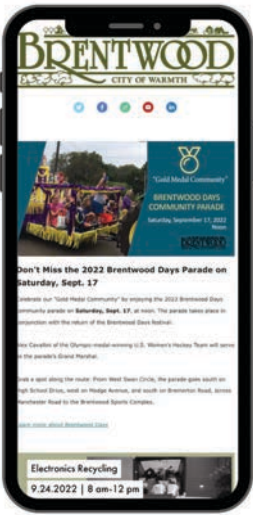

## Groundbreaking for Brentwood Park Destination Playground



The City of Brentwood broke ground on the destination playground and water play area in the new Brentwood Park on Thursday, Nov. 3.

The playground will open in Fall/Winter 2023 and will offer 2.5 acres of interactive play experience with many amenities not found elsewhere within the St. Louis region.

Feedback from residents helped guide this project. The Brentwood Board of Aldermen voted to approve the \$7.4 million to create this one-of-a-kind destination.

### Overview

An adventure playground offers 2.5 acres of interactive play experience

This memorable destination for children and adults focuses on creative and inclusive play

Many of the amenities within this playground are unique to Brentwood Park and not found elsewhere within the St. Louis region

The integration of play and landscape connects people with nature and provides an experience that changes throughout the seasons

This imaginative and inclusive play experience is organized into four key areas: Family Fun Zone

Nestled into the hillside at the west end of the playground, this zone engages small children and families with swings, hillside slides, balance play, spinners, and an imaginative climbing structure. Many of these play elements are designed to be inclusive play experiences, including a generation swing

(which provides a shared swing experience for child and caregiver), a ground-based spinner that accommodates mobility assistance devices, and hillside roller slides. This zone includes a picnic shelter that overlooks the play area, an ideal setting for birthday parties or lunch with friends.

### Adventure Play Area

This heart of the playground includes a range of play opportunities, from a net climber that rises 22 feet above the play surface, to a large group catapult swing that moves kids through the air using their own body weight and momentum. A side-by-side zip line extending 110 feet through the playground and landscape allows children to race or ride together, and natural log pile climber is a creative play destination with stacked logs and nets. The adventure hill in this zone allows for connections to natural landscape and quiet locations to get away or to explore imaginative play with a group of friends.

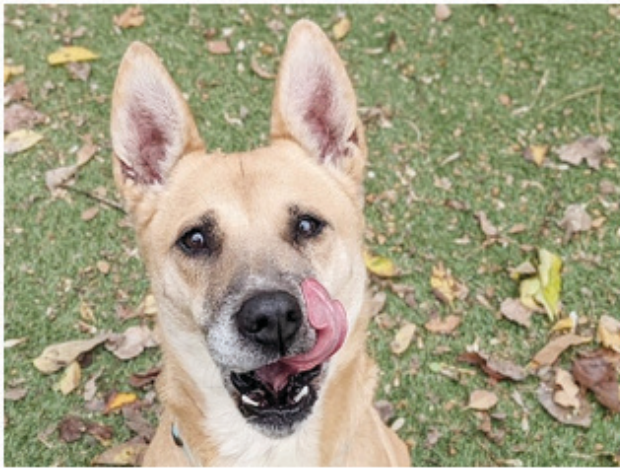
### Overlook

With a view of the lake, amphitheater, and the trail, the ADA-accessible overlook provides a breathtaking panorama of the park. Walking to the end allows space to take in the natural beauty and

enjoy a peaceful retreat. It will also be accessible from the playground or the Great Rivers Greenway trail that runs through the park, making it a perfect stop to rest.

### Water Play Explorer Creek

Conceived to mimic the Deer Creek watershed, this interactive water play element includes water spraying from the ground and walls. Water flowing through the play area can be dammed to reroute for creative play. Informal seating ledges that mimic quarry shelves are a nod to the history of this park site. The water drains into a stormwater management and native landscape pollinator area and will be recycled for use in irrigation of the playground landscape. Overlooking this water play area, and centrally located within the playground is a signature pavilion, which will be home to many events and activities within the playground. In addition to the covered gathering space, the pavilion includes a small water play element that creates a waterfall into the area below on the south and opens to a game lawn/event space to the north.

USA Today frequently names things as “The Best In America”, and Missouri has collected a number of such accolades. Lake Of the Ozarks has been named America’s best recreational lake. Cardinal Sin Vodka, distilled in St. Charles, MO, has been declared America’s best craft vodka and now, Chaumette Winery, Ste. Genevieve, MO has been declared America’s best winery restaurant by USA Today!

The Grapevine Grill beat out winery restaurants in Paso Robles, CA, Woddenvile, Wash- ington, Healdsburg, CA, Temecula, CA and more.

This award finalized our decision to travel to Ste. Genevieve to do interviews for our Travel Planners Radio Show as well as shoot video for our ne Travel Planners TV Show.

Robert Beasley is the Chef at the Grapevine Grill, and may be well know to many St. Louisans. While growing up in Louisiana, he was influenced by his grandmothers Cajun and Creole cooking.

With a degree from the Culinary Institute of America, he spent some time in Des Moines, IA and then came to St. Louis. He was Executive Chef at Pairings Bistro, and the Ballpark Hilton. He also worked at Cardwell’s at the Plaza, and LHM Hotel Properties. He was also the corporate Chef for Charlie Gitto’s restaurants

The Grapevine Grill’s menu combines Chef Beaseley’s more than twenty-five years of experience into a simple one page menu with something to please every one. I hate a ten- page menu that is merely a different combination of a few basic ingredients, or worse yet, a myriad of items that really don’t go together. On top of that, a multi page menu pretty much guarantees that most, if not all the items come from the freezer and are simply warmed in the microwave, or boiled in a bag, before coming to the table.

The Grapevine Grill’s menu offers starters such as garlic fries with parmesan, bacon and chive aioli, humus, homemade chips with French onion dip, spicy BBQ shrimp, and jumbo crab dip with baked crustini.

Salad items are; classic Caesar, mixed greens and a chopped salad.

Flat breads include four cheese, roasted chicken, and Volpi pepperoni.

Sandwich items are a Cubano, Grilled chicken, Roasted Turkey wrap, an eggplant parmesan sandwich with French bread, roasted tomato sauce, fontina and parmesan cheeses and a toasted almond pesto. They also offer a grass fed burger with roasted sweet peppers, car- amelized onions, white cheddar, apple wood smoked bacon, greens, and herb cream cheese on a toasted brioche bun.

They also have rib-eye, strip, and filet steaks. All their beef is aged a minimum of twelve weeks and the rib-eye and strip steaks are aged for sixteen weeks.

Sue had the filet steak and it was perfectly prepared, and served with smashed potatoes and fresh asparagus. It could not have been better.. She actually let me have a bite and if you are a steak person I highly recommend this one.

Chef Beasley sources most of his food items from local sources and the menu changes seasonally because of this and it assures you that you are dining on the freshest of ingredients.

On the owners recommendation, I had the crawfish etouffee. It was the real deal, a rich stock thickened with a a dark roux, and green onions served over rice. It was perfectly spiced, not too hot and not to mild. Chef sources his mudbugs from Metairie, LA.

Desserts include chocolate Amaretto pecan pie, Grand Marnier carrot cake, Snicker bar ice cream pie, flourless chocolate torte. We tried the carrot cake and the chocolate Amaretto pecan pie. Once again, absolute perfection.

It goes without saying there is an excellent choice of reasonably priced wines to choose from as well.

I really enjoyed the fact that the Grapevine Grill is a very relaxed, unpretentious atmosphere. Casual dress is totally acceptable, but if you are there for a special reason, feel free to dress-up as much as you like. The service was excellent, but not over bearing. Dining is available in the dining room, banquet room for large parties, and on the veranda overlooking the vineyards and the Saline Creek river Valley’s rolling hills. Reservations are suggested, especially on the weekends.

The small chapel from the Thompson Center in west county has been moved to, and restored at Chaumette Winery. It is nestled on a small hillside with pine trees on three sides and looks like a Nor- man Rockwell print. It is a perfect place for a romantic wedding. There are also a number of French inspired villas for guests as well. Be advised that they will only do one event per day to assure you that you have an excellent experience.

USA Today is correct. The Grapevine Grill at Chaumette Winery is deserving of the title “America’s Best Winery Restaurant.”

Braving the Storm  
SERVPRO Team Thole-Hulsey is  
Helping Floridians Recover from Ian

Many watch with compassion the shocking videos of the effects of hurricanes and tropical storms on TV. It’s surreal to see entire buildings swept away, homes devastated, and lives completely changed in a few hours. The cleanup can take months before life returns to some semblance of normalcy.

After the roof was ripped off, water penetrated all eight floors. The DRT is busy restoring this hotel and helping the Gulf Coast community get back on its feet.

With 500 crews and 100 large loss teams working to help Floridians recover from the impact of Hurricane Ian, the Thole-Hulsey DRT is proud to be working alongside so many great people on the frontlines of this disaster. Enduring days of cold showers and no power, the team often makes four-hour drives with little cellphone services to accomplish the work it came to do.

SERVPRO is partnering with non-profit organizations to offer practical assistance to those affected by Hurricane Ian. The Florida Disaster Fund is a private fund dedicated to assisting Florida communities after storms like Ian with response and recovery. 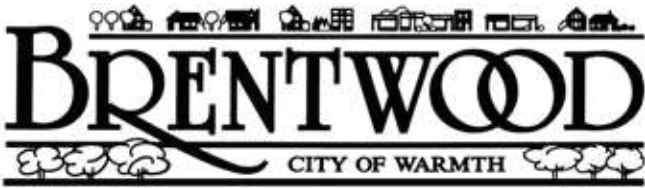


Reminder from Brentwood Police Department: Leash Your Dog

4. A member of the Board of Aldermen from Ward 2 for the full term of two (2) years.
5. A member of the Board of Aldermen from Ward 3 for the full term of two (2) years.
6. A member of the Board of Aldermen from Ward 4 for the full term of two (2) years.

All candidates desiring their names on the official ballot in the election aforesaid are hereby notified to file their names in person with the Deputy City Clerk of Brentwood, Missouri, at the Brentwood City Hall, 2348 S. Brentwood Blvd., Brentwood MO 63144. The filing hours are 8:00 a.m. to 5:00 p.m. Tuesday, **December 6, 2022**, through Tuesday, **December 27, 2022**. The office of the Deputy City Clerk will not be open on Saturdays and Sundays or those days designated a holiday by the City of Brentwood.

All qualified candidates are hereby notified of the statutory requirement to provide to the Deputy City Clerk, at the time of filing, proof of identity such as social security card, Missouri driver's license, or must be recognizable to the Deputy City Clerk.

Candidates must have filed the required Campaign Finance Disclosure reports, and the Financial Disclosure Statement for Political Subdivisions (Ethics) for any prior elections before they can file as a candidate for another office.

All candidates' names shall appear in the same form in which the candidate is registered to vote except that, when certified by the candidate as a necessary means of identification, the following may be allowed:

1. Commonly used nicknames
2. Commonly used abbreviations
3. Parenthetical reference to married names

Persons who, after filing their names as candidates, wish to withdraw as such candidate, must file their notice of withdrawal with the City Clerk in the City Clerk's office no later than 5:00 p.m. on Tuesday, December 28, 2021.

The filing fee for each elective office shall be \$5.00 payable by check or cash. In case of withdrawal of a candidate, there shall be no refund of filing fee. All filing fees shall be paid to the Deputy City Clerk at the time of filing. Provided however, if a candidate files a sworn affidavit with the City Clerk/Administrator stating he/she is financially unable to pay the filing fee, the candidate shall not be required to pay the fee.

The Deputy City Clerk shall be responsible for the oversight of the filing of candidates and shall clearly designate where candidates shall form a line to effectuate such filings and determine the order of such filings; except that, in the case of candidates who file a declaration of candidacy with the City prior to 5:00 P.M. on the first day for filing, the Deputy City Clerk shall determine by random drawing the order in which such candidates' names shall appear on the ballot. Any drawing conducted pursuant to this Section shall be conducted so that each candidate, or candidate's representative if the candidate filed under Subsection 2 of Section 115.355.2 of the Missouri Revised Statutes, may draw a number at random at the time of filing. If such drawing is conducted, the number drawn shall be recorded with the candidate's declaration of candidacy. If such drawing is conducted, the names of candidates filing on the first day of filing for each office on each ballot shall be listed in ascending order of the numbers so drawn.

All candidates must file in person in the Deputy City Clerk's office. Filing will occur at the Brentwood City Hall. This building opens at 8:00 a.m. **For this purpose, a line for filing may be formed outside the main entrance to the Brentwood City Hall on Brentwood Blvd. Then at 8:00 a.m., all persons may proceed to the receptionist's desk at that time.** The forms, or notices used, shall be made available on December 6, 2022 at 8:00 am by the Deputy City Clerk at the Brentwood City Hall. Each day thereafter the forms will be available from 8:30 am to 5:00 pm, Monday – Friday.

## 2022 Medicine Lodge Kansas

We drove back to Kansas, but this time attended the Peace Treaty Powwow in Medicine Lodge, Kansas. The event was held September 23 – 25th. This was a non-pageant year and the next pageant will be held in 2024.

Upon arriving in town we checked into our lodging at the Gyp Hills Guest Ranch. We went to the Stockade Museum for the annual “bean feed” served with cornbread. We did not arrive in town for the first event, the historical stage show, which included gun fights, cowboys and can-can dancers at the Red Dog Saloon. The stage act depicted an 1884 bank robbery. The infamous axe-bearing Carry Nation made her appearance to rid the Red Dog Saloon of its evil liquor.

We toured the Carry Nation House next to the Stockade Museum. There was a woman telling the story of who Carry Nation was. She was a member of the Women’s Christian Temperance Union. She felt it was her duty to put people in jail and tell them the evils of drunkenness. She bought an axe and went on a saloon-smashing career and temperance crusade, which would take her to thousands of miles, even to foreign countries. The museum and home contain historical artifacts and antiques from the surrounding area. Inside the stockade was the Old Courthouse jail, the Smith Log Cabin and you could see the actual peace pipe used in the 1867 peace treaty along with memorabilia from early Peace Treaty Pageants.

The next day we watched the parade showcasing local horseback riding cowboys and cowgirls, winners of local beauty pageants, decorated cars, trucks, motorcycles and fire trucks. Several of the local Indian tribes dressed in their regalia also marched in the parade. The parade route passed by the vendor booths and the 1867 Medicine Lodge Peace Treaty Statue and historical marker.

Later in the day the rodeos would begin. Welcome to the 34th Annu-

al Kansas Championship Ranch Rodeo. This rodeo was created in 1988 to preserve the heritage and lifestyle of the men and women of the working American ranch by producing this event. The WRCA (Working Ranch Cowboys Association) promotes all states of sanctioned ranch rodeos. The first place team from this rodeo ill go on to the November 27th annual World Championship Rodeo held in Amarillo, TX.

The Medicine Lodge Intertribal Powwow gives Native Americans an occasion to meet, dance, socialize, honor their culture and share their traditions with non-Indians at the new powwow grounds at Memorial Peace Park. The programs called for the Gourd Dance, Calling Song, Teen, Youth, Tiny Tots and Golden Age dancers. Other dances sometimes performed are: Women’s Fancy Shawl, Jingle Dress, Buckskin Dance, Cloth Dance, Grass Dance, Straight Dance and Fancy Dance.

A variety of rodeo events include: Ranch Bronc Riding, Stray Gathering, Wild Cow Milking, Team Penning, Calf Branding. One of our favorites was the Mutton Bustin’ Weight limit 60 lbs, participants Ages 4 – 8. You will also watch Saddle Bronc, Bareback and Bull Riding. The evening ended with the Jack Rowdy Band.

We were told not to miss driving on the Gyp Hills Scenic Byway before leaving town. You don’t want to drive it at night though since there are no street lights as you head down the dirt road. It is approximately 42 miles in length and extends from the western city limits of Medicine Lodge to the junction of U.S. 160 and U.S. 183 at Coldwater. There are two scenic overlooks to view flat mesas, deep canyons, sharp high hills, red soils, and caprock formations. You’ll find lush cedar-rimmed hills and an occasional working oil well. The Gyp Hills Scenic Byway is a finalist for the 8 Wonders of Kansas – Geography.
