Ms. Haug has been with Brentwood School District for 12 years and has been an educator since 1999. She graduated from Truman State University with a degree in Communications before earning a Master's in Curriculum and Instruction from Walden and a Master of Fine Arts from Lindenwood.

"In my work at BHS, I am absolutely most proud of teaching students to advocate," Ms. Haug said. "In life, we all have to learn to

speak up when it is important. In our current societal climate, it is more important than ever that we learn logical argumentation, advocacy skills, and clear communication. 
City Hall Closed for Renovations

Brentwood City Hall is closed to the public for several months while undergoing a partial renovation. City Hall staff have been temporarily relocated to other City buildings. Board and Committee meetings will be held at new locations until City Hall is reopened in early 2020.

The Planning & Development department has relocated to the Firehouse (8756 Eulalie Avenue).

The Court office has relocated to the Public Works building (8330 Manchester Road).

Board of Aldermen, Public Works Committee, Public Safety Committee and Ways & Means Committee will meet at Brentwood School District Conference Center (1201 Hanley

Industrial Drive) during the renovation project.

Planning & Zoning Commission, Architectural Review Board, Board of Adjustment and Site Plan Review Subcommittee meetings will be held at the Brentwood Recreation Complex (2505 S. Brentwood Blvd.) during the renovation project.

The main City phone number (314.962.4800) and department and staff phone extensions will remain operational.

Renovations inside the building focus on improving the customer service experience as well as security on the first floor. Renovations also include accessibility improvements to entrances, including ramps, handrails and parking. This construction work is included in the City's fiscal year 2019 and 2020 budgets.



Cyber Security: Protecting Our Increasingly Digital Life

We are constantly connected. Even while we're "offline" on vacation, or away from our computer or mobile devices, chances are we're still connected in one way or another. More and more, the Internet touches almost all aspects of our daily lives.

Don't believe it? Think of the systems that help to keep the lights on, the water running, and transportation moving. Or the devices that track your sleep and exercise, point you to an open parking spot, or control the thermostat at your home. All these and more depend on digital networks to function.

As we enjoy the convenience of these changes, we must consider the new risks they bring as well. Just as we lock our doors to protect our valuables, we must also take steps to protect our devices and information from virtual threats by properly securing everything that is connected to the Internet.

During National Cyber Security Awareness Month, we encourage you to remember a few important steps to help secure your valuable information and then practice them all year long!

1. Keep a clean machine. Like your smartphone or PC, keep any device that connects to the Internet free from viruses and malware. Download software updates regularly on the device itself, as well as for the apps you use, since they often contain fixes to protect against malicious activity.

2. Set strong passwords. Setting passwords that are long, unique, and hard to guess is one of the most important things you can do to protect your online accounts. Changing passwords regularly and using different passwords for different accounts goes a long way to protecting your online information.

3. When in doubt, throw it out. Links in emails, tweets, posts, and online advertisements are often how cyber criminals compromise your computer or mobile device. If it looks suspicious, it's best to delete it, even if you know the source.

4. Avoid shopping on public Wi-Fis. It may be convenient when you're away from home and on the go, but not as secure as a password protected Wi-Fi or your home network. Save your online shopping, banking, or sensitive transactions for a secure connection, preferably when you're back at your house.

5. Monitor your credit score. The credit union offers free credit file monitoring access in both Online and Mobile Banking services. With protective measures in place, such as free daily refreshed credit scores, monthly credit reports and alerts, helping to stop fraud just got a whole lot easier. You can even initiate disputes directly from the app. Visit our website for the complete suite of benefits.

Celebrate St. Louis Union Station's 125th Anniversary with Free Movie Nights Every Friday & Saturday in October

As Judy Garland exclaimed in *Meet Me in St. Louis*, "I can't believe it. Right here where we live -- right here in St. Louis!"

This October watch Judy in the classic film as Esther Smith and her family anticipate the 1904 World's Fair and navigate the joys and sorrows of life in turn-of-the-century St. Louis. The free movie series is being held every Friday and Saturday night in October to celebrate the 125th anniversary of St. Louis Union Station, which opened in 1894 and was the biggest and busiest train terminal in the United States.

Cozy up next to the fire pits and enjoy a free showing of *Meet Me in St. Louis* on the big screen. The St. Louis Wheel will be open for ticketed rides. Guests also can purchase tickets for the Carousel and mini-golf. The Soda Fountain will be open for dinner or delicious ice cream treats and bulk candies.

ABOUT THE ST. LOUIS WHEEL

Towering 200 feet over this city's historic Union Station, the St. Louis Wheel is the biggest attraction to thrill this Mississippi River city since the Gateway Arch. With 42 climate-controlled gondolas, the Wheel operates from 10 a.m. until 10 p.m. 365 days a year.

The giant observation wheel is part of the \$187 million family entertainment complex under construction at 125-year-old St. Louis Union Station. The development's St. Louis Aquarium will open in December 2019.

The St. Louis Wheel is illuminated at night with 1.6 million LED lights that can be arranged in a huge variety of 16.7 million colors and patterns. From the top of the Wheel, guests can see nearly 20 miles in the distance with views of the Gateway Arch and the downtown St. Louis skyline to the east and Forest Park to the west.

Rides on the St. Louis Wheel will last approximately 15 minutes and ticket prices are \$15 for adults and \$10 for children. During the 2019 holiday season, all guests on The Polar Express Train Ride at St. Louis Union Station can show their golden ticket to ride the Wheel for the children's price. Tickets are available online at www.thestlouiswheel.com.

In the Wheel Park surrounding the towering attraction, guests can enjoy rides on the new Carousel at St. Louis Union Station. The classic 36-foot-wide merry-go-round features 30 whimsical animals and two themed chariots. It is manufactured by Chance Rides of Wichita, KS. An 18-hole mini-golf course also is open near the Wheel as part of the new entertainment complex. The Purina Performance Plaza at the Wheel Park offers space for special events and concerts. At the Union Station lake next to the Wheel, a fire and light show set to music plays daily.

The Soda Fountain at Union Station, a modern take on a retro-style diner, also has opened overlooking the Wheel. The restaurant features over-the-top Freak Shakes stuffed with candies, cookies, pastries and more. Burgers, hot dogs and

other classic diner foods are on the menu and bulk candies and creative ice cream flavors by St. Louis' Clementine's Creamery add to the fun.

What's next at Union Station? The St. Louis Aquarium is under construction under the historic trainshed. Opening in December 2019, the 120,000-square-foot two-story aquarium will be home to more than 13,000 animals including 60 sharks and rays. The aquarium will explore the oceans, rivers and lakes of the world and will be a highly interactive experience for visitors who should expect to leave with their hands wet.

The St. Louis Union Station Hotel, a Curio Collection by Hilton, is the centerpiece of the historic complex. The hotel has been named one of the world's top railway themed hotels by Condé Nast. St. Louis Union Station opened in 1894 and was the biggest and busiest train terminal in the nation with 22 railroads moving passengers across the country. St. Louis Union Station is owned by St. Louis-based Lodging Hospitality Management (LHM). The Wheel's operator is ICON Attractions, which also operates The Capital Wheel, Flight Deck and Harbor Carousel at National Harbor in the Washington, DC region.

Slightly Askew Theatre Ensemble presents The Women of Lockerbie

Slightly Askew Theatre Ensemble (SATE) celebrates its thirteenth year producing theatre in St. Louis with *The Season of Ritual*. The year's plays will explore the definition of ritual: ceremony consisting of a series of actions performed according to a prescribed order; acts done in accordance with social custom or normal protocol; or those acts done regularly, usually without thinking.

For the final production of its *Season of Ritual*, SATE will produce Deborah Breevoort's *The Women of Lockerbie*. Written in the structure of a Greek Tragedy, *The Women of Lockerbie* examines the crash of Pan Am 103 over Lockerbie, Scotland. The story follows, Madeline, a mother from New Jersey searching the hills of Lockerbie for her son's remains. She encounters the women of Lockerbie, who are struggling against the U.S. government to get the clothing of the victims found in the plane's wreckage. The women, determined to convert an act of hatred into an act of love, want to wash the clothes and return them to the victim's families.

Pan Am Flight 103 was a regularly scheduled flight from Frankfurt to Detroit via London and New York. On December 21, 1988, the aircraft operating the transatlantic leg of the route was destroyed by a bomb, killing all 243 passengers and 16 crew. Large sections of the aircraft crashed onto residential areas of Lockerbie, Scotland, killing 11 people on the ground. With a total of 270 people killed, it is the deadliest terror attack in the history of the United Kingdom.

Written in 1998 for a playwriting residency sponsored by New Dramatists, *The Women of Lockerbie* was the Winner of the silver medal in the Onassis International Playwriting Competition in 2001 and the Kennedy Center Fund for New American Plays award. *The Women of Lockerbie* is inspired by the true story, although the characters and situations in the play are purely fictional.

SATE presents *The Women of Lockerbie*, November 6-23 (Wednesdays-Saturdays) at 8:00pm, at The Chapel, 6238 Alexander Drive, St. Louis, MO, 63105.

The performing ensemble includes Sarajane Alverson (SATE founding member), Teresa Doggett, Michael Cassidy Flynn, Kim Furlow, Margeau Baue Steinau (SATE's founding Artistic Director), Jennifer Theby-Quinn, David Wassilak, Leslie Wobbe.

Pamela Reckamp, a founding member of SATE, returns to direct.

Scott Riley from Cook and Riley requested that the record made for the CUP hearing and the 353 hearing be incorporated by reference to the the CID hearing. As Andy mentioned in addition to the 353 application, the developer filed a CID formation petition with the City on June 19 2018. The proposed name of that district was South Hanley Road Community Improvement District. It was only going to encompass the project site so there was no adjacent properties that were going to be part of the CID. The CID would only contain the hotel development. The proposed initial board of directors for this particular CID were all representatives of the property, affiliated with Equis. Special sales taxing is being considered.

Andy Struckhoff, PGAV Planners stated the property qualifies as a blight area. The area meets all the factors required under Chapter 353 statute. Economic development sales tax trends and projections were discussed. The area has become an economic and social liability.

C. Procedural Improvement District Act, Sections 67.1401 through 67.1571 of the Revised Statutes of Missouri (the "Act").

Scott Riley from Cook and Riley are representing Equis in this matter. To open the hearing and make sure that we're following the correct procedure, the information that Kevin Chapman conveyed on the site plan we'd like to ask that the Board take notice of that information, so it's incorporated into the record of this hearing. The Chapter 353 portion of the hearing is a tool that's been made available to cities and developers in Missouri. It's one of the oldest economic development tools in the state. Developers apply under Chapter 353 to ask for assistance for development projects in the form of tax abatement and that's why we're here tonight. Our specific ask under Chapter 353 is for a real property tax abatement associated





As St. Louis Blues regular season starts check out the Stanley Cup exhibit at the Missouri History Museum

The St. Louis Blues start their 53rd season—this one as Stanley Cup Champions—when they take the ice Wednesday Oct. 2 and host the Washington Capitals at 7 p.m. at Enterprise Center.

The Missouri History Museum has a Blues Exhibit that will excite fans—and it's free. The exhibit is a must-see for Blues fans because it features the authentic jerseys, sticks, and other gear that was actually used by the players in the 2018-19 season as they had their road to the Stanley Cup.

The Blues held their Championship Ring Ceremony at the exhibit Monday night so the players were the first to see it.

Tuesday morning they held a media gathering to show off the four cases of Blues items located on the second level of the Missouri History Museum. In honor of the exhibit, the Missouri History Museum dyed their fountain blue. On a beautiful Tuesday morning in Forest Park joggers and cyclists passed by the sparkling blue fountain.

The cases feature artifacts from the Blues historic championship run and will be on display at the Museum starting today (October 1, 2019) through January 26, 2020.

Dr. Frances Levine, the president of the Missouri Historical Museum was on hand and complimented Randy Girsch, VP of Community Development at the St. Louis Blues who was there also.

"The Blues did such a great job working with us," she said, saying Girsch had helped with assembling the exhibit.

The History Museum worked with the Blues for the exhibit called History Made which features more than 25 artifacts on loan from the team. History Made tells the story of the underdog team that took home the NHL's highest honor and united its community in the process.

"In a town that had not been known for good news recently, it was a good news moment shared locally but also globally," said Dr. Levine.

Why the Blues Stanley Cup exhibit at the History Museum?

"It says it right there," said Dr. Levine, pointing to a part of the exhibit, which says 'History was made on June 12, 2019.' 'History was made with families, history was made with friends.'

June 12, 2019 is a date that will forever live in St. Louis sports history. The team that had gone 52 years without ever winning a Stanley Cup game, let alone a Championship—hoisted the Stanley Cup for the first time.

"I am excited about this exhibit because I had never lived in an area that was host to a professional sports team, but when I moved to St. Louis (five years ago) I found a niche with the Blues," said Dr. Levine, who has a doctorate in anthropology from Southern Methodist University and spent many years on archaeological digs in the West.

Girsch talked about how great the exhibit will be for tourists, and specifically those who come to St. Louis for the NHL All-Star Game, to be held on January 25, 2020, at the Enterprise Center in St. Louis.

"The NHL All-Star Game will be held in St. Louis this year," he said. "The Blues are the first team to be Stanley Cup Champions and host the All-Star Game in the same year."

Blues Exhibit pr and RobLeigh Walters, the Director of Marketing and Communications for the Museum (shown left with Rob Rains) said the Jordan Binnington case (shown in photo above) was her favorite part of the exhibit. It features his leg pads. She showed media member the various cases in the presentation.

Walters pointed out that while the Blues exhibit is temporary there are other exhibits in the Museum that sports fans will love.

Old Blues "We have an older Blues exhibit among the permanent exhibits at the Museum," Walters said. "We want to incorporate more permanent exhibits about the Blues and we plan to re-do parts of the gallery to do that. We really have a lot of sports history from games St. Louisans played in the streets to the pro teams."

There is a black and white mural of Sportsman's Park and a photo of Jack Buck and Harry Caray and an area you can test your knowledge of St. Louis sports.

"We have an exhibit on Stan Musial," she said "And also a Photo Journalism and Pulitzer Prize display in our first floor exhibit area."

Not-for-Profit Organization Helps Protect Against Disasters

National Preparedness Month every September encourages families, businesses, communities and schools to develop emergency survival plans.

In St. Louis, Missouri, 48 legally blind employees at Lighthouse for the Blind – Saint Louis (LHB) are doing their part by producing medical kits; catheters, adhesives, pandemic flu kits, aerosol and liquid cleaners among many products for business, consumer and government customers.

In fact, the Lighthouse is one of the nation's top providers of emergency preparedness kits to help people survive earthquakes, hurricanes, tornados, blizzards, floods and more. The Lighthouse brand is Quake Kare/Emergency Ready (<https://www.quakekare.com>).

Thousands of people across the nation choose from more than 100 different survival kit products that LHB and its Quake Kare division provide to help keep people safe and secure.

But not all of them know that every sales dollar LHB earns directly supports LHB service programs for people who are blind or visually impaired.

The Lighthouse is a 501(c)3 not for profit entity whose mission is to assist individuals who are legally blind maintain dignity and independence through employment, education and support services.

It operates like a for-profit company to advance its social services mission. The organization has two plant facilities in St. Louis County, Missouri, where legally blind employees work to earn a living and increase their self-esteem while serving customers across the country.

LHB President John Thompson says, "We are proud of all of our employees and our many service programs for the community of people who are blind or visually impaired."

Many schools, churches, first responders and non-profit organizations are providing information or conducting safety seminars during National Preparedness Month.

Congress chose September as National Preparedness Month because the September 11, 2001, tragedy inspired Americans to be more prepared.

September also was chosen because the Atlantic hurricane season peaks in September, as demonstrated by Hurricane Dorian, whose powerful winds, rain and flooding ravaged the East Coast, stranding thousands of people.

"Government research shows that many families, schools and businesses are not prepared to deal with disaster, and many don't have a disaster plan in place," Thompson points out. "In today's uncertain environment, it is crucial for people to plan for

emergencies to help save lives and property."

Lighthouse social programs and learning activities focus on virtually anything that kids and young adults with visual impairments want to enjoy to broaden their life experiences, skills and self-confidence.

All 16 of LHB's "See the Future" programs are financed by revenues that the Lighthouse generates by manufacturing, packaging, selling and distributing its products to businesses, consumers and government agencies.

The LHB programs provide assistance in technology adaptations; skills development for activities of daily living; career development for professionals working in vision specialties; scholarships to attend educational and recreational camps; adult assistance with low vision aids; and a mobile low vision clinic.

"These programs share common goals to provide children and young adults who are blind or visually impaired with opportunities to learn about teamwork, gain self-confidence, build friendships and develop communication and socialization skills," says Thompson.

"We strive to help all of our program participants – and our in-plant employees – become independent and productive members of society," Thompson says.







FRANCE CANAL CRUISE



We like to travel to France at least a minimum of every two years. We have a favorite airline that we have taken three trips on so far. La Compagnie is a 100% business-class airline flying out of Newark NY (EWR) directly to Paris FR (ORY) Orly. The ticket price is \$1,500 - \$1,600 round trip depending on seasons and specials. Anyone with long legs like my husband, Kevin, will really love this French boutique airline. The seat position makes a full recline lie-flat seat. The light blue amenity kit contains ear plugs, toothbrush and toothpaste, eye cream, face mask, sorbet hand cream, blue n gray striped socks, an ink pen and a shoe bag. A welcome onboard glass of champagne added a nice touch. Use of the airport lounges were included. In Newark, we had access to the Art & Lounge; WI-FI access, cuisine and service. In Paris Orly, there is access available at the ICare Lounge.

Before our trip we had asked if anyone knew of an economical hotel in Paris. The answers were Paris and economical don't go together. We proved them wrong when Kevin found a nice boutique hotel in the 15th Arrondissement which was very close to the subway (metro) for sightseeing and to and from the aeroport. We would be spending 2 days in Paris prior to boarding the luxurious Raymonde canal barge cruise for 7 days.





Rocky Sickmann to Deliver Keynote Address at 2019 Veterans Day Observance Ceremony

Soldiers Memorial Military Museum announces Rocky Sickmann as the keynote speaker for the 2019 St. Louis Veterans Day Observance ceremony. Marine Corps Sgt. Rodney “Rocky” Sickmann was one of 52 Americans held captive during the Iran Hostage Crisis (1979–1981). The 2019 Veterans Day Observance will take place on Saturday, Nov. 9, 2019, at 10:30 a.m. at Soldiers Memorial. The event is free and open to the public.

“We’re honored that Rocky Sickmann has agreed to deliver the keynote address for this year’s Veterans Day Observance,” said Mark Sundlov, director of Soldiers Memorial Military Museum. “As historians, we often tend to focus on major conflicts and their lasting impact. However, the powerful stories of service that take place in between major conflicts, like the Iran Hostage Crisis, are just as important to the larger narrative and providing a holistic look at the military experience.”

“I am humbled and honored to be a part of the 2019 Veteran’s Day commemorative events at Soldiers Memorial Military Museum,” said Rocky Sickmann. “Veterans are — and have always been — a family of strong and loyal comrades who represent the ideals which built our country. These men and women fearlessly choose to wear the uniform which serves and protects us all. Paying tribute to our Veterans at Soldiers Memorial this November will be very close to my heart.”

“At Soldiers Memorial, we strive to share the story of American military history through the lens of St. Louis,” said Sundlov. “The experiences of St. Louis service members are as diverse as St. Louisans themselves. Our hope is that visitors of all backgrounds, military or civilian, young or old, can find themselves here at Soldiers Memorial Military Museum.”

About Rocky Sickmann

Rodney “Rocky” Sickmann graduated from Washington High School in 1976 and immediately entered the U.S. Marine Corps. In 1979, just 28 days into his tour of duty at the American Embassy in Tehran, Iran, Sickmann became a player in one of the most terrifying events in U.S. history.

On Nov. 4, 1979, after months of turmoil marked by the return of the exiled Ayatollah Ruhollah Khomeini, the American Embassy in Tehran was overrun by militants and its employees taken captive. Sergeant Rocky Sickmann, then just 22, was one of 65 Americans taken hostage. Sickmann remained a hostage for 444 days before being released on Jan. 20, 1981 following 14 months of diplomacy by President Jimmy Carter.

Sickmann kept a diary while being held captive. Placing the diary in a plastic bag and taping it to his leg, he was able to smuggle it home with him when he was released. The diary is the only known diary to have been smuggled out of Iran and published. Today, the diary is no longer in publication.

In 2018 Rocky Sickmann loaned Soldiers Memorial Military Museum his diary for temporary display in its newly renovated St. Louis in Service exhibit. Never-before publicly exhibited, two pages of the diary were on display in the exhibit, while Soldiers Memorial staff worked to digitize the entire diary. Today, reproductions of various pages from Rocky Sickmann’s diary can be seen on display in the exhibit, ensuring that his story and other stories of service will be shared and reflected on for generations to come.

Sickmann was Honorably Discharged after six years in the U.S. Marine Corps and received several accolades during his service including the Prisoner of War Medal, The Defense Meritorious Service Medal, Award of Valor, and Good Conduct Medal.

In 2016, Sickmann’s military and professional experience, coupled with his passion for our armed forces, led him to pursue an opportunity with his favorite non-profit organization: Folds of Honor.

Dining In Paris Can Be Affordable!



Salmon Salad

We spent almost 5 days in Paris during a recent trip to France, and found out that it is possible to eat well at a reasonable price.

We flew to France, and back, on La Compagnie, an all business class airline that is priced like legacy airlines premium coach service. Gourmet meals, drinks, lay flat seats and private lounge service on both sides of the Atlantic. One item that stood out was a poached egg with salted caramel, creamed corn and popcorn. Very unique and very tasty.

We stayed on the left bank, in a nice residential area a few blocks from the Eiffel Tower. Our hotel and restaurants were much more reasonably priced than if we had stayed in a more touristic area. The hotel Beau Grenelle was \$85.00 per night and was very nice.

Tratoria Napolitana Da Enzo was next to our hotel. It is a small, neighborhood, pizza place with a few pastas and great salads as well. The staff was very friendly, the service was great and the food was excellent. I had a smoked salmon and tomato salad and sue had a pizza. Total price with a Heineken beer \$23.00!

We had a great breakfast at a bistro about twenty yards from our hotel; a large omelet, toast, jellies and coffee was less than \$10.00! Later that night we had drinks and ice cream at lower than expected prices.

We had a very nice dinner at a Bistro/restaurant less than a block away. Sue had grilled fish with a remoulade of zucchini, tomatoes and onions. I had a perfectly cooked steak and fries with a small salad. We each had a glass of wine and the bill came to a bit less than \$40.00. The al fresco area offered marvelous people watching for free.

The 15th arrondissement also has a great deal of ethnic restaurants as well as pastry shops, coffee shops and fast food locations. You won't go hungry in this area and its all very affordable.

After returning from our canal barge cruise through the Champagne region, we stayed an extra day near the Orly airport. The hotel Kyriad was \$65/night and was much better than expected. That price included a very large breakfast buffet with hot and cold items, cereals, cheeses, frozen yogurt, juices, and more.

The attached restaurant was nothing short of amazing. It is a Portuguese chain restaurant comparable to a Chili's or Applebee's here in the States. It featured huge portions of seafood items as well as French cuisine.

Sue and I decided to indulge in a Chateaubriand with pommes frites for two. I didn't pay much attention to the description on the menu, but I later saw that the beef tenderloin was 800 grams. That translates to almost two and one half Pounds! The platter of fries was almost two feet long! It was so tender that I never used a knife to cut it, only a fork. This meal was more than enough for four to five people. It was perfectly cooked and wickedly delicious. Total cost \$37.50!!

After eating nothing for 24 hours, I simply had a smoked salmon the next night, about \$9.00. They also have killer desserts such as a banana split with whipped cream and all. It was enough for two people. We wisely passed on that. I told the manager I wanted him to open one of these restaurants in St. Louis.

We did splurge one night by going to the Club Lido for a show that included a glass of Champagne and a few macrons, but it just seemed like the thing to do. After all, we had saved enough by staying, and dining in the local neighborhoods of Paris to be able to afford a touch of elegance.

As you can tell it is very easy to keep to your budget in the City Of Lights if you live like a local. You will also enjoy seeing what makes Paris such a wonderful place to visit.
