## Student Artists Shine in 100 Neediest Cases Campaign

Eighteen Brentwood High School students have been recognized for their powerful and thought-provoking artwork in the 100 Neediest Cases campaign, a longstanding initiative by the United Way of Greater St. Louis and the St. Louis Post-Dispatch.

The artwork depicts the harsh realities many families and individuals currently face across the St. Louis region, including homelessness, hunger and illness.

“We have an exceptional group of ART 3 and ART 4 students this year,” said Tim Rempel, BHS art teacher. “Their ability to translate challenging and emotional themes into powerful visuals is remarkable. They didn’t just create art—they told stories that deeply resonate with the struggles faced by so many in our community.”

All artwork was evaluated by professional artists, with the top 40 pieces earning publication in both print and digital editions of the Post-Dispatch. “These pieces showcase not just the technical skills of our students, but also their ability to empathize and connect with the human experience,” added Rempel. “It’s incredible to see how they’ve used their creativity to inspire awareness and hope.”

Established in 1922, the 100 Neediest Cases campaign has provided critical support to thousands of families and individuals during the holiday season. Through partnerships with more than 50 social service agencies, the United Way selects 100 cases each year, which are featured in the Post-Dispatch and illustrated by student artists. These profiles and accompanying artwork help raise awareness and inspire donations to assist both featured cases and others in need. Last year, the campaign raised an impressive \$1.6 million.

The award is part of the Sketch for Survival Junior competition, a global initiative designed to raise awareness and funds for endangered species and threatened ecosystems.

Butler’s winning piece was featured in the renowned “On the Edge” exhibition, with showcase events in Edinburgh and London. The exhibition celebrates the power of art to inspire action for conservation, making this achievement a significant honor for Butler and the Brentwood community.

The Mark Twain and McGrath elementary school communities came together to celebrate the holiday season during their annual Winter Sing events.

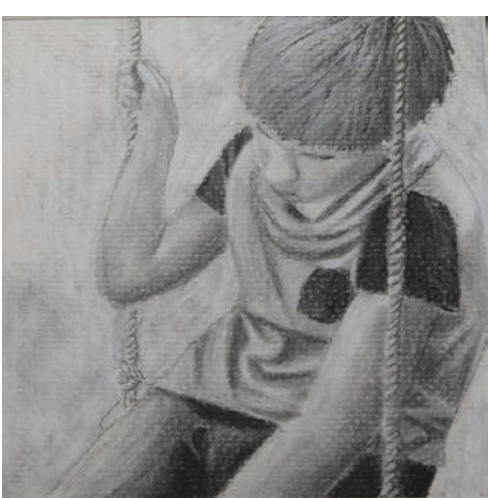

WHY a BLOOD DRIVE?

- Approximately 36,000 units of red blood cells are needed every day in the U.S.
- Nearly 7,000 units of platelets and 10,000 units of plasma are needed daily in the U.S.

How would you like to be the person responsible to collect all of that each day?

Eight years ago, our son Christopher fought MML (Multiple Melanoma Leukemia) and during his 22 months of battling he needed transfusions to help him fight off infections. Because others donated blood and platelets, we had EXTRA TIME with our son. This drive honors him and helps to make blood supplies available for others in need. YOUR donation will make you feel good about yourself, and it will mean the world to that person in need and their family.

We are asking for donors to sign up online at redcrossblood.org sponsor code: BWPParksRec

The average adult has eight to 12 pints of blood in their body. Making a blood donation uses about 1 pint, after which your body has an amazing capacity to replace all the cells and fluids that have been lost. Your body will replace the blood volume (plasma) within 48 hours. It will take four to eight weeks for your body to completely replace the red blood cells you donated.

Every two seconds someone in the U.S. needs blood. It is essential for surgeries, cancer treatment, chronic illnesses, and traumatic injuries. Whether a patient receives whole blood, red cells, platelets or plasma, this lifesaving care starts with one person making a generous donation. 1 donation can potentially save up to 3 lives. Blood and platelets cannot be manufactured; they can only come from volunteer donors. Nearly 21 million blood products are transfused each year. Platelets, critical for cancer patients, must be transfused within 5 days of donation. The Red Cross holds about 500 blood drives every day. January 26 is our day to help their effort.

Facts About Blood Needs

- Approximately 36,000 units of red blood cells are needed every day in the U.S.
- Nearly 7,000 units of platelets and 10,000 units of plasma are needed daily in the U.S.
- Nearly 21 million blood components are transfused each year in the U.S.
- The average red blood cell transfusion is approximately 3 units.
- The blood type most often requested by hospitals is type O.
- Sickle cell disease affects 90,000 to 100,000 people in the U.S. About 1,000 babies are born with the disease each year. Sickle cell patients can require blood transfusions throughout their lives.
- According to the American Cancer Society, more than 1.8 million people are expected to be diagnosed with cancer in 2020. Many of them will need blood, sometimes daily, during their chemotherapy treatment.

A single car accident victim can require as many as 100 units of blood.

Blood Supply Statistics

The Red Cross provides about 40% of our nation's blood and blood components, all from generous volunteer donors. But supply can't always meet demand because only about 3% of age-eligible people donate blood yearly. Each new donor helps us meet patient needs.

- Each year, an estimated 6.8 million people in the U.S. donate blood.
- 13.6 million units of whole blood and red blood cells are collected in the U.S. in a year.
- About 45% of people in the U.S. have Group O (positive or negative) blood; the proportion is higher among Hispanics (57%) and African Americans (51%).
- Type O negative red cells can be given to patients of all blood types. Because only 7% of people in the U.S. are type O negative, it's always in great demand and often in short supply.
- Type AB positive plasma can be transfused to patients of all blood types. Since only 3% of people in the U.S. have AB positive blood, this plasma is usually in short supply.
- Red blood cells must be used within 42 days (or less).
- Platelets must be used within just 5 days.

BAYER FUND RENEWS SUPPORT MISSOURI BOTANICAL GARDEN THERAPEUTIC HORTICULTURE PROGRAM FOR PEDIATRIC ONCOLOGY PATIENTS

Siteman Kids at St. Louis Children’s Hospital and Mercy Cardinals Kids and AYA (Adolescent and Young Adult) Cancer Center to Benefit from \$25,000 Grant

The Missouri Botanical Garden announced today Bayer Fund, a philanthropic arm of Bayer in the U.S., renewed a nearly \$25,000 grant to continue support for the Garden’s therapeutic horticulture programs for pediatric oncology patients.

The Therapeutic Horticulture team of the Garden will utilize the practices of nature engagement to improve the well-being of patients and family members. Sessions will take place in both inpatient and outpatient settings and will include patients of all ages.

In 2023, Bayer Fund provided a nearly \$25,000 grant to expand programming to Siteman Kids at St. Louis Children’s Hospital and Mercy Cardinals Kids and AYA (Adolescent and Young Adult) Cancer Center. In total, 463 people participated in the Garden’s pediatric oncology program at partner hospitals. This number includes both cancer patients and their families.

The renewed grant will allow the Garden to continue to offer therapeutic horticulture sessions at partner sites in 2025, including Cardinal’s Kids Cancer Center, the pediatric oncology and hematology center at Mercy Children’s Hospital, and at Siteman Kids at St. Louis Children’s Hospital. Additionally, expanded programming will invite cancer patients and their families to Garden grounds, including private Garden tours for families of kids with compromised immune systems.

“We are thrilled to build on the success of this program,” said Jennifer Smith-Simms, Manager of Public Education Programs. “During and after sessions, cancer patients and their families reported reduced stress, improved well-being, and an increase in relaxation. With this continued funding, we can deepen their connections with plants and bring nature to people who have limited exposure to it. The Garden will continue to enrich and improve the lives of people impacted by childhood cancers in the St. Louis region.”

“Bayer Fund is proud to support the Missouri Botanical Garden and their work to make real, sustainable impacts through connections with nature,” said Al Mitchell, President of Bayer Fund. “Programs like therapeutic horticulture with the Garden help our neighbors and make our community stronger.

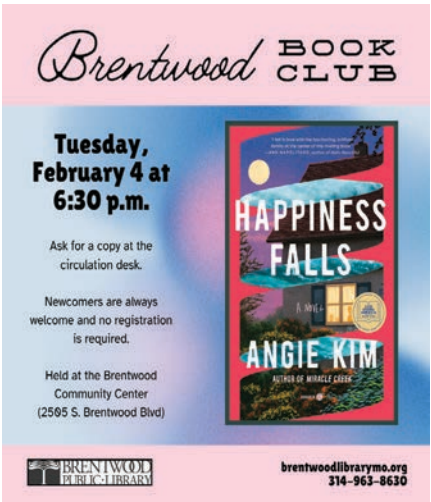

## Nolan Gorman, Jordan Walker top list of 10 most important Cardinals to watch in 2025

Trying to complete our annual New Year’s Day look at who figure to be the 10 most interesting Cardinals to watch in the coming year is a little more complicated than usual as 2025 begins.

It’s hard to make the list without knowing who is going to be on the team.

The status of third baseman Nolan Arenado has clouded the roster ever since John Moze-liak confirmed he was trying to trade Arenado as the Cardinals looked to go through a “re-set” this season.

Arenado exercised the no-trade clause in his contract to block a potential deal to the Astros, and now the Cardinals hope they can find a deal that Arenado will approve – and open a key spot on the roster.

Partially because of the logjam with Arenado, the “re-set” plan likely is not as far along as the Cardinals had hoped just six weeks away from the start of spring training. As of now, not including Arenado, a projected 26-man roster would include 23 players who finished 2024 in a Cardinals uniform.

Several of those returning players make this list – with the 2025 season perhaps being a “make or break” year for some of them.

In alphabetical order, here is our list of the 10 most interesting Cardinals to watch in 2025 – a list that would expand to 11 if Arenado still finds himself putting on a Cardinals uniform in February in Jupiter, Fla. How these 10 players perform will go a long way to determining what kind of year this will be for the team and if it truly will be a “re-set” season.

**Chaim Bloom** – A year before he officially takes over for Mozeliak as the Cardinals president of baseball operations, Bloom already is putting his stamp on the organization through his efforts to improve the team’s player development system. He also figures to be involved in personnel decisions for the major-league team, especially concerning players who likely will still be on the team in 2026 and beyond. How influential Bloom can be in those decisions without actually being in charge will be something to watch.

**Brant Brown** – The Cardinals are hoping that hiring Brown as the new hitting coach

will help the team improve many of its offensive woes from 2024. The biggest problem was a lack of production with runners in scoring position, which can be a difficult challenge for a coach. Brown already has traveled to visit with many of the team’s young hitters, beginning his work early with the players who need to perform better for the team’s overall results to be better this season.

**Willson Contreras** – He was one of the players with a no-trade clause the Cardinals asked about their desire to be a part of the “re-set” plan, and Contreras was the most vocal about wanting to stay. The team wants him to play first base on a semi-regular basis in 2025, believing it will help him stay healthy and keep his bat in the lineup on a more consistent basis. Contreras’ toughest challenge might be on defense, trying to replace Paul Goldschmidt, who annually prevented a lot of throwing errors from the team’s other infielders.

**Nolan Gorman** – His future is the most affected by the indecision with Arenado. If Arenado is somewhere else, Gorman projects to be the starting third baseman. If Arenado is still here, then Gorman will be back at second base – and influence what happens with both Brendan Donovan and Thomas Saggese. Gorman is one of the players heading into a pivotal year, no matter which position he is playing. He needs to get at least 500 at-bats, and he needs to prove that he won’t strike out half the time while still hitting 30 or more home runs.

**Ryan Helsley** – As is true with Arenado, many people expected Helsley would be on another team by now but he is still here. His presence on the Cardinals is invaluable, coming off a record-setting 49 saves, but if the team does truly want to “re-set” moving Helsley with a year left before he becomes a free agent would likely maximize the best possible return. If he is still a Cardinal when the season begins, the team has to hope Helsley remains healthy so there is a chance they could move him at the trading deadline because there would seem to be very little chance the Cardinals would be able to retain him once he becomes a free agent next winter.

**Tink Hence** – One of the top two pitching prospects in the organization, it’s likely that Hence will begin the year in Triple A – but he needs to be in St. Louis at some point during the season. The challenge for the Cardinals is trying to make moves with some of their veteran starters which will open a spot for Hence in the rotation, with that complicated by Miles Mikolas’s no trade clause and Steven Matz’s injury history. The good news is if the Cardinals can’t trade them, this will be the last year in St. Louis for both and perhaps Erick Fedde, also set to be a free agent after this season.

**Quinn Mathews** – Right next to Hence as the top pitching prospect in the organization is the left-handed Mathews, who shot through four levels of the farm system in 2024 in his first professional season. Like Hence he likely will begin this season in Triple A – unless an unexpected opening or two develop in the rotation – but Mathews should be here before the end of the season. Success from both Hence and Mathews this season would go a long way in the Cardinals planning for who will be in their rotation in 2026 and beyond.

**Victor Scott II** – An injury to Dylan Carl-

son made Victor Scott II the Cardinals opening day centerfielder in 2024, an assignment he was not ready for. It began a tough offensive year for Scott, and his struggles kept him from getting a longer look at the major-league level and kept him from showing off his best skill, his ability to steal bases. The Cardinals need to give Scott more consistent playing time this season to see if he can transfer his 94 steals in the minors in 2023 to the majors which would add a valuable element to their offense.

**Jordan Walker** – Perhaps no one on the Cardinals roster other than Gorman figures to be under more pressure to perform offensively this season than Walker. Like Gorman, former first-round pick Walker has yet to display his potential at the major-league level even though he has shown glimpses of it the last two seasons. For the Cardinals’ “re-set” to truly be successful, Walker has to join Gorman as a major offensive threat in the middle of the lineup – not hitting in the bottom of the order, and not being swapped out of the lineup a day because he went 0-for-4 the previous day.

**Masyn Winn** – One of the few bright spots for the Cardinals in 2024, Winn established himself not only as a Gold Glove caliber shortstop but also as a solid leadoff hitter. He just needs to build on that performance in 2025, which the Cardinals expect him to do. Winn also has the qualities of becoming one of the team vocal leaders, another area where they struggled last season. His success last year should give the Cardinals reasons to think that given regular playing time, some of their other young players should develop the same way this season.

## MSHP Reports Three Traffic Fatalities Over Christmas; No Drownings or Boating Fatalities

Colonel Eric T. Olson, superintendent of the Missouri State Highway Patrol, provides the following preliminary statistics related to the Christmas holiday counting period:

Three people died in traffic crashes during the 30-hour counting period, which began at 6 p.m. Tuesday, December 24, 2024, and ended at 11:59 p.m. Wednesday, December 25, 2024.

### 2024 Christmas Holiday Traffic Statistics

Troopers investigated the following:

Traffic Crashes — 65  
Traffic Crash Injuries — 38  
Traffic Crash Fatalities — 3  
DWI — 17

[Note: Last year during the 78-hour Christmas counting period, there were 1,034 traffic crashes statewide. In those crashes, three people were killed and another 346 were injured. During the 2023 Christmas holiday, troopers investigated 124 traffic crashes which included 2 fatalities and 71 injuries. Troopers arrested 81 people for driving while impaired during the 2023 counting period.]

There were no boating crashes or drownings over the 2024 Christmas holiday counting period.

The three fatalities occurred on Tuesday, December 24, 2024. A 28-year-old female of Valley Mines, MO, died when the vehicle she was driving traveled off the left side of the road and struck a tree. She was wearing a seat belt at the time of the crash. Two male occupants, age four and six, also died in the crash. Both were restrained by a safety device. The crash occurred on Route OO, south of Route F, in St. Francois County. The driver was pronounced dead at the scene by the St. Francois County Coroner. The six-year-old male was pronounced at Parkland Health Center in Farmington. The four-year-old male was pronounced at St. Louis Children’s Hospital.

There were no traffic fatalities on Wednesday, December 25, 2024.

NOTE: The fatality statistics in this news release could change if late deaths occur, if other departments report fatalities after this news release was sent out, or if a fatality is determined to be caused by a medical condition rather than a traffic/boating/drowning incident.

- Snack strategically: Eat sugary treats with meals when saliva production is higher, helping to neutralize acids and clean teeth.
- Maintain a healthy routine: Brush twice a day with a fluoride toothpaste, and floss daily, especially after indulging in holiday treats.
- Schedule a post-holiday checkup: Start the new year with a professional cleaning to ensure your teeth stay healthy and strong.

## SCIENTISTS PREDICT HOTTEST YEAR ON RECORD GLOBALLY, WHAT DOES THAT MEAN FOR ST. LOUIS?

St. Louis to see more hot days, less snow in the future

Scientists anticipate 2024 will be the warmest year on record globally, surpassing a record set last year. In St. Louis, 2024 is unlikely to set a record but the temperatures continue to trend warmer.

Following Earth’s second-warmest November on record, scientists predict 2024 will end as the hottest year ever measured, surpassing the record set in 2023, according to a report Monday by European climate service Copernicus.

In St. Louis, 2012 remains the hottest year on record, with 2023 in second place. While 2024 is unlikely to beat the 2012 record, Garden Scientist Adam Smith said hotter days will lie ahead for the St. Louis area.

“We will experience more days hotter than 105°F, and more overall hot days,” Smith said.

Smith uses mathematical models to create maps that predict long-term impacts of climate change. For St. Louis, his projections show that if we continue the current greenhouse gas emissions path, sometime in the next century we will have a climate like eastern Texas. That will mean more very hot days, more humidity and infrequent snow.

“We often talk about ‘global warming,’ but climate encompasses all aspects of the system—rain, snow, drought, fog, wind, sun,” Smith explained.

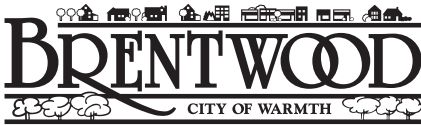
In 2024, the St. Louis area experienced a drought for most of the summer, followed by catastrophic storms. This is a pattern likely to continue, which could cause problems for plants and people.

“In the Midwest, we’re actually getting more rainfall, but it comes in bigger storms with longer periods of dry spells between them,” Smith said. “This makes it hard for plants and people to manage—when rain hits really dry soil, it tends to run off rather than soak in, so ironically, there’s less water for plants, and more flooding for people.”

Smith said it can be tempting to write off 2024’s high temperatures and heavy storms as an anomaly caused by El Niño.

“But the fact that El Niño is happening more frequently because of climate change means that the basis for the heat this year is still climate change,” he explained.

The Missouri Botanical Garden continues to respond to climate change through sustainability efforts on its grounds, by adapting its living collection to include species that will

Fried Mashed Potato Balls



1 1/2 c. cold leftover mashed potatoes

1/2 c. shredded mozzarella (about 2 oz.)

1/4 c. all-purpose flour

1/4 c. grated parmesan cheese (about 1 oz.), plus more for serving

2 Tbsp. fresh parsley, chopped, plus more for serving

1/4 tsp. black pepper

1 large egg

3/4 c. dried breadcrumbs

Vegetable oil, for frying

Kosher salt, to taste

Directions

In a large bowl, mix together the mashed potatoes, mozzarella, flour, parmesan, parsley, pepper, and egg. Place the breadcrumbs on a large plate.

Form the potato mixture into 12 golf-ball-size balls (about 2 1/2 tablespoons each). The balls will be a little sticky, so wet your hands a little as you go. Roll the balls in the breadcrumbs, pressing to make sure they adhere. Place the balls on a clean plate as you go.

In a deep skillet or Dutch oven, heat 2 1/2 inches oil to 375°F, or until it bubbles when you add a small pinch of breadcrumbs.

Add the potato balls to the oil and fry until golden brown on all sides, 3 to 5 minutes, turning occasionally. Transfer to a paper towel-lined sheet pan or plate and immediately sprinkle with salt. Serve with more parmesan and parsley.

Dining in Alton, Illinois is more than pizza, burgers, brats and beer. We recently had an exceptional experience at Gentelin’s On Broadway.

Chef Ryan Gentelin has created a unique dining venue that will satisfy any diner’s expectations. Gentelin’s may be easily described as a fine dining restaurant by it’s menu and ambiance. It is also a very friendly, casual dining location with a comfortable, well stocked bar area. The dining area is perfect for special occasions as well as family dining.

We were there for a Christmas party hosted by WBGZ / My Mix 94.3 radio stations that I do voice work for. We were seated in a private dining room that easily seats fifty plus people. The evening started with a buffet of Maryland Crab Cakes with a basil remoulade sauce and a tray of fresh shrimp and cocktail sauce.

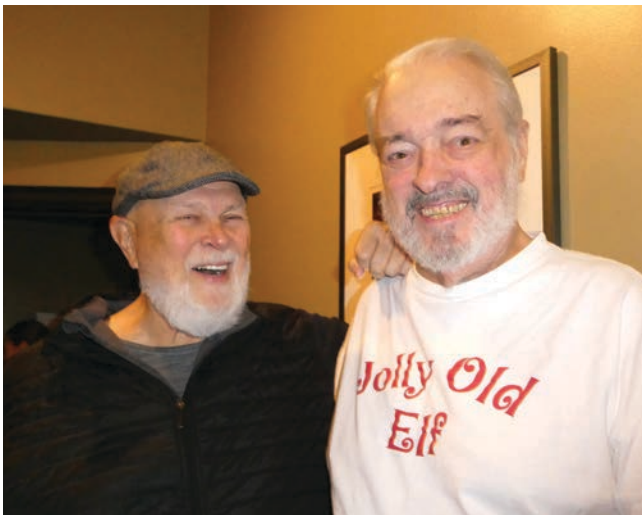

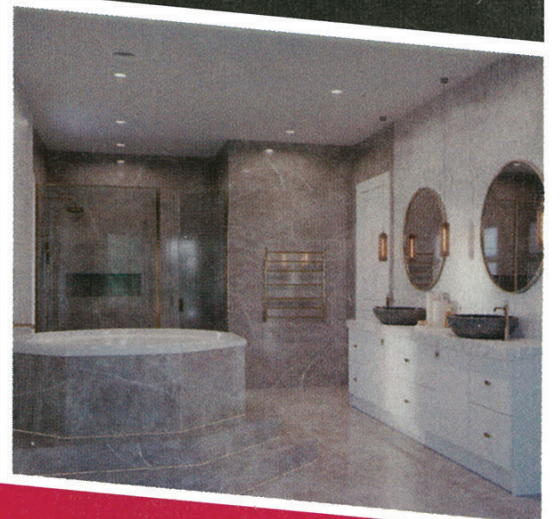
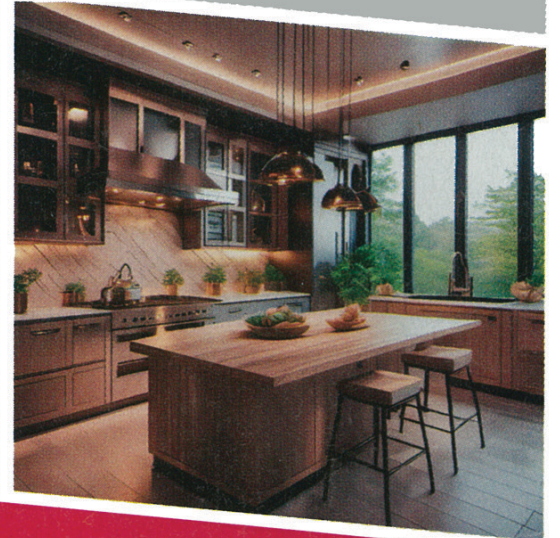

He noted that many members of the Board attended Ways and Means meetings during presentations to gain a full insight and understanding of the proposed budget.

Alderwoman Sims presented the 2025 proposed budget, noting that projected revenues were to be \$31.885M and projected expenditures \$31.452M. She stated there is an ongoing commitment to the strategic vision and extended her gratitude to the Ways and Means Committee for their leadership, input and additional meetings, as well as other Board members for attending meetings and the Mayor for his continued leadership. She thanked the management team and staff for their efforts, planning and preparation to present the numbers - noting that the city’s employees are its greatest asset.

She offered highlights of budget document, noting this is a strategic policy document that balances needs with resources, that continues to exceed goals and meet fund balance policy. (Highlights of Revenue Projections, Compensation and Reclassification, Capital Improvements plan and Infrastructure, Programs and Initiatives, Departmental Highlights, Capital Projects and Financial Summary are available in BoardDocs)

The recommendation of the Ways and Means Committee was for approval of the presented budget. The mayor noted that this budget is a concise summary of many hours of hard work. He opened to the Board an opportunity for questions. There were no questions at this time.

It was noted that the second reading of the Budget will be at the next meeting on December 16th.

Illustrations by Camille N. Dry and designed & edited by Rich. J. Compton.

Over 220 pages of illustrations and descriptions of life in St. Louis in the late 1800's. The preliminary drawings for this work were made early in the spring of 1874. After a careful consideration of the subject, it was determined to locate the point of view so that the city would be seen from the southeast, believing that to be the most advantageous in all respects. Accordingly, the point of site was established on the Illinois side of the river, looking to the northwest, and at sufficient altitude to overlook the roofs of ordinary houses into the streets.

A careful perspective, which required a surface of three hundred square feet, was then erected from a correct survey of the city, extending northward from Arsenal Island to the Water Works, a distance of about ten miles, on the river front; and from the Insane Asylum on the southwest to the Cemeteries on the northwest.

Every foot of the vast territory within these limits has been carefully examined and topographically drawn in perspective, by Mr. C. N. Dry and his assistants, and the faithfulness and accuracy with which this work has been done an examination of the pages will attest. Absolute truth and accuracy in the representation of the territory has been the standard and in no cases have additions or alterations been made unless the same were actually in course of construction. In a few cases, important public and private edifices that are not yet finished are shown completed, and as they will appear when done.

All the buildings within the limits of the survey in July, 1875, are shown; and a very large number of those executed or commenced since that date have been also introduced, the pages having been constantly corrected up to the last possible moment before publication.

### Baked Parmesan Veggie Casserole

This vegetable casserole is the perfect addition to any meal! It combines vegetables with the delicious flavors of dairy, creating a side dish that everyone will love.

Prep Time: 30 minutes

Yield: 4 – 6 servings

### Ingredients:

- 2 cups of broccoli florets
- 2 cups of cauliflower florets
- 1 cup of baby carrots
- 6 Tbsp. butter, divided
- 1 small onion, chopped
- 1 garlic clove, minced
- ¼ cup all-purpose flour
- 2 cups milk
- 1 large egg yolk, beaten
- 1 cup grated Parmesan cheese
- ½ tsp. salt
- 1/8 tsp. pepper
- ½ cup seasoned bread crumbs

### Directions:

Preheat oven to 400oF. Place the vegetables in a steamer basket. Add basket to a large saucepan filled with 1 inch of water. Bring water to a boil; cover saucepan and steam vegetables 3-4 minutes or until crisp-tender. Place steamed vegetables in a greased 9x13-inch baking dish. Repeat until all the vegetables are steamed.

Meanwhile, in a small saucepan over medium heat, melt 4 Tbsp. butter. Add onion and cook until tender, stirring often. Add garlic and cook for 1 more minute.

Stir in flour until blended. Gradually add milk and bring to a boil. Cook for 2 minutes, stirring often until thickened. Slowly stir in egg yolk and cook for 1 minute longer. Remove from heat. Stir in cheese, salt and pepper.

Pour cheese mixture over the steamed veggies.

In a small skillet, cook bread crumbs in remaining butter until golden brown; sprinkle over top of casserole.

Bake, uncovered, 15-18 minutes or until heated through.

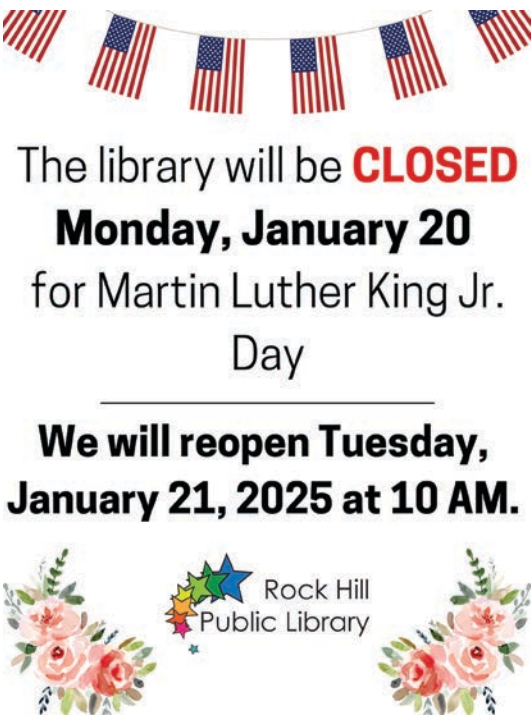
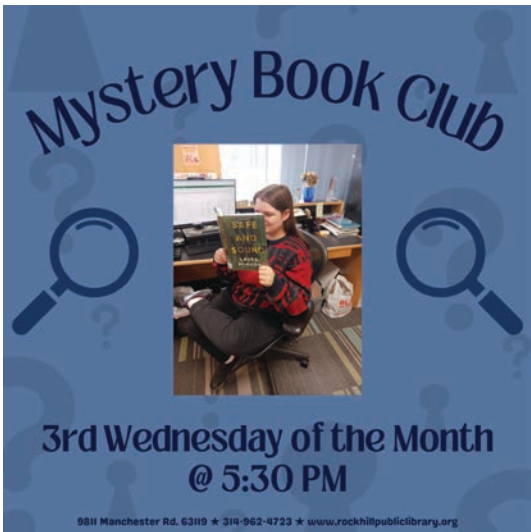

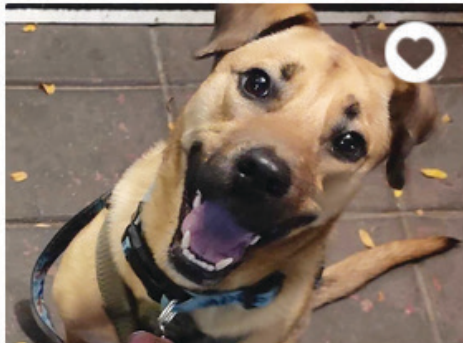

In recent years we, the citizens of Brentwood, have made several big decisions to invest in the long-term health and vibrancy of our community (i.e., Brentwood Bound in 2019; Library Expansion in 2024). Moving forward, we need to leverage these investments and align our various lifecycle replacement needs with new initiatives that will continue to make Brentwood a community for all to thrive. Three opportunities as I see for us in the near future are to:

- Revisit the Brentwood Comprehensive Plan. Brentwood completed its last comprehensive plan in April 2018. In light of the completion of Brentwood Bound, new flood maps, the library vacating existing space, and the Mt. Calvary land purchase, I believe it is time to step back and take a holistic view of the upcoming needs of the city as well as what we want Brentwood to be 10 years from now. I want to make sure residents are engaged in sharing their vision for Brentwood’s future, and I would like to see how we can get to that future in an incremental and financially responsible way.
- Develop a long-term plan to address the Black Creek flooding. While Black Creek’s waters routinely rise and fall, flooding following two large storms in 2022 and 2024 has had a major impact on residents, businesses, and trails. While the city has repaired or is repairing damaged areas, we should explore options to help prevent future damage particularly if these options can be environmentally friendly.
- Continue to maintain strong financial profile balancing near term investments within a larger term plan to be able to weather any future seen or unforeseen needs. Brentwood’s current outstanding obligations/debt, while key for reinvestment and flood mitigation, will mean we need a steady and clearly mapped out plan for investment in the near term and reserves to handle any unplanned surprises.

A little about myself, I have been active in the community serving with the Rotary Club of St. Louis in multiple positions over the last 12 years including volunteering on numerous done in a day projects, being a volunteer leadership academy counselor, and serving in various leadership positions. In May 2024 I was appointed to the Brentwood Board of Adjustments where I have gotten to see first-hand how to find compromises between neighbors and the city’s existing policies and regulations. Professionally, I am a Sr. Manager in academic medicine/healthcare with 13 years experience following 4 years in consulting. I have a master’s degree in business administration (MBA) and a graduate certificate in public finance.

If elected as your Ward 2 Alderman, I am confident I can help Brentwood continue to be a wonderful place to live and an advocate for the people of Ward 2.

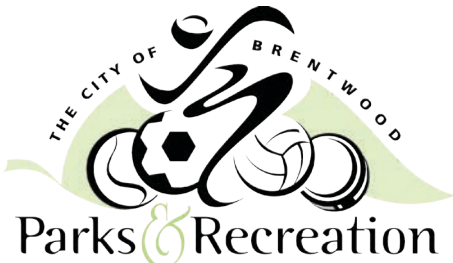

Explore St. Louis Marks Milestone 2024

Success ranges from America’s Center expansion to best-ever advertising reach

From the debut of Hall 4X to P!nk’s packed concert to record-breaking marketing reach, 2024 was a banner year for Explore St. Louis and its efforts to promote and position St. Louis as a top-tier destination for leisure travel as well as meetings and events.

The organization welcomed Ed Skapinok as its Chief Commercial Officer in July, a new position for the organization that is unique in the travel and tourism industry. Skapinok relocated to St. Louis to take the position, which combines the consumer-facing functions of Explore St. Louis for a unified and comprehensive approach to selling the region.

Explore St. Louis’ public relations outreach netted 1.34 billion positive media impressions for the St. Louis region as the organization hosted more than 120 journalists throughout the year. Additionally, Explore’s half-hour film, The Flavor of St. Louis, received national recognition with a Silver Adrian Award from Hospitality Sales & Marketing Association International, along with a Skift Award nomination.

SMARInsights’ annual advertising effectiveness study reported that Explore St. Louis’ marketing campaign effectively influenced leisure travel to St. Louis, achieving an incremental travel rate of 7.2%, which translated to 934,651 additional trips. This resulted in an ad-influenced trip spending of \$933 million, representing a 53% increase over last year. In addition, the 2024 spring and summer campaigns achieved 49% awareness, reaching approximately 13 million households - the highest awareness since 2017 and the largest volume of aware households to date.

This year, the America’s Center expansion project marked significant progress with the debut of the 72,000-square-foot Hall 4X as well as 23 upgraded, fully-enclosed loading docks, while The Dome rolled out new turf and energy-efficient LED lighting in time for the 2025 Battlehawks season. In the new year, America’s Center will see a new lobby come online as well as the Center’s 40-bed culinary garden and enhancement of the Washington Avenue facade.

On the meetings and events side, St. Louis led the U.S. in year-over-year growth in meetings and events, and as a whole, Explore St. Louis reports remarkable growth in St. Louis tourism, hotel industry performance and the meetings and conventions sector.

Looking ahead to 2025, America’s Center Convention Complex will have one of its biggest and busiest years yet. In addition to a full slate of meetings and conventions, St. Louis will welcome Meeting Professionals International for its annual World Education Conference in June, bringing meeting planners from across the globe to the Gateway City. On the event side, in January, car lovers and monster truck enthusiasts can check out the St. Louis Auto Show and Monster Jam. The St. Louis Battlehawks will break in The Dome’s brand-new turf when the season starts in spring 2025, and Kendrick Lamar & SZA will perform on June 4 as a part of their Grand National Tour.

As the organization looks toward 2025, Explore St. Louis is poised for further expansion and growth, capitalizing on the momentum and economic achievements in 2024.

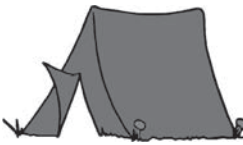

## IN SEARCH OF THE GREAT AMERICAN BALD EAGLE

Searching for eagles. This is one of our favorite winter activities to do along the Mississippi River. Every year the Great American Bald Eagle returns to our area.

These magnificent birds can be seen along the limestone bluffs and in the trees along the river. There are several families that nest in their large nests and return to these nests yearly. One year we saw an eagle floating down the river on an ice chunk looking for fish.

Cory Jobe, President/CEO of the Great Rivers & Routes Tourism Bureau said, "This is a very popular festival with a lot of free activities." On January 4 there was a Meet & Greet where a live American Bald Eagle from the World Bird Sanctuary with its handler and you would have had the opportunity to learn more about the eagles and take photos.

Be sure to mark your calendar for next year if you couldn't be there this year.

Visit the Audubon Center at Riverlands Migratory Bird Sanctuary and the National Great Rivers Museum at #2 Locks & Dam. There will be kids activities including children's crafts. Eagle watching Shuttle Tours available every Saturday in January and February at 11 a.m. And 1pm. Tours begin and end at the Alton Visitors Center, 200 Piasa St. Tickets are \$15 per person and must be purchased online in advance.

You can see live bald eagles every weekend in January and February. Head to the Golden Eagle Ferry and the Brussels to watch the eagles in the treetops where they have a great perch to watch the eagles "fishing" when the ferry churns up the fish.

Stop by for dinner at Pere Marquette State Park and watch the eagles from there.

Eagles are more active in the early morning hours or at dusk. You will be able to view other migrating waterfowl, such as, Pelicans and Swans. Trumpeter Swans are the largest of all native North American waterfowl.
