Can I take estrogen while participating in this trial?

According to the informed consent document for the study, participants are not allowed to take any prescription or non-prescription drugs, nutritional supplements, or herbal supplements for at least 7 days before the first dose or at any time during the study. Specifically, hormone replacement therapy is not permitted within 28 days before the first dose or at any time during the study. Therefore, if you are considering participating in this trial, you would not be able to take estrogen if it is part of a hormone replacement therapy during the study period.

I will be turning 56 during the time I am in the study. Will I be terminated from the study when I turn 56?

Turning 56 during the study will not lead to your termination from the trial. The age requirement for the study is that participants must be between the ages of 18 and 55 at the time of enrollment. Once you are enrolled in the study, reaching an age beyond this range during the study period will not affect your participation.

Am I allowed to vape while I am in the CRU?

Vaping while in the Clinical Research Unit (CRU) is not allowed during the study. The informed consent document specifies that participants must not use tobacco or products with nicotine in an amount greater than the equivalent of 5 cigarettes per day. This restriction likely extends to vaping, as it is a nicotine-containing product. Will I have to pay anything to participate in this study?

Participating in this study does not require you to make any payments. Instead, you will receive compensation for your participation. Here's how the compensation is structured:

Also, Pfizer may use the information and samples from the study for its own research and development, potentially leading to profits, but there are no plans to pay you or provide you with any products developed from this research.

In summary, you will not have to pay to participate in the study; rather, you will receive compensation based on your level of participation and adherence to the study's requirements.
