
Vietnam's Agriculture on the Typical Patterns of Transformation





VIETNAM – US: OPEN MARKET ACCESS

1. Fruits & vegetables

- US market access for Viet Nam
 - Opened: dragon fruit, longan, lychee, rambutan, star apple and mango
 - Pending: pomelo, passion fruit
- Viet Nam access for the U.S.
 - Opened: 171 crop seeds. Potato, 12 grasses / grass seeds, sorghum, cherry, pear, grape; apple, oange and blueberry
 - Pending: grapefruits, nectarine

3. Fisheries

- VN provided market access for 221 fisheries exporters from the U.S.
- US Vietnam: Compatible recognigation system
- Fully comply the relevant legal regulations of the U.S.
 - Lacey Act
 - Mammal Protection Act (MMPA)
 - Seafood Import Monitoring Program (SIMP)
- Join international efforts combating IUU:
 - Port State Measures Agreement (PSMA)
 - Straddling Fish Stocks Agreement (SFSA)


2. Livestocks

- US is the largest exporter of poultry (34%); the 2nd largest exporter of beef; the 6th largest exporter of pork in Viet Nam
- Vietnam has provided market accesses for 486 meat exporters
- Viet Nam provided US companies certificates for 52 GM events, mostly corn and soybean, as inputs for animal feed

4. Timber and timber products

- The USTR Investigation 301 was concluded by an Agreement towards joint-effort combating illegal logging and trade
 - A joint Timber Working Group was established
 - Regular meetings to exchange information
 - Viet Nam to sign MOUs with importing countries to ensure legality of imported timber
- Vietnam's efforts:
 - Forest cover: 42% with 1 million ha having FSC
 - Participating in global initiatives for environmental protection and GHG emission reduction such as: AIM4C, SPG, 100 million farmers...
