

## **ES&H PM Position Description**

Primary place of work is at 255 Hiway Dr, Clinton, TN and FPSG UPF Field office Y-12 as a Safety Manager for the HEUMF Fire Pump and Hybrid Fire Suppression Systems.

Fire & Pump Service Group (FPSG) performs Specialized Industrial Special Hazards Fire Suppression engaging as an Engineering, Procurement and Constructing (EPC) for turnkey installations implementing NA-1.

### **Responsibilities**

Responsible for coordinating and implementing ES&H for projects within contract scope.

This position requires office and field oversight.

Experience and familiarity with DOE sites/work environment is necessary.

- Effectively monitor and present ES&H for project updates to relevant stakeholders, clients, or project team members.
- Implement all rights entitled to FPSG as a subcontractor to Bechtel National, i.e. safety, coordinated decisions, site shut down due to unsafe condition.
- Assist to set project timeline and maintain weekly look ahead schedules and reporting for ES&H.
- Attend and coordinate weekly and daily meetings with client and trades.
- Develop and conduct daily safety meetings to meet state, Federal and Contract requirements.
- Write and develop work ES&H plans and daily work/safety FHA's, JHA's plans.
- Oversee ES&H to manage FPSG subcontractors, and administrate contract compliance, i.e. safety, progress, contract flow down, etc.
- Meet project performance expectations for documentation and field progress implementing ES&H program proactively.
- Maintain the rigorous project documentation.
- Monitor Contract project ES&H Reporting i.e. daily, weekly, quarterly.
- Support project team members with tasks you assign them ES&H related i.e., Project Superintendent, NQA Manager, Project engineer, Project controls.
- Cross responsibilities for Project Management with NQA overlap with the NQA manager and the ES&H and Project Management or perform the work in their absence.
- Some travel is required to visit other job sites for review to create creative planning. May require overnight stays out of town.
- Share constructive input to hasten and streamline project efficiency for both the client and the subcontractor. Maintain all the obligations that flow down to FPSG from the client.
- Background and security checks to meet the project is required.
- FPSG's is under contract for 3-5 years at the UPF site with other projects coming online and projected to 2035.

## **Experience Minimum Requirements**

- Full time at the construction site and responsible for health and safety during execution of the construction field work.
- Position requires a 4-year technical degree in the ES&H discipline plus a minimum of 3 years of experience in related construction work environment.
- A total of 13 years of field experience in related construction work with 5 years involving ES&H responsibilities will be accepted in place of a 4 year degree.
- Completed the Thirty (30) hour Occupational Safety and Health Standards in the Construction Industry training course (OTI 510) or equivalent.
- Provide three (3) professional references that have first-hand knowledge of the candidate's safety and health experience that the FPSG may contact.
