**Section VI.** Members of the Board of Directors shall forfeit production stipends.

### **ARTICLE IV – BOARD OF DIRECTORS**

**Section VI.** Members of the Board of Directors may accept a stipend if they fulfill a production role in which stipends are given in a production, not to exceed one stipend per person, per season.

Stipends will be limited up to \$500 overall, per production, decided on by the production team and brought to the Board of Directors for review and approval. A written agreement may be made that makes stipends contingent on the financial success of the show and at the discretion of the Board.

If a production role is not fulfilled by any of the original appointed parties, the stipend(s) would be forfeited, not divided.
