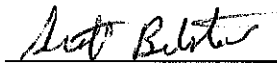
Other Discussion:

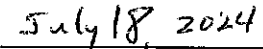
Red Lake SWCD Soil Health Position: The soil health position as a part of the Share Services Agreement has been filed and that applicant will be starting mid July.
