NRCS Report: EQIP- I haven't heard anything about additional funding coming to E. Polk. All apps. selected for funding have been obligated. CSP- Assessment and ranking was completed by the deadline. In total, we had 36 applications on file in E. Polk. 13 were determined to be eligible for this funding cycle. Others either cancelled, deferred until next year, or were not screened as high priority. 1 applicant was deemed ineligible. I am expecting a min. of 2 to get selected for funding but am hoping for more. We should find out very soon. CRP- Workload is starting to pick up. I have completed several assessments and will start creating conservation plans for new offers soon. So far, 7 offers are waiting for planning. One watershed one plan RCPP- a new pot of money that overlaps with parts of E. Polk Co. Application deadline is 4-26-24. I reviewed and contacted EQIP applicants not selected for funding and overlap with the priority area. CRP rental rates provided by FSA. So far rental rates range from \$68-\$212 – the higher end of \$212 is NOT common. Most rental rates have averaged anywhere from \$100-\$175.
