NRCS Report:

EQIP- We have 31 applications that I am working through- visiting with producers/assessments. Most of my efforts will be focused on processing applications for the near term. A 2nd signup has not been announced, but 2 additional applications were received after signup 1 deadline. One significant change with how contracts will be written starting this year is no more management flexibility. This means producers will need to have a good idea of their crop rotation for each field, up to 3-5 years. Initial allocation for the local fund pool is \$780,000. If you'd like to know more about the various fund pools available to our area (12 total), please let me know. Most 2022 practices have been certified and paid.

CSP renewal- 3 contracts are set to expire this year and will be eligible for renewal. Applications for renewals will be accepted through March 10, 2023

CSP contract admin.- all but 1 E. Polk contract has 2022 practices that have been certified.

I attended the Sandhill River 1W1P advisory council meeting, which I felt was productive with good discussion. There was an area EQIP refresher and a team iPhone app. training I attended this month. We are looking for Earth Team volunteers for the F.O. If you know anyone interested in volunteering, please send them my way.
