Balstad report on LeRoy Johnson's potential project along side of the Vesedal wetland bank. Klein will need to check with BWSR and see if this would be a project that would qualify to use state funds. She will also check with the SHRWD to see if they would be willing to help fund this project. This item will be tabled until next month.

2020 Grants: The board would like to apply for a WASCOB grant in the Clearwater River Watershed of the RLWD. A grant for Cameron Lake would also like to be discussed further with the RLWD to see if we could get an application together to help improve that resource concern. Klein will contact the SHRWD to see if there's any WASCOB or other related grants that they would like to apply for as well.

Had a total of 70 EQUIP applications equaling about 5 million. 14 preapproved EQIP applications, for approximately 1.75 million dollars, we have a preapproved CSP application for 75,000 dollars, and we have a new soil con technician that started June 22nd. His name is Justin Bellefeuille, a recent UMC graduate. He is doing good and working on CRP field reviews (we have 121 re-enrollments) and N/HEL determinations right now.
