Old Business:

Vesledahl Wetland Bank – Rachel provided an update from Steve Hofstad, BWSR. BWSR and MnDOT have several internal meetings and to discuss and review documents that demonstrate the responsibilities between MnDOT and BWSR for future landowner drainage maintenance request involving the bank. MnDOT plans to send a letter out to all neighboring landowners describing the process to permit drainage maintenance within the bank. These letters will hopefully go out this week and will be shared with the board once available.

Area 1 TSA – The TSA has approved with moving ahead with the hiring of an engineer and engineer technician as a TSA employee for the northern area. In the case of lack of funding (lack of projects) the northern districts will assume responsibility of any financial shortfalls of the two new employees with a maximum out of pocket of \$24,000. This would be worse case scenario and is unlikely to happen. The southern half of the TSA will be hiring additional staff as well, but they will be district staff. It was also decided that we will move forward with Stage 2 of the PRAP study which will focus on structure of the TSA being essentially in two separate pods as well as focus on the legal agreements that will be needed.

Rainfall Monitoring: In need of a new volunteer for Queen Township. – Tabled.

New Business:

Approve payment of \$5,864.21 to Eureka Water Probes for a new sond for water monitoring, this will be reimbursed by the MPCA SWAG agreement that. Motion by Balstad, Second by Kiecker.

Rachel presented a potential funding opportunity with NRCS on WASCOB project for Kevin Blaser in Columbia 4. Total project cost is \$13,494.28 with EQIP covering \$7,911.00. 75% of the total project would be \$10,120.71. Additional funds that will be requested from the district in the future would be \$2,209.71 or the remaining amount to get the total cost share up to 75%. Approve supporting this project, with completed cost share application to come. Motion by Balstad, Second by Kiecker.
