Soil Health Update: Brett Arne provided an update the soil health RCPP funds that we applied for. The funds were supposed to be distributed in March but with the federal funding examinations currently ongoing the funding hasn't been approved by USDA to be released yet. Discussion was had on how to proceed with our current policy and current soil health cost share funding. The current policy and rates will be used. Rachel Klein still has authorization to approve no till applications if they meet our policy and practice standards since those applications are time sensitive.

North Pod Engineering Update: Logan Handyside and Justin Muller provided an update on the North Pod and East Polk's past and present projects. Discussion was had on policy for life expectancy of projects and how some districts are using incentives to get projects in the ground during the growing season.

NRCS Report: EQIP FY25- 1 new application selected for funding. CSP FY25 Classic- 1 application selected for funding in E. Polk. I'm working on getting contract and plan docs put together. CSP FY26 renewal- no active contracts are up for renewal this year. A lot of time spent processing FSA HEL determination requests, generated by FSA through the imagery review process, along with completing admin. reviews on nutrient and pesticide management plans. We have a new acting team lead- Matt Waterworth, based out of Warren, MN. Since the last meeting I participated in a regenerative farming workshop in Grand Forks, a joint NRCS/SWCD meeting, the Glacial Ridge LTT meeting, and a nutrient management training.

BWSR Report: Brett Arne provided an update on the legislative session. It is expected that there will be some funding cuts. The SWCD Aid won't be impacted but we may see a decrease in funding for

competitive grants. NRBG Grants had a one year bump and this year they will return to the normal amount previously received.
