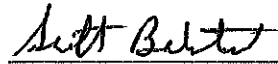

AgBMP Report: Accepting Applications!

Open Discussion: Rachel provided information on Prevailing Wage discussions that are happening at the North Pod and RRVCSA level. Brett Arne, BWSR Board Conservationist, held a meeting for the managers and explained that BWSR has a task force working with the MN Department of Labor to determine whether SWCD practices qualify. Prevailing Wage Law was established for State Agencies that directly hire contractors for projects. SWCDs are not directly hiring contractors and are only reimbursing landowners. Each SWCD can determine how they want to handle prevailing wage. BWSR is hopeful that they will have guidance soon and Rachel recommends waiting for that guidance before any changes are made.
