EQIP FY25 sign-up 1 application deadline announced: 9/6/2024. This is significantly earlier than previous years. Last year was 9/30 and previous years it was closer to end of calendar year. CSP- 2 left to get to contract- 1 ready to be signed, and 1 needs contract built still. RCPP- One application selected for funding in Red Lake River 1W1P fund pool. CRP- The 13 offers reported last month are still waiting for planning. Deadline for plans to be reviewed, signed, and sent back to FSA is 9/6/2024. Expiring CRP (21) status reviews need complete by 9/30/24. I have been trying to ID training opportunities for this summer, but with current workload it's been put as a low

priority. A job announcement was flown for a soil con. For my office. We should hear soon if there were any candidates that made the certification list and interviewed.
