Cover Crop/No Till Policy. Rachel reviewed the new Soil Health Practices Grant (RCPP) Maximum Payment Rates and reported that a funding request was sent for \$180,000. Out of that \$180,000, \$150,000 can be used for projects and \$30,000 can be used for technical assistance. Additional funding can be requested as often as monthly. Discussion was had on payment rates and maximum contract amounts as the District's Soil Health Policy was and Priorities were reviewed.

- Approve the maximum payment rate for practice standard 329: Residue and Tillage Management, No Till at \$50/acre. Motion by Balstad, Seconded by Kiecker.
- Approve the maximum contract amount for Soil Health Practices to be \$15,000. Motion by Balstad, Seconded by Kiecker.
- Approve the maximum payment rate for practice standard 345: Residue and Tillage Management, Reduce Till at \$30/acre. Motion by Balstad, Seconded by Kiecker.
- Approve the maximum payment rates for all other practices approved for the Soil Health Practices Grant to follow the rates provided by BWSR. Motion by Balstad, Seconded by Sonstelie.

Approve partnering on a SWAG (surface water assessment grant) Agreement with the RLWD. Motion by Balstad, Seconded by Sonstelie.

NRCS Report:

- EQIP FY25- 10 applications were selected during 1sst round of preapprovals: 1 high tunnel system, 5 CPA/DIAs (forest management plans), 1 in monarch fund pool (wildlife planting), 1 in Farmstead fund pool, & 2 in the IRA cropland fund pool. Funding the IRA fund pools have been paused. Several selected applicants have already gone to contract and building plans is almost complete for the others.
- CSP FY25 Classic- 16 application on file to be assessed and ranked by 3-21-25. I am starting to set appts to review maps and select activities with producers.
- I spent some time working with Gabby and making sure I am up to date on the soil health RCPP. There are a few trainings coming up. If it works with my schedule, I'll attend. The next one on my radar is a virtual training to learn about programmatic requirements of the grant (2-19-25).
- It was announced in January that the CREP program will be expanded to include 12 additional counties and increase the enrollment goal to 75,000 ac. This expansion includes Polk County.
- There will be a MN state training on the expanded agreement on 2-20-25. The SWCDs should have gotten an invite to this training from BWSR
