## **NRCS Report:**

Had 18 CSP applications and 6 received funding. Attended the cover crop training yesterday. Allen Lepp is the new assistant State Conservationist that will start in August 2018. Jenny Burrack is officially back in the McIntosh office that was effective 2 weeks ago.

### **Member Report:**

Ken Pederson reported he was on the planning committee for the Area 1 meeting that was held on Tuesday, June 19<sup>th</sup> in Detroit Lakes.

Al Bauer attended the AIS meeting on June 12<sup>th</sup> in Crookston. There are 3 people hired to inform people of AIS that are on duty by the area lakes. There was some interest in purchasing a portable cleaning station for boaters to use to clean their boats, 1 station costs \$28,000.00 and it's not in the budget to purchase at this time. Also attended the Vesledahl meeting, they toured the site and is still ongoing.

# Staff Report:

Erickson has been busy with WCA and the DNR well readings. Attended the RRVCSA meeting in Mahnomen on Tuesday, June 12<sup>th</sup>.

Byklum reported a profit of \$2,309.80 on trees for 2018. Handed out to the board candidate prospectus for MASWCD President and Vice President, the letter of interest has to be received by September 6, 2018.

Klein has been busy working on Buffers, WCA, and Trainings (Soil Mechanics 1, WASCOB, and Cover Crop), Meetings (Shoreline Restoration, Local Work Group, RLWD, SHWD, Lake Sarah Restoration, County Buffer meeting, Groundwater Protection Rule, Pictometry Demo meeting, WRAC, AIS, and TEP). Also attended the Area 1 Envirothon, helped with the Tree Pickup Day, and is assisting Mielke with the Lake Monitoring.

Mielke has been doing field work and educational materials. Has sent out the Lake Leader newsletter. Went to Clay SWCD for a demonstration on a Rain Barrel workshop to learn how they do it. A Rain Barrel workshop will be held in McIntosh on Saturday, June 23<sup>rd</sup>. As of now no one has signed up, will see if people sign up in the next few days. Has been doing 6 rivers for Stream Monitoring and 11 Lake Levels. Has made a Shoreline Restoration booklet for information for the public. Attended training for the Watershed game.

Motion by Ken Pederson to encumber CWF (15) funds for Mike Grandbois/Virgil Wilde at 75% cost share for Sletten, Section 10 and 15 at \$16,658.40. Seconded by Larry Vettleson. Affirmative-all. Opposed-none. Motion carried.

Motion by Bruce Grundyson to encumber \$6,641.92 2017 Cost Share and \$9,847.88 2016 Capacity funds for Shane Munter at 50% cost share for Hill River, Section 35 at \$32,979.60. Seconded by Ken Pederson. Affirmative-all. Opposed-none. Motion carried.

Motion by Bruce Grundyson to encumber 2016 Cost Share at \$3,007.52 and 2017 Cost Share at \$1,592.48 for a total of \$4,600.00 for Terry Bailey, Shoreline Restoration for Native Lakeshore at the Union Lake Sarah Campground in Erskine at 50% cost share for Knute 148, Range 42 at Seconded by Ken Pederson. Affirmative-all. Opposed-none. Motion carried.

Karla Byklum handed out her resignation letter to the board. Her last day at the district will be Thursday, June 28<sup>th</sup>. She will train the new applicant in the transition process a few days in July. The Personnel Committee will meet on Monday, June 25<sup>th</sup> at 8:00 a.m. to discuss the job vacancy with Erickson.
