Staff reports:

Rachel Klein – Conducting buffer compliance site reviews and working with county on a letter. Completing feedlot inspections and feedlot newsletter was sent out, and working on WCA. Attended BWSR Academy, AgBMP training, TEP meeting.

Lisa Erickson – Attended 1W1P kick-off meeting; steering committee will meet in December and Policy Committee is being set up. Smash Tax was in office to train on Quickbooks and Quickbooks is has been corrected for 2018. Discussed sending in timesheets and the concern of them being sent before the pay date. Also discussed the discrepancy of some staff being paid out annual/sick leave without taxes being taken out; Smash Tax recommended 1099s in those cases.

Motion to amend contracts CWA14-09 to change funds from the Targeted Watershed grant to \$4,069.39 out of CWF 2015 grant and \$9,970.61 to be taken out of Capacity 2016 funds; CWA 14-13 to change funds from the Targeted Watershed Grant to \$4,560.00 to be taken out of the CWF 2015 grant; CWA 14-08 to change funds form the Targeted Watershed Grant to \$\$1,100.00 to be taken out of State Cost-share 2016 grant and \$4,600.00 be taken out of the CWF 2015 grant: S. Balstad, Second: L. Vettleson. Motion carried.

Reviewed Jeff Morvig cost-share vouchers for water and sediment control basins. Motion to approve payment at a rate of 75% cost-share for CWA 14-08 totaling \$7,125.00, CWA 14-13 totaling \$5,700, and CWA 14-08 totaling \$17,550.00 for a total payment of \$30,375.00: L. Vettleson, Second: S. Balstad. Motion carried.

Weed management grant vouchers reviewed for King, Columbia, Godfrey, Garfield and Badger Townships. Motion to approve a flat-rate payment of \$761.54 to each township totaling \$3,807.70: L. Vettleson, Second: S. Balstad. Motion carried.
