Bauer reported on the Aquatic Invasive Species meeting. They're distributing promotional items including pens, boat towels, can coozies, cell phone cases, and keyfloats to educate the public.

Balstad reported in November the SHWD and East Polk SWCD will be meeting with the landowners regarding the Targeted Watershed Grant.

Elshaug reported that East Polk and Pennington have meet their goals on the MAWQCP program. West Polk has 4 applications. Been busy mapping Buffers. Attended Conservation Practice Training in Hinckley, MN the end of August.

Byklum reported attending the Polk County Commissioners board meeting regarding the yearly budget with Newton on August 16. Has been doing the Water Monitoring and Lake Levels

every week. It's a 140 mile route with 11 lake levels and 5 stream monitoring sites that are checked. The extra Capacity funds of \$15,337.00 has just been deposited into the bank account.
